- 9) QUESTION: Is installation (spreading of the mulch) required? ANSWER: No.
- 10) <u>QUESTION:</u> Is this all to be completed or delivered at once? Or Is this going to be spread out over a period of time?
 - <u>ANSWER:</u> A schedule for delivery will be set once a selection has been made. We are requesting a one-time mulch delivery to each location.

 ANSWER: Please disregard this page. I believe this was left in the bid packet from a previous RFQ for general contracting type work.
- 12) <u>QUESTION:</u> When is the expected installation date? <u>ANSWER:</u> A schedule will be set once a selection has been made.
