Addendum #1 on bid #4628 Mental Health Providers in Schools, making the following corrections and clarifications.

1) Will there only be one award to one provider or multiple awards to multiple providers?

**Response:** There will only be a single mental health provider award.

2). Is clinical social work licensure (LCSW) required or can the individual provider possess a different license (i.e. LPC. LMFT. Etc.)? Can the individual provider be license-eligible?

**Response:** Licensed Clinical Social Workers are preferred. However, the LPC and LMFT may be used if:

- 1) They can bill insurance and be reimbursed for the student's counseling service;
- 2) Demonstrate competency in children's mental health issue; and
- 3) Serve the students well.

The AWARE grant funding are for dollars of last resort and it is imperative that insurance is filed. The individual provider may be license-eligible. If utilized, the proposal should include a staffing model that has a plan for clinical supervision.

3) How many schools/sites will one LCSW be responsible for serving? Will one person be dedicated to one school or will travel be necessary? Is one LCSW assigned to only work at the Life Development Center?

<u>Response:</u> This is open for interpretation. Certainly, you could phase the project in as the school practice builds up to full time and continue caseloads at both the school and the provider's main location. The same is true with the Life Development Center- as the caseloads build up to full-time.

4) If only certain schools will be served, what schools are being targeted?

**Response:** High schools and middle schools will be targeted first because of a gap in services related to our counselor's time being consumed by tasks such as scheduling student's classes and testing. However, it is the intent to provide services to all students at all schools as the project grows and reaches sustainability.

5) Is it possible to obtain a breakdown of the children's demographics at the targeted schools (or County-wide)? Is it possible to determine what percentage of children are on free lunch?

**Response:** Specific demographic data for schools is unavailable. Free lunch data from School Nutrition Director is attached.

6) Does a budget need to be submitted?

<u>Response:</u> No; a budget is not being requested. It is the intent that the mental health provider will bill student insurance for services rendered. The AWARE grant will pay for services to individuals who are ineligible for public health insurance programs, individuals for whom coverage has been formally determined to be unaffordable, or for services that are not sufficiently covered by an individual's health insurance plan.

7). Letters of Support - do the LOS count against total number of pages?

**Response:** The letters of support do not count against the total number of pages in the proposal.
