Clarifications and/or Changes to the Contract Documents & Specifications:

<u>Item #1</u>

Issue: Staking responsibility

<u>Response</u>: Staking information is sufficiently supplied in the contract plans and will be the responsibility of the general contractor. The city will maintain the right to verify via inspection any staking and project installations by the contractor.

Item #2

Issue: Discussion of pipe supplied by the City

<u>Response:</u> After the prebid meeting, the City decided not to supply pipe material for the project. Bids will remain as originally bid with the contractor responsible for supplying all pipe materials with none supplied by the City.

Item #3

Issue: Linear footage of pipe and manhole bid quantity vs. plans quantity

<u>Response</u>: Prior to bidding and during construction of the roadway, the City installed two manholes, steel casing and subsequent internal sewer main. Considering the existing installed pipe (68 linear feet) underneath Dee Cee roadway (Manhole A-2b to Manhole A-3), the bid quantity will be reduced to match the project requirement. The revised linear footage of pipe to be installed and bid is 984 feet. The number of manholes is reduced by 2 and the correct bid quantity is 6 manholes.
