## **REASON: ANSWERS TO QUESTIONS**

Q. Is it a Bid All or Any? can we bid only what we can supply?

A. Any. You can bid only what you can supply.

- Q. What is the approximate usage time for generators? 8 hrs shift, 24 hrs shift?
  - A. Usually it is 24hrs but can be longer or shorter at times.
- Q. If mutually agreed on the renewal of the contract, is price adjustment allowed with the renewal?
- A. Yes, only at renewal. If as a result of a general change in prices or discounts, the Contractor has changed prices to all of its customers, the price under this contract may be adjusted accordingly. Contractor may be requested to show proof of alleged price changes prior to approval of any price adjustments.
- Q. Is this a multiple award contract?
  - A. Yes, we may have multiple vendors for this service.
- Q. If at the time of the quote request the item is not available, does the winning bidder have an option not to quote

A. Yes

- Q. Is there any penalty if a winning bidder cant supply the generator within an hour? At least one IOOO+KW generator must be available for quick access with not more than a one (1) hour delivery time.
  - A. If a vendor cannot fulfil the contractual agreement the contract would be cancelled.
- Q. You are requesting to price a 60 Day Qty at the daily rate but we would actually charge 2 months and not 60 x the day rate.
  - A. Use your daily rate times 60, this is for comparison and not consecutive days and multiple locations.

- Q. What accessories you all would need for the 1,000kw generator and what the quantities would be?

  A. No accessories required.
- Q. "Unit prices must not include delivery charges. Delivery costs will be charged as a separate line item, if applicable" on page 7. If the delivery charge is not to be included in the rental price and there is no separate line, where shall we input the delivery charge?

A. Line 11

- Q. We also don't see a separate line to quote 1000+KW generator in the bid doc. Per the requirement on page 7 for "At least one IOOO+KW generator must be available for quick access with not more than a one (1) hour delivery time". Could you please advise.
