# **Project Overview**

The Project involves installing approximately 9,600 linear feet of new 24-inch gravity-flow sanitary sewer replacing an existing 24-inch gravity-flow sanitary sewer. Multiple reconnections of smaller existing sewers will be required to complete the work.

The majority of the new sanitary sewer work will be completed in the same location and alignment as the existing sanitary sewer using standard excavation techniques and trenchless techniques. Specifications herein and the Construction Drawings describe the details of the work to be completed.

Funding for this project is through the Georgia Environmental Finance Authority (GEFA). The GEFA Supplemental General Conditions for Federally Assisted State Revolving Loan Fund Construction Contracts, dated May 9, 2014, as well as the GEFA American Iron and Steel Special Conditions and Information dated April 11, 2014, included as part of the Contract Documents as Attachments A and B, shall be adhered to by all parties. Bidders shall refer to Attachments A and B, and to Division 2, Section 3 of the RFB documents for information on the GEFA required bid submittals.

## **Bid Requirements**

Refer to Division 2, Section 3 "Bid Submittals".

The following items are required to be included as part of the bid submittal. Failure to include any of these items may result in the bid being deemed non-responsive.

- A. Bid Form.
- B. Georgia Bid Bond in the amount of five percent (5%) of the total bid amount.

- C. Bidder Qualification Information Form including References.
- D. Georgia Security and Immigration Compliance Act of 2006 form.
- E. Contractor Affidavit and Agreement form.
- F. Subcontractor Affidavit form.
- G. GEFA Forms as follows (from Supplemental General Conditions):
  - 1. DBE Compliance Form and related documentation.
  - Certification Regarding Equal Employment Opportunity.
  - 3. Certification Regarding Debarment, Suspension, and Other Responsible Matters.
  - 4. EPA Forms 6100-3 and 6100-4 (DBE Subcontractor Participation, Performance, and Utilization Forms, respectively), unless ALL of the work is self-performed by the prime contractor.
- H. Copies of any and all license(s) required to perform the work.
- I. Any other items as required in this RFB including but not limited to the items contained in the instructions to bidders.
- J. Non-Collusion Certificate provided on Division 3, Section 4.
- K. Addenda (if any).

# **Construction Specifications**

- A. Division 4, Section 1 Work Items and Measurement.
  - This section provides an explanation of the work that is to be completed as part
    of each Work Item and how the Work Item shall be measured for payment.
  - Work Item descriptions incorporate work shown on the Construction Drawings and all related work referenced in Division 4, Section 3.
  - The Work Items correspond to the Work Items listed on the "Pay Item Schedule" of the Bid Form.
- B. Division 4, Section 2 Material Requirements.
  - This section describes in general the materials that are to be provided for the work.
  - An indication is provided with each section of whether the material is to be provided by the Contractor or provided by CCWA.
  - The material conformance reference forms a part of the specifications and shall be of the latest editions.
  - All materials provided shall be new and domestically manufactured unless approved otherwise.

- All iron and steel materials shall comply with the GEFA American Iron and Steel Special Conditions and Information guidance document.
- Where a material is required and not specifically described in the RFB documents, the material shall be provided by the Contractor and shall conform to Section "2.1 General".
- The Contractor shall submit, for CCWA approval to use, product information on all materials required to be provided by the Contractor unless noted otherwise.
- C. Division 4, Section 3 Construction Standards.
  - Note the project will adhere to the GEFA Supplemental General Conditions prevailing Davis-Bacon Wage Rates.
