# The following are amendments to the IFB #357-19 ROCK CREEK BERM CONSTRUCTION – REBID:

- 1. The Bid Bond document within the IFB has a correction. Please submit the attached with your offer on October 25, 2019.
- 2. All other dates, terms and scope of services remain the same as posted in the IFB document.

The following are questions and answers to the IFB #357-19 ROCK CREEK BERM CONSTRUCTION – REBID:

QUESTION: Can you advise if this is a lump sum bid or can you please send me the unit pricing sheet?

ANSWER: The Price Proposal Form is located on page 28 of the IFB document. I have attached here for your convenience but, please be advised there are many forms that is to be returned within the sealed price proposal.

**QUESTION:** Will the surveying be completed by the county including layout, grade stakes, and clearing limits? If not, will the county provide a bench mark and auto Cad file for construction?

ANSWER: No surveying will not be performed by Dawson County. The only benchmark we have are based on the as-builts of the park. The as-builts states an elevation of 1143.75 for top of the existing pavilion slab. The county will request the CAD file from the Civil Engineer and given to the contractor.

QUESTION: What is the new top of ring and cover for the existing sewer manhole?

**ANSWER:** The manhole lid will match the elevation of the top of the proposed berm.

QUESTION: How many park benches are to be removed? Where are they to be stored? Are they to be put back after construction? If so, where are the park benches located too?

ANSWER: There will be approx. 2 benches that will have to be removed, it will be the responsibility of the county to properly pickup, store, and re install the benches once the project has been completed.

**QUESTION:** Are we to haul off the topsoil striping, then bring back and respread on the top of the berm?

**ANSWER:** It would be the idea to keep all disturbances and soils on site, however this falls under means and methods.

QUESTION: Due to the time of year and availability, according to native plant resources, not all native plant materials can be acquired in the correct size nor the correct species. If I cannot locate 10 Dwarf Willow, Salix Herbacea, at 1" Cal. Would it be acceptable to substitute from the same approved list with 10 American Holly, Ilex Opaca, 1" Cal. or some combination of the other existing trees in place of the unattainable Dwarf Willow, Salix Herbacea? Consequently, instead of only providing 10 American Holly, it would be 20 American Holly. Will Dawson county and the EPD approve to substitute trees from the same approved native material list, from the EPD, for species that cannot be acquired?

ANSWER: Please try and keep to the scope of the project, if not possible, the contractor will provide adequate substitutions and quantities. These substitutions will be reviewed by NRCS. There is as of this date no substitution list.

QUESTION: The American Holly, Ilex Opaca, can be fulfilled at ¾ inch Cal. and not the min. of 1" Cal. Due to Demand for native plant list, certain size requirements cannot be guaranteed to be met. Will the county and the EPD approve, the material list, if species requirements can be met but only at the next available size?

ANSWER: As stated above please try and stick to the scope, if unavailable or unobtainable please submit substitutions and quantities for NRCS to review.

QUESTION: If the two following examples, are not accepted by the county and the EPD, will my bid still be accepted?

What does Dawson county and the EPD, recommend staying in compliance with both, and address the issues with availability?

ANSWER: I don't believe the bid would be disqualified if the contractor has legitimate reasons why some plants cannot be obtained or sizes cannot be met. All alternatives will be approved by NRCS before installation.

QUESTION: Will Dawson county and the EPD provide an approve substitute list for Canopy Trees, Understory Trees, and Shrubs?

**ANSWER:** A substitution list will not be provided at this time.

QUESTION: What does Dawson county suggest in laying dormmate sod for stabilization due to when project will occur? Dormmate sod is not a reliable stabilization method if root is not taken. Will Gold Mine Golf, Inc. be held liable for sod that does not stabilize completed berm at the end of project?

ANSWER: Because Dawson County has spec'd Bermuda sod as its recommended choice for permanent stabilization, the county will allow for the postponement of the installation of sod until the Sod season becomes active in May. By which the contractor will return and plant the sod as scoped.

QUESTION: What is Dawson County's recommendation for erosion control for this case? Is there an approved erosion control process, such as, straw matting and seeding and what will Gold Mine Golf, Inc. be responsible for and be held liable for?

ANSWER: Per our permit: slopes must be stabilized with GDOT approved matting that has been incorporated with seed and fertilizer. All slopes must be properly protected until permanent vegetative stand is established.

QUESTION: If stabilization is done by straw matting and grass seed, will Gold Mine Golf, Inc. be held liable to return in May, when sod is available again, to stabilize sod? If so, pricing increase or decrease may occur due to availability of sod.

ANSWER: Yes, the contractor will return in May to achieve permanent stabilization.

QUESTION: Will Dawson county, accept seeding and straw matting stabilization with two types of grass seed to be put down one for the winter month stabilization that will die out in the summer to make way for permanent seed to take root?

ANSWER: Yes, Dawson County will accept this method this matting will be an approved GDOT matting infused with seed and fertilizer, until the Bermuda planting season begins, then Bermuda will be put down for permanent stabilization.
