Addendum #2: Question and Answers

QUESTIONS

- Will Cherry Park Elementary location be included on the cost form?
 Yes, Cherry Park Elementary School has been added to the cost form.
- Will the old Edgewood location be added to the service location?
 No, the old Edgewood location will not be added to the service location.

Remove "bed bugs" from Description of Service items #1 and #5.

3. How will bed bugs adequately be suppressed? The District and/or the contractor will perform an inspection to determine if bed bug treatment will be necessary. The treatment will only take place after the District has deemed the treatment necessary. The bed bugs treatment will be handled as an additional fee. Price should be submitted on the Cost Form (UPDATED), page 30. 4. Will you clarify under Description of Service on page 16, item #5 the "Termites and other wood destroying organisms"?

The following bullet has been deleted from item #5, page 16 "Termites and other wood destroying organisms."

- 5. Does District currently have a termite's service agreement on the existing contract?
- 6. Does District own any rodent equipment (rodent bait, glue traps, etc.)?
- 7. Does District currently have any kind of fly treatment program?
- 8. Does District currently have any kind of ant treatment program?

 Yes, the District currently treats the ants with Top Choice on the playgrounds, perimeter of every building and all athletic areas.
- 9. Is there prior pricing available? If so, I would like to formally request a copy. The District spent approximately \$35,000 on the annual pest control contract last fiscal year July 2018-June 2019. This cost excluded other services outside of the regular maintenance. - 10. How much is the District currently paying for pest control service?

 The District spent approximately \$35,000 on the annual pest control contract last fiscal year July 2018-June 2019. This cost excluded other services outside of the regular maintenance.
- 11. There is no square footage provided for each service location. Is this information available?

The service locations square footage has been provided in Addendum #1.

- 12. Are you currently doing any in-house pest control?

 Yes, the District currently treats the ants with Top Choice on the playgrounds, perimeter of every building and all athletic areas.
- 13. Wildlife Approximately, how many occurrences has the RHSD had in the last 12 months?

 The District had a total of one (1) squirrel and two (2) bat occurrences in the last 12 months.

14. Wood Destroying Insects – Approximately, how many occurrences has RHSD had in the last 12 months?

The District had a total of five (5) wood destroying insects' occurrences in the last 12 months.

15. Please clarify under "Contractor Responsibilities" on page 18, item #9. It mentions the Contractor shall not spray in the presence of students or school staff.

Some areas may require strong products or misting units for aggressive treatment deemed necessary by the District. These treatments may cause a disturbance to the students and staff.

On page 18, item #8. It also states that Pest Service can start at 7:00am in kitchen areas. What time does the kitchen staff start? We can't perform work if staff starts at 7:00am due to pages 18 and 19 requirements.

The kitchen staff starts at 6:00am. As stated, in the solicitation the hours are subject to change. Item #8 has been revised to state: "Service for each school will begin at approximately 7:00AM and continue thereafter in such manner as to not interfere with school.

16. Please clarify under "HOURS" on page 19, "If spraying is required and approved, it must be done after students are dismissed". Does that mean dismissed from the school grounds? Or the area being treated?

Students must be dismissed from the area that will be treated.

17. Emergencies – Approximately how many emergency calls has RHSD had in the last 12 months.

Based on the request for wood destroying insects, urban wildlife and bed bugs. The District had a total of approximately fourteen (14) work orders in the last 12 months.

18. Exterior treatment – Verify that this pertains only to the 15' perimeters of the buildings listed in Addendum 1 (no athletic fields).

As stated on page 17, item #10 - "In addition to the treatment of the interior of the building, the exterior perimeter of the buildings shall be treated out to fifteen (15) feet once per year and thereafter as needed". No athletic fields are to be treated.
