QUESTIONS AND ANSWERS

The following are answers to all questions considered by proposers when preparing their responses. Information shall be considered by proposers when preparing their responses.

- Q1. You indicate that there are 75 control joints in your IFB. That is correct for the interior of the central warehouse portion of the building. On the exterior of the building there are far more control joints on the building portion to the right side as well as under the covered canopy connecting the two (2) departments. Are we to include all control joints on the exterior of the central warehouse and electrical department buildings as well as the 75 designated control joints within the warehouse?
- A1. The solicitation indicates approximately 76 expansion joints. Bidders are responsible for verifying the amount of internal and external expansion joints. The City is soliciting for the vertical expansion joints of the Central Warehouse only. The area housing the Electric Department is not involved.
- Q1. The interior warehouse control joints are not of uniform width and taper down to less than ½. Proper joint design would warrant us to saw cut these joints to a uniform depth and width. Is out bid to include saw cutting to create uniform joints or are we to just install a beauty bead in these areas?
- A1. There will be no cutting or grinding of interior expansion joints.
