2) The Submission Form (S-1) references a different project - Restroom Facilities at Chilhowee Park. Should we complete and return this form as is, or will the City provide an updated form in an addenda?

3) For public design projects, design professionals in the state of Tennessee are to be selected through qualifications-based selections per TCA § 12-4-107, meaning firms should be selected based on qualifications, then mutually agreeable fees should be negotiated after that qualification selection process. Providing a bid/fee/dollar value as requested on the 'Subcontractor/Consultant Statement' form could result in our firm and other respondents being disqualified. Based on this, would you like us to note TBD or similar verbiage on the form in the two areas requiring a dollar value?

Correct, we do not require a dollar amount on this form. Please fill in a percentage if you intend to subcontract work to a DBE.

4) What is required for the "Evaluations on Prior Project" section? Are references acceptable?

It should include pertinent projects with associated references.

- 5) The submittal forms included indicate providing a bid amount. Are we to show N/A for this since it is just and RFQ similar to previous submittals? See the response to number 3 above.
- 6) It appears that there may be some grade issues with the new tennis court location as it relates to the existing trail. Since this trail is not part of the main greenway system, is it acceptable to relocate a portion as needed to prevent including retaining walls along the northern edge of the new courts? Do you anticipate the need for structural retaining walls?
 - We plan to select the team based on their experience and qualifications. The answers to these questions should not affect who you select for your team. At this point we do not need the qualifications of your structural engineer.
- 7) What level of construction support is expected for this project?
