IN THE MATTER OF AWARDING THE BID FOR "CONSULTING SERVICES FOR ARPA FUNDS" TO UHY ADVISORS AND AUTHORIZING EXECUTION OF THE MASTER SERVICES AGREEMENT WITH UHY CONSULTING, INC.

WHEREAS, a Public Notice to Bidders asking for sealed bids for Consulting Services for ARPA Funds was published in the Washington Missourian March 25, 2022 edition for receipt by April 20, 2022; and

WHEREAS, ten (10) bids were received from Viriya Consulting, LLC.; Berry Dunn; UHY Advisors; iParametrics, LLC.; BDO USA, LLP.; Anser Advisory Consulting, LLC.; EY; Ernst & Young, LLP.; NAN McKay & Associates, Inc.; Baker Tilly US, LLP.; and The Elite Group Inc.; and

WHEREAS, after due deliberation and consideration, it is the recommendation of the Franklin County Purchasing Department that the contract for Consulting Services for ARPA Funds be awarded to the lowest and most responsive bidder, UHY Advisors; and

WHEREAS, the Franklin County Commission hereby finds and determines it is in the best interest of Franklin County to award the bid for Consulting Services for ARPA Funds to UHY Advisors and to authorize the execution of the Master Services Agreement with UHY CONSULTING, INC.

IT IS THEREFORE ORDERED by the Franklin County Commission that the contract for Consulting Services for ARPA Funds is hereby awarded to UHY Advisors and that the Presiding Commissioner, Tim Brinker, is authorized to execute the Master Services Agreement with UHY CONSULTING, INC. and any and all documents as may be necessary or desirable to carry out and comply with the intent of this Order, for and on behalf of the County of Franklin, Missouri.

IT IS FURTHER ORDERED that a copy of this Order and the executed Master Services Agreement be provided to UHY CONSULTING, INC.; Debbie Aholt, Treasurer; Shakara Bray, Purchasing Director; Lynne Maloney, Accounts Payable; and to Angela Gibson, Auditor.
