We have reviewed the four (4) bids received for the City of Sebring - Veteran's Beach Rehabilitation, ITB#20-013.

The apparent low bidder for Phase 1 was Loren Jock Trucking, Inc. at \$178,091.00, one hundred seventy eight thousand ninety one dollars. The remainder of the bids for Phase 1 were Midcoast Construction Enterprises, LLC with a bid of \$195,025.00, one hundred ninety five thousand twenty five dollars, Marmer Construction, Inc with a bid of \$237,892.00, two hundred thirty seven thousand eight hundred ninety two dollars, and Shoreline Foundation, Inc with a bid of \$245,044.00, two hundred forty five thousand forty four dollars.

The apparent low bidder for Phase 1 plus Phase 2 was Loren Jock Trucking, Inc. with a total bid of \$326,550.00, three hundred twenty six thousand five hundred fifty dollars. The remainder of the bids for Phase 1 plus Phase 2 were Shoreline Foundation, Inc with a total bid of \$348,830.00, three hundred forty eight thousand eight hundred thirty dollars, Marmer Construction, Inc with a total bid of \$357,355, three hundred fifty seven thousand three hundred fifty five dollars and Midcoast Construction Enterprises, LLC with a total bid of \$363,946.00, three hundred sixty three thousand nine hundred forty six dollars and.

The Bid request also requested a Phase 1 Alternate Option #1, "Composite Sheet Pile" option. In reviewing the submitted Composite Sheet Piles provided by the bidders, two (2) of the Composite Sheets specifications did not meet the equivalent specifications for the Steel sheet piles in the Phase 1 portion of the Bid request and therefore were deemed non-responsive. The final two (2) bids were then considered. The apparent low bidder for Phase 1 with Option 1 was Loren Jock Trucking, Inc. with a total bid of \$188,770.00, one hundred eighty eight thousand seven hundred seventy dollars. The

other bid for Phase 1 with Option 1 was Shoreline Foundation, Inc with a bid of \$235,794.00, two hundred thirty five thousand seven hundred ninety four dollars.

To the best of my knowledge the apparent low bidder, Loren Jock Trucking, Inc., for each Phase and/or option is qualified to do the work. Loren Jock Trucking, Inc. was represented at the pre-bid meeting and acknowledged all Addenda.

It is our recommendation that if the insurance and bond requirements are met, the Phase 1 (using steel sheet pile) be awarded to the low bidder Loren Jock Trucking, Inc. for \$178,091.00, one hundred seventy eight thousand ninety one dollars. If the City of Sebring would like to included the Phase 2 Option for Dock Replacement, it is our recommendation that if the insurance and bond requirements are met, the Phase 1 plus Phase 2 be awarded to the low bidder Loren Jock Trucking, Inc. for \$326,550.00, three hundred twenty six thousand five hundred fifty dollars.
