To All Potential Proposers: This addendum is issued to modify the previously issued RFQ documents and/or given for information purposes, and is hereby made a part of the RFQ documents. Please attach this addendum to all documents in your possession.

Q: Does the County have a preferred method for delivery of responses? Do they prefer hard copies or is submitting through Vendor Registry ONLY sufficient?

A: The County would prefer hard copies, however, either method is acceptable.

Q: The RFQ states on page 11, item 9 that the existing Justice Center will continue to be used for civil and juvenile court. What is the anticipated scope for the new justice center courts and support areas? Should we assume two new court rooms (1 circuit, 1 sessions), associated clerk's office and other support space?

A: The court and support areas in the proposed criminal justice center include, but may not be limited, the following to rooms or areas:

- 2 courtrooms
- Grand jury/conference room
- Holding cells
- 4 Witness/attorney consultation rooms
- Clerks offices including records storage/vaults
- 2 judges' chambers
- Breakroom or kitchenette

As the project progresses, the number or types of rooms may change.

Q: The addenda only mentioned forms on pages 5 and 9. Does the anti-collusion form on page 18 need to be included as well?

A: The anti-collusion form WILL need to be included as well. This item was mistakenly left out of the previous addendum. As with the forms on pages 5 and 9, it will not count toward the 20 page statement of qualifications limit.

Q: Page 14, number 14 states a signed and notarized copy of the Conflict of Interest Statement must be submitted. Is there a specific form the County wishes to be used or do respondents make a small statement with a signature and notary signature?

A: The Conflict of Interest form is being issued with this addendum as Attachment to the RFQ.
