**286.0105** Notices of meetings and hearings must advise that a record is required to appeal.— Each board, commission, or agency of this state or of any political subdivision thereof shall include in the notice of any meeting or hearing, if notice of the meeting or hearing is required, of such board, commission, or agency, conspicuously on such notice, the advice that, if a person decides to appeal any decision made by the board, agency, or commission with respect to any matter considered at such meeting or hearing, he or she will need a record of the proceedings, and that, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based. The requirements of this section do not apply to the notice provided in s. 200.065(3).

Section 286.011(6), F.S., All persons subject to subsection (1) are prohibited from holding meetings at any facility or location which discriminates on the basis of sex, age, race, creed, color, origin, or economic status or which operates in such a manner as to unreasonably restrict public access to such a facility. Thereby, in compliance with the Americans with Disabilities Act (ADA) and F.S. 286.26, anyone desiring to attend a public meeting who needs a special accommodation should contact 772-219-1255 or email to <a href="mailto:bids@martin.k12.fl.us">bids@martin.k12.fl.us</a> at least 48 hours in advance of the meeting, excluding Saturday and Sunday.

## **NOTE**

**Public comment:** Prior to the adoption of s. 286.0114, F.S. (2013), Florida courts had determined that s. 286.011, F.S., provides a right to attend public meetings, but does not provide a right to be heard with the exception of "board or commission".
