- Q: Addendum #2 Section 116623 references Wall Safety Pads. Are we to furnish this item and if so what is the quantity?
- **A:** Wall Safety Pads are to be provided. 100' LF of outdoor pads are required, 6' minimum height. Pads are now noted on CS 030.
- Q: Is there to be irrigation for the sports field?
- **A:** The Multipurpose Field/sports field needs to be part of the irrigation system.
- Q: Is there to be new infield mix and soil conditioner for the small baseball field along Wilcox Blvd? Should the outfield be regraded to drain from home plate to the outfield fence?
- **A:** The infield area presently under the soil spoil pile needs to be repaired with infield mix and soil conditioner. Areas of the outfield that exhibit rutting from construction activities should be repaired, but regrading the entire outfield is beyond the scope of this contract.
- Q: Should plants, seeding, and trees around the new YFD building be deducted from the base bid?
- **A:** Plants, seeding, and trees around the building are not part of this contract. Street trees near the building on Wilcox and Dodson are part of this contract.
- Q: Section 2810-11. The landscape contractor is to remove 36" of subgrade from all planter islands and backfill with topsoil. Is this typical on all planter island beds and are the beds along drives and fencing done this way?
- **A:** This is typical on all planter beds. Beds along drives and fencing should be done in this fashion unless approved in writing by the Landscape Architect.
- Q: Please provide a detail and/or a cut section for the infiltration bed.
- A: Sheet GI 101 is included in this Addendum.



A: No, these forms must be included in the sealed bid envelopes for subcontractors that are listed on the envelope.




