This addendum will amend **Bid #22-093, CTC Emulsified Asphalt Pavement Sealing Projects (FY23)** originally issued on Wednesday, March 8, 2023. This clarification is being provided to all known and registered correspondents in response to questions received. All addenda and original bid documents are also available online at: www.gtcounty.org, select "Bid Opportunities" from the Quick Links section.

Question 1: Please clarify #GC-32 quantities. - Sealcoat - BID 12,200 sy (I am measuring 12,467 sy (roads) + 2,084 sy (driveway aprons) for a total of 14,551 sy)?

Response: Any agreed upon overages will be resolved through Change Order at Unit Price.

Question 2: #GC-32 pot hole repair

Will areas be marked by the county that you would like repaired? Will repairs be invoiced at bid unit price once contracted and completed?

There is an area on Bobcat just north of songbird intersection that appears to be a sinkhole over storm drain line. Will the county make this repair before contract starts? Or do we need to price accordingly?

Response: Pot Hole repair areas will be marked. All agreed upon repairs will be billed at unit price bid.

The Area Supervisor informed me of the repairs being complete. If not the County will repair this "sinkhole".

Question 3: Please clarify #GC - 33 quantities - Sealcoat - BID 11,300 sy (I am measuring 12,020 sy)?

Response: Any agreed upon overages will be resolved through Change Order at Unit Price.

Question 4: Is this Contract a Lump Sum contract or will unit prices be used for actual quantities installed for final billing?

Response: This is a Lump Sum contract with Unit pricing used for additional work.

Question 5: During our previous contract the county wanted the roads opened back during the evening time and not the 24hr. closure. With the current bid of a squeegee coat and spray coat that might be difficult to achieve for proper drying and curing time. What time restrictions are there for this contract?

Response: Total road closure will not be acceptable. 24hr closure of one lane per road to allow for proper curing times. Application plan must be submitted to the County for approval.

Question 6: On page 4 of submittal form, under Bid Security, it states that each bid must be accompanied by a certified bid bond. On page 18, under vendor checklist (62), there is a note that this is only for bids over \$100,000.00? If my bid is under \$100,000.00, do I need to include a bid bond?

Response: For fair comparison of bids and due to the nature of funding for this procurement, yes, please provide a bid bond even if your bid is under \$100,000.
