All work site preparation, fabrication, materials, labor, design, and other work necessary to install foundation repair piers and to jack the foundation of the eastern wall of the fire station back to its original orientation. This will include, but not be limited to, the following:

1. Base Bid: Mobilization, limited excavation and erosion control implementation, preparation of building interior for installation of support piers, fabrication and installation of piers, and jacking of building foundation. The Contractor is responsible for performing the necessary design of the piers for the specified loads, including sizing the piers, defining the spacing and arrangement, determining the necessary pier length, detailing the support brackets and connections to the structure, and all other details pertaining to the structural sufficiency of the foundation piers. The Contractor is responsible for all permits. The work site shall be restored, including building interiors.

Add Alternate 1:

The piers, brackets, connections, and other structural elements in the Base Bid shall be designed to resist the specified seismic loads.

Add Alternate 2:

Limited excavation and additional material handling and protection, preparation of handball court interior wood floor for installation of driven/push foundation repair piers, design, fabrication and installation of helical driven/push foundation repair piers and bracketry to carry the specified loads, and jacking the foundation as necessary to restore the indicated walls to original orientation. Approximately 12 total piers.

## Add Alternate 3:

The piers, brackets, connections, and other structural elements in Add Alternate 2 shall be designed to resist the specified seismic loads.

Add Alternate 4:

The interior floating slabs shall be pressure grouted in the areas indicated to raise the concrete slabs and restore their original orientation. Pressure grouting shall be cementitious or polyurethane. Injection holes shall be repaired with non-shrink epoxy grout and brought flush with the floor surface.

Add Alternate 5:

The interior floating slab in the handball court shall be pressure grouted in the areas indicated to raise the concrete slabs and restore its original orientation. Pressure grouting shall be cementitious or polyurethane. Injection holes in the slab shall be repaired with no-shrink epoxy grout. Wood floors shall be cored and carefully restored to their original condition.

Add Alternate 6:

The exterior masonry wall shall be repointed in the areas indicated where the foundation repairs of this project have been made.
