- This is a 180 day project from the issuance of the Notice to Proceed.
- Liquidated damages are \$500.00 per day.
- The prime Contractor is responsible for 70% of the work.
- Work times are between 7:00AM and 7:00PM, Monday through Friday. Saturdays may be worked, if needed. No work shall be conducted on Sundays.
- The City shall inspect removed equipment and materials, at their discretion, to determine whether the removed items will be scrapped or salvaged.
- This project's location is outside of the City limits and is located within Horry County's jurisdiction. All permits and electrical inspections must be granted and approved through Horry County.
