MASONRY CO., INC. FOR THE RAISING OF EXISTING MANHOLE FRAMES AND COVERS, WWTA PROJECT NO. 19-320, FOR A TOTAL COST NOT TO EXCEED \$200,000.00.

WHEREAS, the Hamilton County Procurement Department accepted sealed bids on September 6, 2019 for the raising of existing manhole frames and covers in various locations of the Hamilton County WWTA service area from existing elevation to final elevation, including the repair of existing manholes and replacement of frames and covers as required; the furnishing of all labor, material, equipment, tools, supervision, incidentals, and any other items necessary to satisfactorily complete the project; and,

WHEREAS, the lowest qualified bid was submitted by the firm, C.K. Masonry Co., Inc. totaling \$141,500.00; and,

WHEREAS, the WWTA staff recommends that C.K. Masonry Co., Inc. be contracted for the raising of existing manhole frames and covers at a total cost, including contingency, not to exceed \$200,000.00 without approval by the Board.
