When an addendum is issued for the purposes of postponing the bid opening date and time, the addendum shall establish the new bid opening date and time no earlier than five (5) days after the addendum issue date. Addenda shall be posted on the on-line bidding source(s) stated in the Invitation for Bids. A Bidder shall acknowledge receipt of all addenda issued by identifying the addendum number and the date of issuance with the Bidder's initials in the spaces provided on the Official Bid Form or the bid shall be found non-responsive in accordance with the District's Procurement Code. If this solicitation is amended, then all terms and conditions which are not modified remain unchanged.

**INTERPRETATIONS AND CLARIFICATIONS:** Requests for additional information or questions regarding error, omission or clarification of any portion of the Bid Documents or the Contract Documents or any addendum, shall be submitted in writing to the District Bid Contact Person stated in the Invitation for Bids by e-mail or facsimile no later than five (5) days prior to the bid opening date and time unless an earlier date is stated on the Invitation for Bids or as may be amended. Any interpretations, corrections, or changes to the Bid Documents or the Contract Documents made in any other manner than by a written addendum shall not be binding, and Bidders shall not rely upon them. Any information given a prospective Bidder concerning a solicitation will be furnished promptly to all other prospective bidders as an addendum to the solicitation, if that information is necessary for submitting offers of if the lack of it would be prejudicial to other prospective bidders. See clause entitled "Bidder Representations." We will not identify you in our answer to your question. The District seeks to permit maximum practicable competition. Bidders are urged to advise the Procurement Specialist – as soon as possible – regarding any aspect of this procurement, including any aspect of the solicitation that unnecessarily or inappropriately limits full and open competition.

Questions asked during the mandatory pre-bid.

- 1. Does the transformer pad need to be replaced? Answer: No, it does not.
- 2. Who is the engineer for Santee Cooper? Answer: Andy Altman for this area.
- 3. Who will handle the telephone wiring and board in the main electrical room? Answer: HCS IT department will be removing that. Contractor is not responsible.
- 4. Who will be moving the CMI panel in custodial closet? Answer: CMI will be moving the panel. Contractor is not responsible.

- 5. What time of generator is being used? Answer: Diesel
- 6. Can an alternate be added for servicing the existing switchboard? Answer: Yes, See revised Official Bid Form.
- 7. Can an alternate be added to expedite the switchboard? Answer: Yes, See revised Official Bid Form.

All other Work required in the Contract Documents to remain as described.
