Fencing at Ocean Woods Cemetery

The purpose of this Addendum 01 to IFB 23-B0017 for Fencing at Ocean Woods Cemetery, dated September 20, 2022, is to list the key points of discussion from the mandatory site visit.

- It is the intent of this bid to select a Contractor to remove approximately 1,900 to 2,000 feet of existing six (6) foot wooden fencing and install a new six (6) foot wooden privacy fence at Ocean Woods Cemetery, located at 2408 South Kings Highway, Myrtle Beach, SC 29577. All measurements listed are approximate. Contractor will be responsible for their own measurements.
- All fence will be stick built (no pre-fab panels) with pressure treated lumber and will be shadow box style.
- There are two red flags at the cul-de-sac marking fence stops. This will be reviewed with the awarded Contractor prior to beginning work.
- Contractor is not responsible for clearing the vegetative growth on the fence.
- Total demolition of the existing fence will not occur at one time. As each section is removed the new section will be put up.
- The existing posts are cemented into the ground. All existing fencing including the old cement is to be removed and disposed of properly.
- A secure material lay-down area will be available behind the Cemetery Office Building.
- **BID AWARD**

Sellers understand that the City of Myrtle Beach ranks all bids by price; however, pursuant to applicable terms and conditions of this bid, buyers may use criteria other than price to evaluate offers. This includes, but is not limited to: Section 3.02 - Responsive Bids; Section 3.03 – Non-Responsive Bids; Section 5.04 – Price Evaluation; Section 12.01 – Award Criteria. Accordingly, please note that the award will be made to the responsible seller whose bid conforms to the solicitation that is most advantageous to the buyer on basis of price, technical capability, and delivery. No partial bids allowed. Bidder must submit a price for both the base bid as well as the alternate. However, bid will be awarded based on the total lowest grand price for the base bid. See Revised Price Schedule. The Revised Price Schedule is attached and hereby made a part of this addendum.

- **Base Bid** will be the fencing on the north end of the Ocean Woods Cemetery. This fencing runs from South Kings Highway along the property line with the

neighboring businesses, along Harrelson Boulevard and along the airport property line.

- **Alternate #1** will be the portion of fencing adjacent to the Ocean Woods Cemetery Office Building to South Kings Highway.
- Work hours will be from 7:00AM to 5:00PM, Monday through Saturday, excluding City holidays. The cemetery is considered a calm and peaceful place. To the maximum extent possible, noise and debris must be kept to a minimum. Contractor will be responsible to maintain the calm and peaceful aesthetics of the environment as much as possible. Daily communication with the Cemetery Manager or Project Manager will be necessary. Work will not be performed during the time that a funeral is scheduled. All work must stop thirty (30) minutes prior to the service, and may resume as soon as all members of the service have left the cemetery. Funerals usually last 1 – 2 hours. The performance period is sixty (60) calendar days.
- The Contractor will be responsible for obtaining all permits, but the permit fees for this City-sponsored project will be waived. Contractor will be responsible for all other licenses and fees, including a City business license.
- Tony Payne, Recreation Manager will oversee the project. Kurt Klepper, Cemetery Manager, will be the on-site manager for the project. Kurt Klepper will provide information on funeral times, cemetery roadway use, material lay-down area and all other pertinent information.
- The parking lots behind adjacent businesses may not be used on a regular basis for parking. Kurt Klepper, Cemetery Manager, will provide roadway and parking information for all Contractor equipment.
- Additional questions are due no later than 12:00 noon on Tuesday, October 4, 2022. Questions may be submitted via e-mail to lgreenough@cityofmyrtlebeach.com. All questions received by the deadline will be answered via addendum. Questions received after the deadline may or may not be answered.
- Sealed bids are due in the Purchasing Office no later than 2:00PM (local time) on Wednesday, October 12, 2022. No electronic submissions will be accepted. The City of Myrtle Beach is not responsible for late or misdirected mail.
- The mandatory site visit sign-in sheet is attached and is hereby made part of this addendum.






