

RESOLUTION NO. 2019-004

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA, AWARDED ITB 2018-28, FOR PARKLAND FIRE STATION NO. 42 - BUILDING ADDITION, TO THE LOWEST, RESPONSIVE AND RESPONSIBLE BIDDER, TOMASIOU ENTERPRISES, INC., IN THE AMOUNT OF \$268,000, INCLUDING PERMIT FEES AND A 10 PERCENT (%) ALLOWANCE FOR CITY AUTHORIZED EXPENDITURE; AND AUTHORIZING THE PURCHASING DIRECTOR TO EXECUTE A CONTRACT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Parkland ("City") requires construction services of a qualified contractor for the Fire Station No. 42 - Building Addition; and

WHEREAS, this project increases the capacity at Fire Station No. 42 in order to accommodate an additional Fire Rescue Unit and additional fire rescue personnel required to support the needs of the City; and

WHEREAS, On November 9, 2018, in accordance with the City's Procurement Code, Invitation to Bid ("ITB") No. 2018-28, for Parkland Fire Station No. 42 - Building Addition, was advertised in the Sun-Sentinel, on DemandStar and on the City's website; and

WHEREAS, on December 18, 2018; four (4) bids were received from Tomasiou Enterprises, Inc., Conbuild, LLC, Hatcher Construction and Development, Inc. and Waypoint Contracting, Inc.; and

WHEREAS, upon review of the apparent low bid, staff is recommending award of ITB 2018-28 for Parkland Fire Station No. 42 - Building Addition, to the lowest, responsive and responsible bidder, Tomasiou Enterprises, Inc., in an amount not-to-exceed \$268,000, including 10 percent (%) allowance for City authorized expenditures: \$24,000 and \$4,000 for permit fees.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA AS FOLLOWS:

Section 1. The foregoing "WHEREAS" clauses are confirmed and ratified as being true and correct and are hereby incorporated herein.


Section 2. Tomasiou Enterprises, Inc. is hereby awarded ITB 2018-28 for Parkland Fire Station No. 42 - Building Addition in amount not to exceed \$268,000.
