Separate sealed bids for furnishing all supervision, materials, labor, tools, equipment, and appliances necessary for the construction of the following described project, will be received by the City of Chattanooga at City Hall, Purchasing Department, Suite G13, located at 101 E. 11<sup>th</sup> Street, Chattanooga, TN 37402, until **2:00 p.m., local time**, on **Wednesday, May 23, 2018**, and then at said place publicly opened and read aloud:

### **Passenger Street Reconstruction** **CONTRACT NUMBER T-17-010-201**

The scope of work shall consist of the reconstruction of Passenger Street from Johnson Street to the Choo Choo property boundary including but not limited to the following: Excavation of existing pavement and preparation of subbase for placement of permeable roadway materials; Removal of existing catch basin and headwall and undercutting of soft soils in former infiltration bed; Installation of Tensar Triax Geogrid under entire roadway; Installation of impermeable liner along both edges of roadway; Installation of 8" perforated double wall pipe and #57 stone pipe bedding and cover; Placement and compaction of 15" of #3 stone on Geogrid; Placement and compaction of 4" of #57 stone; Placement, compaction, and screening of 2" #89 leveling course; Mechanical and manual placement of the permeable paver system; Brooming of the paver joints; clean up and disposal of excess materials; Placement of sidewalk and header along east side of roadway; Placement of all concrete aprons, slabs, and collars; Placement of new handicap ramps; Placement of asphalt apron onto E 14<sup>th</sup> Street; Placement of trees and sod where indicated.
