INSTRUCTIONS TO OFFERORS

1. **SUBMISSION OF PROPOSAL: OFFEROR PROPOSALS MUST BE RECEIVED FOR REVIEW AND EVALUATION BY THE CHIEF PROCUREMENT OFFICER OR DESIGNEE NO LATER THAN THE DATE INDICATED IN THE COVER SHEET. PROPOSALS RECEIVED AFTER THIS DEADLINE FOR ANY REASON WILL NOT BE ACCEPTED OR CONSIDERED.** The date and time of receipt will be recorded on each proposal. Proposals must be addressed and delivered to the Chief Procurement Officer at the delivery address listed. Proposals must be sealed and labeled on the outside of the package to clearly indicate that they are in response to the “Sierra County Design Build Sierra County Administration Building” Request For Proposals and should reference “RFP #2020-07-011”. Proposals submitted by facsimile or other electronic means **WILL NOT BE ACCEPTED**. A public log will be kept of the names of all Offerors submitting proposals. Pursuant to Section 13-1-116 NMSA 1978, the contents of any proposal shall not be disclosed to competing Offerors prior to contract award.
2. **ACKNOWLEDGEMENT OF ADDENDA:** Offerors shall acknowledge receipt of any addenda of this RFP by identifying the addendums number and date in the space provided on the offer form.
3. **ALTERNATE OFFERS:** Alternate offers will be accepted and considered provided they are “equal to” and meet all specifications of this RFP which may include all specifications of the Brand used to identify the quality of the goods and/or services requested. The County reserves the right to make the final determination as to whether or not an alternate offer is equal. It is the Offeror’s responsibility to provide, as part of the offer, descriptive literature, specifications and information on all alternate products and services offered. References of current users should be included. If the item(s) or service(s) offered are not clearly identified as alternate item(s) or services, it is understood that the offer is for item(s) and service exactly as specified in this RFP.
4. **AWARD INFORMATION:** Award information will be posted electronically on the County’s Procurement Department web site: <http://www.sierraco.org- Vendor Registry>

5. **AWARDS – MULTIPLE.** The County reserves the right to make multiple awards for projects in support of the Sierra County Flood Commission and Sierra County projects.
6. **SITE VISIT AND MANDATORY PRE-PROPOSAL CONFERENCE:** February 19, 2020 @ 2:00 PM- LOCATION: 1712 N. DATE STREET, TRUTH OR CONSEQUENCES, NM 87901 – Please, note: This Pre-Con will help the Potential Offeror know what the County is looking for in the renovation. Any Potential Offeror not at Pre-Con and not on the list will not be accepted for the rest of the bidding process.
7. **DEADLINE TO SUBMIT WRITTEN QUESTIONS:** Potential Offerors may submit written questions as to the intent or clarity of this RFP until 2:00 PM MST on or before February 27, 2020. All written questions must be sent by e-mail to the Chief Procurement Officer or designated representative.
8. **RESPONSE TO WRITTEN QUESTIONS/RFP AMENDMENTS:** Written responses to written questions and any RFP amendments will be posted to the County Purchasing Office web site link: <http://www.sierraco.org- Vendor Registry>
9. **CANCELLATION:** The County reserves the right to cancel without penalty, this RFP, any resultant Purchase Order/Agreement, or any portion thereof for convenience, unsatisfactory performance, or unavailability of funds.
10. **CASH DISCOUNTS:** The County will take advantage of cash discounts offered whenever possible; however, cash discounts will not be used as a means to determine the lowest cost.
11. **CLARIFICATIONS:** Any clarification of instructions, terms and conditions, insurance, bonds, or offer preparation shall be made only by the CPO stated on the cover sheet of this RFP. Technical clarifications should be addressed to the individual identified on the cover sheet. Clarifications must be in writing and submitted as an addendum to be considered and relied upon as a part of this RFP solicitation.
12. **COPIES OF OFFER:** If submitting by hard copy or on CD, please submit the number of hard/CD copies of your offer as stated on the cover sheet along with all supporting documents. Proposal submitted on a CD must be in PDF format.
13. **LATE SUBMISSIONS:** Late submissions of offers will not be accepted or considered unless it is determined by County that the late receipt was due solely to mishandling by the County or the offer is the only offer received. Late submissions will be returned unopened.
14. **MODIFICATIONS:** Only modifications received prior to the date and time specified for the closing will be accepted. No modifications will be accepted after the opening. Technical

clarifications of the offer may be requested by the Chief Procurement Officer following the opening.

15. **OFFEROR CLARIFICATION:** The Offeror should include with their proposal a local or toll-free number and e-mail address for offer clarifications. Failure to do so may result in the Offer being deemed non-responsive.
16. **PERIOD FOR OFFER ACCEPTANCE:** Offeror agrees that any offer made submitted will be good for a period of ninety (120) calendar days; an additional time period may be requested in the RFP Scope of Work.
17. **PUBLIC INFORMATION:** All information, except that classified as confidential, will become public information at the time that the RFP is awarded. Confidential information must be marked "CONFIDENTIAL" in red letters in the upper right hand corner of the pages containing the confidential information. Price and information concerning the specifications cannot be considered confidential.
18. **REJECTION OF OFFERS:** The County reserves the right to make an award based on the evaluation criteria contained herein, to reject any and all offers or any part thereof, and to accept the offer that is in the best interest of the County.
19. **SUBMISSIONS OF DRAWINGS/LITERATURE:** The submission of samples, drawings and literature to be used in the evaluation of the offer, must be submitted by the designated closing date and time in order to be considered. All submissions shall be made at no expense to the County. Returns shall only be made at the Offers request and expense. Submissions provided on a CD shall be in PDF format.
20. **TAXES:** The County is exempt from Federal Excise Taxes and from New Mexico Gross Receipts Taxes on materials. Services are not exempt. Taxes on services should be included as a separate line item and not included in the base price offer. Applicable taxes are excluded from the RFP evaluation. A non-taxable transaction certificate can be made available by the County to the awarded firm.
21. **WITHDRAWAL OF OFFERS:** Offers may be withdrawn by written notice, electronically (email) or in person by an Offeror or an authorized representative at any time prior to the submittal due date and time. Offerors requiring bid security will result in forfeiture of the bid security if the offer is withdrawn following the opening.
22. **NOTIFICATION OF FINALISTS:** The Evaluation Committee may select finalists to be invited to participate in the subsequent steps of the procurement. The Evaluation Committee

reserves the right not to utilize the finalist process if they deem it in the best interest of the County.

23. **BEST AND FINAL OFFERS:** Finalists may be asked to submit revisions to their proposals for the purpose of obtaining best and final offers on the date to be determined.
24. **ORAL PRESENTATIONS:** Finalists may be required to attend and participate in an oral presentation (date(s) to be determined).
25. **ACCEPTANCE OF CONDITIONS GOVERNING THE PROCUREMENT:** Offerors must indicate their acceptance of the Conditions Governing the Procurement in the letter of transmittal form (see Appendix B). Submission of a proposal constitutes acceptance of the Evaluation Factors contained in Section II of this RFP.
26. **INCURRING COST:** Any cost incurred by the Offeror in preparation, transmittal, presentation of any proposal or material or negotiation associated with their response to this RFP shall be borne solely by the Offeror.
27. **PRIME CONTRACTOR RESPONSIBILITY:** Any contract that may result from this RFP shall specify that the prime contractor is solely responsible for fulfillment of the contract with the County. The County will only make contract payments to the prime contractor.
28. **SUBCONTRACTORS:** Use of subcontractors must be clearly explained in the proposal and each must be identified by name. The prime contractor shall be wholly responsible for contract performance whether or not subcontractors are used. Substitution of subcontractors, after contract award, must receive prior written approval of the County Purchasing Office.
29. **AMENDED PROPOSALS:** An Offeror may submit an amended proposal before the deadline for receipt of proposals. Such amended proposals must be complete replacements for a previously submitted proposal and must be clearly identified as such in the transmittal letter. County personnel will not merge, collate, or assemble proposal materials.
30. **OFFERORS RIGHT TO WITHDRAW PROPOSAL:** Offerors will be allowed to withdraw their proposals at any time prior to the deadline for receipt of proposals. The Offeror must submit a written withdrawal request signed by the Offeror's duly authorized representative addressed to the Chief Procurement Officer. The approval or denial of withdrawal requests received after the deadline for receipt of the proposals is governed by the applicable procurement regulations.
31. **PROPOSAL OFFER FIRM:** Responses to this RFP, including proposal prices, will be considered firm for one hundred twenty (120) days after the due date for receipt of proposals or ninety (90) days after the due date for the receipt of a best and final offer, if one is solicited.

32. DISCLOSURE OF PROPOSAL CONTENTS: The proposals will be kept confidential until a contract is awarded by the awarding authority. At that time, all proposals and documents pertaining to the proposals will be open to the public, except for material which is proprietary or confidential. The Chief Procurement Officer will not disclose or make public any pages of a proposal on which the Offeror has stamped or imprinted "proprietary" or "confidential" subject to the following requirements.

Proprietary or confidential data shall be readily separable from the proposal in order to facilitate eventual public inspection of the remaining portions of the proposal. Confidential data is normally restricted to confidential financial information concerning the Offeror's organization and data that qualifies as a trade secret in accordance with the Uniform Trade Secrets Act, 57-3A-I to 57-3A-7 NMSA 1978. The price of products offered or the cost of services proposed shall not be designated as proprietary or confidential information.

If a request is received for disclosure of data for which an Offeror has made a written request for confidentiality, the Purchasing Agent shall examine the Offeror's request and make a written determination that specifies which portions of the proposal should be disclosed. Unless the Offeror takes legal action to prevent the disclosure, the proposal will be so disclosed. The proposal shall be open to public inspection subject to any continued prohibition on the disclosure of confidential data.

33. NO OBLIGATION: This procurement in no manner obligates Sierra County or any of its departments or other subdivisions to the eventual lease, purchase, etc., of any tangible personal property offered or services proposed until a valid written contract is approved by the Chief Procurement Officer and other required approval authorities.

34. TERMINATION: This RFP may be canceled at any time and any and all proposals may be rejected in whole or in part when the County determines such action to be in the best interest of the County.

35. SUFFICIENT APPROPRIATION: Any contract awarded as a result of this RFP process may be terminated if sufficient appropriations or authorizations do not exist. Such termination will be effected by sending written notice to the contractor. The County's decision as to whether sufficient appropriations and authorizations are available will be accepted by the contractor as final.

36. LEGAL REVIEW: The County requires that all Offerors agree to be bound by the General Requirements contained in this RFP. Any Offeror concerns must be promptly brought to the attention of the Chief Procurement Officer.

37. GOVERNING LAW: This procurement and any agreement with Offerors that may result shall be governed by the laws of the State of New Mexico and Federal Government.

- 38. BASIS FOR PROPOSAL:** Only information supplied by the County in writing through the Chief Procurement Officer or in this RFP should be used as the basis for the preparation of Offeror proposals.
- 39. OFFEROR QUALIFICATIONS:** The Evaluation Committee may make such investigations as necessary to determine the ability of the Offeror to adhere to the requirements specified within this RFP. The Evaluation Committee will reject the proposal of any Offeror who is not a responsible Offeror or fails to submit a responsive offer as defined in Sections 13-1-83 and 13-1-85 NMSA 1978.
- 40. RIGHT TO WAIVE MINOR IRREGULARITIES:** The Evaluation Committee reserves the right to waive minor irregularities. The Evaluation Committee also reserves the right to waive mandatory requirements provided that all of the otherwise responsive proposals failed to meet the same mandatory requirements or doing so does not otherwise materially affect the procurement. This right is at the sole discretion of the Evaluation Committee.
- 41. CHANGE IN CONTRACTOR REPRESENTATIVES:** The County reserves the right to require a change in contractor representatives if the assigned representatives are not, in the opinion of the County, meeting its needs adequately.
- 42. NOTICE:** The Procurement Code, Sections 13-1-28 through 13-1-199 NMSA 1978, imposes civil and misdemeanor criminal penalties for its violation. The State of New Mexico criminal statutes also impose felony penalties for bribes, gratuities and kick-backs.
- 43. COUNTY RIGHTS:** The County reserves the right to accept all or a portion of an Offeror's proposal.
- 44. RIGHT TO PUBLISH:** Throughout the duration of this procurement process and contract term, potential Offeror's and contractors must secure from the County written approval prior to the release of any information that pertains to the potential work or activities covered by this procurement or the subsequent contract. Failure to adhere to this requirement may result in disqualification of the Offeror's proposal or termination of the contract.
- 45. OWNERSHIP OF PROPOSALS:** All documents submitted in response to the RFP shall become the property of the County. However any technical or user documentation submitted with the proposals of non-selected Offerors may be returned after the expiration of the protest period, by request, at the expense of the Offeror.
- 46. AMBIGUITY, INCONSISTENCY OR ERRORS IN RFP:** Offerors shall promptly notify the Chief Procurement Officer, in writing, of any ambiguity, inconsistency or error which they discover upon examination of the RFP.

- 47. COMPETITION:** By submitting a proposal, Offeror certifies that they have not, either directly or indirectly, entered into any action in restraint of full competition in connection with the proposal submitted to the County.
- 48. CONFIDENTIALITY:** Any confidential information provided to, or developed by, the contractor in the performance of any agreement resulting from this RFP shall be kept confidential and shall not be made available to any individual or organization by the contractor without the prior written approval of the County of Sierra.
- 49. ELECTRONIC MAIL ADDRESS REQUESTED:** A large part of the communication regarding this procurement will be conducted by electronic mail (e-mail). Offeror must have a valid e-mail address to receive this correspondence.
- 50. USE OF ELECTRONIC VERSIONS OF THIS RFP:** This RFP is being made available by electronic means. If accepted by such means, the Offeror acknowledges and accepts full responsibility to insure that no changes are made to the RFP. In the event of conflict between a version of the RFP in the Offeror's possession and the version maintained by the County, the version maintained by the County shall govern.
- 51. BACKGROUND INVESTIGATIONS:** Sierra County is committed to the safety of its employees, contractors and the community it serves. To that end, any firm awarded a contract shall be required to assure that the personnel assigned to the project do not possess criminal records that would violate the standards for employment. The successful Offeror(s) must certify that the company and its' employees are or will be in compliance with those standards for the project awarded.

REQUEST FOR PROPOSAL (RFP) STANDARD TERMS AND CONDITIONS

The purchases of materials and/or services awarded under this RFP shall be subject to the County's "Standard Terms and Conditions" and all information and statements contained in this Request for Proposal. Offerors may submit alternate terms and conditions; however, County reserves the right to reject the language if it is determined not to be in the best interest of County.

The following General Terms and Conditions are an equal and integral part of this Request For Proposal (RFP). The terms, conditions and specifications contained in this RFP along with any attachments and the Offerors' response may be incorporated into any Purchase Order/ Agreement issued as a result of this RFP, including any addenda. The County reserves the right to negotiate with a successful Offeror (Contractor) provisions in addition to those stipulated in this RFP. The contents of this RFP, as revised and/or supplemented, and the successful Offerors' proposal may be incorporated into the Contract. Should an Offeror object to any of the County's Standard Terms and Conditions the Offeror must propose specific alternative language that would be acceptable to the County. General references to the Offerors' terms and conditions or attempts at complete substitutions are not acceptable to the County and will result in disqualification of the

Offerors' proposal. Offerors' must provide a brief statement of the purpose and impact, if any, of each proposed change; followed by the specific proposed alternate wording.

Any proposed changes to the terms and conditions attached to this RFP must be stated in Offerors' proposal in a Section marked "STANDARD TERMS AND CONDITIONS". Offerors are cautioned that any changes to the terms and conditions that are NOT stated in the RFP response will not be entertained by the County at a later date. Any provisions in any proposal, quotation, acknowledgment or other forms or contract documents applicable to the services that are inconsistent, or in conflict, with any provisions of this RFP or the resultant contract will be ineffective and inapplicable.

The County reserves the right to reject a proposal on the basis the compromising language cannot be accepted by the County. Any additional terms and conditions which may be the subject of negotiation will be discussed only between the County and the successful Offeror and shall not be deemed an opportunity to amend the Offeror's proposal.

An Awardee of a Price Agreement established with the County has the opportunity to market the resultant Price Agreement to other local public bodies and state agencies under the State of New Mexico Public Purchases and Property Act, NMSA 1978, Article 1, Procurement, Section 13-1-129, "Procurement under existing contracts."

- 1. ACCEPTANCE AND REJECTION:** If prior to final acceptance, any goods or services are found to be defective or not as specified, or if the County is entitled to revoke acceptance of them the County may reject or revoke acceptance, require Contractor to correct without charge within a reasonable time, or require delivery at an equitable reduction in price, at the County's option. Contractor shall reimburse the County for all incidental and consequential costs related to unaccepted goods or services. Notwithstanding final acceptance and payment, Contractor shall be liable for latent defects, fraud, or such gross mistakes as amount to fraud. Acceptance of goods or services shall not waive the right to claim damages for breach of contract.
- 2. APPROPRIATIONS:** The terms of this Agreement are contingent upon sufficient appropriations and authorization being made by the Board of County Commissioners for the performance of each task order assigned under this Agreement. If sufficient appropriations and authorization are not made by the Board of County Commissioners, this Agreement shall terminate immediately upon written notice being given by the County to the Contractor. The County's decision as to whether sufficient appropriations are available shall be accepted by the Contractor and shall be final. If the County proposes an amendment to the Agreement to unilaterally reduce funding, the Contractor shall have the option to terminate the Agreement or to agree to the reduced funding, within thirty (30) days of receipt of the proposed amendment.

3. **ASSIGNMENT:** Any resultant Purchase Order/Agreement may be assignable by the County. Except as to any payment due hereunder, any resultant Purchase Order/Agreement shall not be assignable by Contractor without written approval from the County.
4. **AUTHORITY:** If Contractor is other than a natural person, the individual(s) signing this Agreement on behalf of Contractor represents and warrants that he or she has the power and authority to bind Contractor, and that no further action, resolution, or approval from Contractor is necessary to enter into a binding contract.
5. **CHANGES:** The County may make changes within the general scope of any resultant Purchase Order/Agreement by giving notice to Contractor and subsequently confirming such changes in writing. If such changes affect the cost of, or the time required for performance of a resultant Purchase Order/Agreement, an appropriate equitable adjustment shall be made. No change by Contractor shall be recognized without written approval of the County. Any claim of Contractor for an adjustment under this Paragraph must be made in writing within thirty (30) days from the date of receipt by Contractor of notification of such change. Nothing in this Paragraph shall excuse Contractor from proceeding with the performance of the Purchase Order/Agreement as changed hereunder.
6. **COMPENSATION:**
 - A. The County shall pay to the Contractor in full payment for services satisfactorily performed under the individual Task Orders based on the schedule of payments contained in the individual task order. In no event will the Contractor be paid any amount in excess of the specified total amount payable in the individual task order without the task order being amended in writing.
 - B. Payment is subject to availability of funds pursuant to the Appropriations Paragraph set forth below and to any negotiations between the parties from year to year pursuant to Article 1, Scope of Work.
 - C. Contractor must submit a detailed statement accounting for all services performed, as specified in the individual task order. If the County finds that the services are not acceptable, within thirty days after the date of receipt of written notice from the Contractor that payment is requested, it shall provide the Contractor a letter of exception explaining the defect or objection to the services, and outlining steps the Contractor may take to provide remedial action. The County will continue to pay Contractor for any undisputed amounts pursuant to Article 6 (A). Upon certification by the County that the services have been received and accepted, payment shall be tendered to the Contractor within thirty days after the date of acceptance. If payment is made by mail, the payment shall be deemed tendered on the date it is postmarked. However, the County shall not incur late charges, interest, or penalties for failure to make payment within the time specified herein.

- D. The payment of taxes due for any money received under this Agreement shall be the Contractor's sole responsibility and shall be reported under the Contractor's Federal and State tax identification number(s).
7. **CONFIDENTIALITY:** Any confidential information provided to or developed by the Contractor in the performance of this Agreement shall be kept confidential and shall not be made available to any individual or organization by the Contractor without the prior written approval of the County.
8. **CONTRACTOR'S EMPLOYEES AND AGENTS:** Contractor shall have complete charge and responsibility for persons employed by Contractor and engaged in the performance of the specified work. The Contractor, its agents and employees state that they are independent contractors and not employees of the County. Contractor, its agents and employees shall not accrue leave, retirement, insurance, bonding or any other benefit afforded to employees of the County as a result of any resultant Purchase Order/Agreement.
9. **DISCLAIMER AND HOLD HARMLESS:** Sierra County shall not be liable to the Contractor, or the Contractor's successors, heirs, administrators, or assigns, for any loss, damage, or injury, whether to Contractor's person or property, occurring in connection with Contractor's performance of Contractor's duties according to this Agreement. Contractor shall hold Sierra County harmless from all loss, damage, and injury, including court costs and attorney fees, incurred by Sierra County in connection with the performance by Contractor of Contractor's duties according to this Agreement.
10. **DISCOUNTS:** If prompt payment discounts apply to any resultant Purchase Order/Agreement, any discount time will not begin until the materials, supplies, or services have been received and accepted and a correct invoice has been received by the County's Accounts Payable Department. In the event testing is required prior to acceptance, the discount time shall begin upon completion of the tests and acceptance.
11. **ENFORCEMENT OF AGREEMENT:** A party's failure to require strict performance of any provision of this Agreement shall not waive or diminish that party's right thereafter to demand strict compliance with that or any other provision. No waiver by a party of any of its rights under this Agreement shall be effective unless expressed in writing, and no effective waiver by a party of any of its rights shall be effective to waive any other rights.
12. **ELIGIBILITY FOR PARTICIPATION IN GOVERNMENT PROGRAMS:** Each party represents that neither it nor any of its management or any other employees or independent contractors who will have any involvement in the services or products supplied under a resultant Purchase Order/Agreement, have been excluded from participation in any government healthcare program, debarred from or under any other

federal program (including but not limited to debarment under the Generic Drug Enforcement Act), or convicted of any offense defined in 42 U.S.C. Section 1320a-7, and that each party, its employees and independent contractors are not otherwise ineligible for participation in federal healthcare programs. Further, each party represents that it is not aware of any such pending action(s) (including criminal actions) against each party or its employees or independent contractors. Each party shall notify the other immediately upon becoming aware of any pending or final action in any of these areas.

- 13. EQUAL OPPORTUNITY AND AFFIRMATIVE ACTION:** In performing or providing the services and goods required under a resultant Purchase Order/Agreement, each party shall be an equal opportunity employer and shall conform to all affirmative action and other applicable requirements; accordingly, each party shall neither discriminate nor permit discrimination in its operations or employment practices against any person or group of persons on the basis of race, age, religion, color, national origin, ancestry, sex, physical or mental handicap or medical condition, sexual preference, prior military involvement or any other manner prohibited by law.
- 14. F.O.B:** Unless stated otherwise, the price for goods is F.O.B. the place of destination, and the place of destination is the County's designated campus address.
- 15. GOVERNING LAW:** In any action, suit or legal dispute arising from this Agreement, the Contractor agrees that the laws of the State of New Mexico shall govern and that venue will lie in the Seventh Judicial District Court in Sierra County. By execution of this Agreement, Contractor acknowledges and agrees to the jurisdiction of the courts of the State of New Mexico over any and all lawsuits arising under or out of any term of this Agreement.
- 16. INDEMNIFICATION AND INSURANCE:** Contractor assumes the entire responsibility and liability for losses, expenses, damages, demands and claims in connection with or arising out of any actual or alleged personal injury (including death) and/or damage or destruction to property sustained or alleged to have been sustained in connection with or arising out of the goods delivered by Contractor or the performance of the work by Contractor its agents, employees, sub-contractors or consultants, except to the extent of liability arising out of the negligent performance of the work by or willful misconduct of the County. Contractor shall indemnify, defend and hold harmless the County, its officers, agents, and employees from any and all liability for such losses, expenses, damages, demands, and claims and shall defend any suit or action brought against any or all of them based on any actual or alleged personal injury or damages and shall pay any damage costs and expenses including attorneys' fees, in connection with or resulting from such suit or action. Contractor will also indemnify, defend and hold harmless the County against any joint and several liabilities imposed against the County with respect to strict products liability claims attributable to the fault of the Contractor.

Contractor agrees that it and its sub-contractors will maintain general liability, product liability and property damage insurance in reasonable amounts (at least equal to the New Mexico Tort Claims Act limits) covering the above obligation and will maintain workers' compensation coverage covering all employees performing under a resultant Purchase Order/Agreement on premises occupied by or under the control of the County. The liability of the County will be subject in all cases to the immunities and limitations of the New Mexico Tort Claims Act, Sections 41-4-1 et seq. NMSA 1978, as amended."

17. INDEPENDENT BUSINESS: Neither Contractor nor any of its agents shall be treated as an employee of the County for any purpose whatsoever. Contractor declares that Contractor is engaged in an independent business and has complied with all federal, state and local laws regarding business permits and licenses of any kind that may be required to carry out the said business and the tasks to be performed under any resultant Purchase Order/Agreement. Contractor further declares that it is engaged in the same or similar activities for other clients and that the County is not Contractor's sole or only client or customer.

18. INSPECTION: The County may inspect, at any reasonable time, any part of Contractor's plant or place of business, which is related to performance of any resultant Purchase Order/Agreement. Final Inspection will be made at the destination upon completion of delivery of goods and services. Acceptance of delivery shall not be considered acceptance of the goods and/or services furnished. Final inspection shall include any testing or Inspection procedures required by the Specifications.

19. INSTRUMENTALITIES: Contractor shall supply all equipment, tools, materials and supplies required for the performance of the designated tasks or requirements set forth in any resultant Purchase Order/Agreement or its attachments.

20. INVALID TERM OR CONDITION: If any term or condition of this Agreement shall be held invalid or unenforceable, the remainder of this Agreement shall not be affected and shall be valid and enforceable.

21. MERGER: The contract shall incorporate all the agreements, covenants, and understandings between the parties thereto concerning the subject matter thereof. No prior agreements or understandings, verbal or otherwise, of the parties or their agents shall be valid or enforceable unless embodied in the contract.

22. STATE OF NEW MEXICO MINIMUM WAGE RATES AND PAYROLL SUBMITTALS (State and County Funded Projects): Jobs with an estimate cost >\$60,000 done under this RFP will be subject to the Public Works Minimum Wage Act (13-4-11 through 13-4-17, NMSA, 1978 as amended) and per exhibit labeled "Wage Act." Minimum wages will be supplied at time of award or may be obtained from the State of New Mexico Labor & Industrial Commission, 1596 Pacheco Street, Santa FE, NM 87501.

For all federally funded construction projects greater than \$2,000 the contractor and all subcontractors and their tiers shall deliver or mail legible copies of the certified weekly payrolls for all costs/services invoiced for the project awarded resulting from this RFP to the appropriate oversight agency and the County's Chief Procurement Officer or designated representative in accordance with 29 CFR 3.4. The Contractor shall certify that all payrolls submitted meet or exceed the applicable wage determination as shown in this RFP. See Federal Flow-Down Terms and Conditions and Certification Requirements

Contractor shall be responsible for the collection and submittal of all certified payrolls and shall retain a copy of all payrolls for a period of 3 years from the completion of the project. A copy of all certified payrolls shall be sent weekly to the County's Chief Procurement Officer or designated representative. The Contractor shall be responsible for labeling each submittal with the project name; payroll period; and contractor and/or subcontractor name; each employee's full name and social security number, address and zip code, birth date, sex and occupation, time and day of when employees work week begins, hours worked each day, total hours worked each workweek, basis on which employees IS wages are paid, regular hourly pay rate, total daily or weekly straight-time earnings, total overtime earnings for the workweek, all additions to or deductions from the employee's wages, date of payment and the pay period covered by the payment the County'

23. OTHER APPLICABLE LAWS: Any provision required to be included in a resultant Purchase Order/Agreement by any applicable and valid executive order, federal, state or local law, ordinance, rule or regulation shall be deemed to be incorporated herein.

24. OWNERSHIP: Ownership of Documents - All documents which are prepared by the Contractor or any member of the consulting team that form a part of its services under a resultant Purchase Order//Agreement are the sole property of the County and such works may not be reproduced nor distributed without the express written consent of the County and shall be delivered to the County upon termination and or completion of this Purchase Order/Agreement if the County so requests. The Contractor shall be responsible for the protection and/or replacement of any original documents in its possession. The County shall receive all original drawings and the Contractor shall retain a reproducible copy.

a. *Work Made for Hire* - For the consideration payable under a resultant Purchase Order/Agreement, the work product required by the Purchase Order/Agreement shall be considered a work made for hire within the meaning of that term under the copyright laws of the United States, applicable common law and corresponding laws of other countries. The County shall have the sole right and authority to seek statutory copyright protection and to enjoy the benefits of ownership of the work. The party performing the work hereby assigns all rights, title and interest in and to the work to the County and shall require all members of the consulting team to agree in writing that they assign all right, title and interest in work product required by the Purchase Order/Agreement to the County.

b. *Inventions.* For the consideration payable under a resultant Purchase Order/Agreement, the Contractor agrees to report any invention arising out of the Work required by the Purchase Order/Agreement with the County. The County shall have sole right and authority to seek statutory patent protection under United States and foreign patent laws and to enjoy the benefits of ownership of the invention, whether or not the invention was required of the Contractor or member of the consulting team as part of the performance of Work. The Contractor hereby assigns all right, title and interest in and to inventions made in the course of the Work to the County and agrees to execute and deliver all documents and do any and all things necessary and proper to effect such assignment. Contractor shall require all members of the Consulting Team to agree in writing that they will execute and deliver all documents and do any and all things necessary and proper to effect assignment of inventions arising out of the Work required by the Purchase Order/Agreement with the County.

c. *Survival of Provision.* This provision shall survive expiration and termination of the Purchase Order/Agreement.

25. PATENT AND COPYRIGHT INDEMNITY: Contractor shall indemnify, defend and hold harmless the County against all losses, liabilities, lawsuits, claims, expenses (including attorneys' fees), costs, and judgments incurred through third party claims of infringement of any copyright, patent, trademark or other intellectual property rights.

26. PAYMENT TERMS: Upon written request from Contractor for payment, the County shall, within 30 days, issue a written certification of complete or partial acceptance or rejection, with payment to follow within 30 days after certificate of acceptance.

27. PAYROLL OR EMPLOYMENT TAXES: No federal, state, or local income, payroll or employment taxes of any kind shall be withheld or paid by the County with respect to payments to Contractor or on behalf of Contractor its agents or employees. Contractor shall withhold and pay any such taxes on behalf of its employees as required by law. The payroll or employment taxes that are the subject to this paragraph include but are not limited to FICA, FUTA, federal personal income tax, state personal income tax, state disability insurance tax, and state unemployment insurance tax. If Contractor is not a corporation, Contractor further understands that Contractor may be liable for self-employment (Social Security) tax, to be paid by Contractor according to law.

28. PENALTIES: The Procurement Code, Section 13-1-28 at seq. NMSA 1978, as amended imposes civil and criminal penalties for its violation. In addition, the New Mexico criminal statutes impose criminal penalties for bribes, gratuities and kickbacks.

29. PUBLIC WORKS PERFORMANCE AND PAYMENT BONDS: A performance bond and a payment bond, covering materials and labor, each in the amount of 100% of the contract cost may be required. The bond must be executed by the bidder with a surety

company authorized to do business in New Mexico or other sureties approved by the State Board of Finance. The performance and payment bonds must be received by the Buyer issuing the award within five (5) days of the award and must reference this RFP Number on the face of the documents. All performance and payment bonds must meet the requirements of 13-4-18 NMSA, 1978, as amended

30. PURCHASE ORDER/AGREEMENT: Any resultant Purchase Order/Agreement shall be the sole and entire Purchase Order/Agreement between the parties; any documents incorporated into the Purchase Order/Agreement are listed explicitly on the front side of the Purchase Order/Agreement, or are incorporated by implication by the terms of any resultant Purchase Order/Agreement. Any terms inconsistent with or in addition to any resultant Purchase Order/Agreement proposed by Contractor are deemed rejected unless agreed to in writing by an appropriate County official.

31. RELEASE THE COUNTY COMMISSIONERS: The Contractor shall, upon final payment of the amount due under the contract, release the County Commissioners of the Sierra County, their officers and employees and the State of New Mexico from liabilities, claims and obligations whatsoever arising from the contract. The Contractor agrees not to purport to bind the Sierra County of New Mexico or the State of New Mexico to any obligation not assumed in the contract by the County Commissioners of Sierra County of New Mexico or the State of New Mexico unless the Contractor has express, written authority to do so, and then only within the strict limits of that authority.

32. RETENTION OF RECORDS: Contractor will maintain detailed records indicating the date, time and nature of services provided under any resultant Agreement for a period of at least five years after termination of the Agreement, and will allow access for inspection by the County of New Mexico, the Secretary for Health and Human Services, the Comptroller General and the Inspector General to such records for the purpose of verifying costs associated with provisions of services under the Agreement. The Contractor shall provide all materials and labor necessary to comply with the rules, regulations and ordinances

33. STATUS OF CONTRACTOR: Subcontractor or Sub-Subcontractors: Work performed in the performance of any resultant Agreement by the Contractor, Subcontractor or Sub-Subcontractors and its agents and employees are independent performing services for the County and are not employees of the County of Sierra. The Contractor, Subcontractor or Sub-Subcontractors and its agents and employees shall not accrue leave, retirement, insurance, bonding, use of county vehicles, or any other benefits afforded to employees of the County of Sierra as a result of this Agreement. The Contractor, Subcontractor or Sub-Subcontractors acknowledges that all sums received hereunder are reportable by the Contractor, Subcontractor or Sub-Subcontractors for tax purposes, including without limitation, self-employment and business income tax. The Contractor, Subcontractor or Sub-Subcontractors agrees not to purport to bind the County of Sierra unless the Contractor, Subcontractor or Sub-Subcontractors has express written authority to do so, and then only within the strict limits of

that authority.

34. SUBCONTRACTING: The Contractor shall not subcontract any portion of the delivery of goods or services to be performed under this Agreement without the prior written approval of the County. Subcontractors listed in an approved task order constitute approval of the County. No such subcontract shall relieve the Contractor from its obligations and liabilities under this Agreement, nor shall any subcontract obligate direct payment from the County. In all cases, the Contractor is solely responsible for fulfillment of this Agreement.

35. TERM: This Agreement is for one (1) year from the date of approval by the Sierra County Board of County Commissioners. This Contract will automatically renew on an annual basis, for up to three (3) additional one (1) year terms unless terminated pursuant to Article 37 (Termination for Convenience), Article 38 (Termination for Cause), or Article 2 (Appropriations). In accordance with Section 13-1-150 NMSA 1978, no term for a professional services contract, including extensions and renewals, shall exceed four years, except as set forth in Section 13-1-150 NMSA 1978.

36. TERMINATION FOR CONVENIENCE:

A. Termination. This Agreement may be terminated by either of the parties hereto upon written notice delivered to the other party at least thirty (30) days prior to the intended date of termination. Except as otherwise allowed or provided under this Agreement, the County's sole liability upon such termination shall be to pay for acceptable work ordered and performed prior to the Contractor's receipt of the notice of termination, if the County is the terminating party, or the Contractor's sending of the notice of termination, if the Contractor is the terminating party; provided, however, that a notice of termination shall not nullify or otherwise affect either party's liability for pre-termination defaults under or breaches of this Agreement. The Contractor shall submit an invoice for such work within thirty (30) days of receiving or sending the notice of termination. Notwithstanding the foregoing, this Agreement may be terminated immediately upon written notice to the Contractor if the Contractor becomes unable to perform the services contracted for, as determined by the County or if, during the term of this Agreement, the Contractor or any of its officers, employees or agents is indicted for fraud, embezzlement or other crime due to misuse of government funds or due to the Appropriations paragraph herein.

THIS PROVISION IS NOT EXCLUSIVE AND DOES NOT WAIVE THE COUNTY'S OTHER LEGAL RIGHTS AND REMEDIES CAUSED BY THE CONTRACTOR'S DEFAULT/BREACH OF THIS AGREEMENT.

B. Termination Management. Immediately upon receipt by either the County or the Contractor of notice of termination of this Agreement, the Contractor shall: 1) not incur any further obligations for salaries, services or any other expenditure of funds under this Agreement without written approval of the County; 2) comply with all directives issued by the County in the notice of termination as to the performance of work under this

Agreement; and 3) take such action as the County shall direct for the protection, preservation, retention or transfer of all property titled to the County and records generated under this Agreement. Any non-expendable personal property or equipment provided to or purchased by the Contractor with contract funds shall become property of the County upon termination and shall be submitted to the County as soon as practicable.

37. TERMINATION FOR CAUSE:

A. County may by written notice terminate this Agreement in whole or in part for Contractor's default if the Contractor fails to comply with the provisions of this Agreement or fails to make progress so as to endanger performance and does not cure such failure within a reasonable period of time. In such event, County may otherwise secure the materials, supplies or services ordered, and Contractor shall be liable for damages suffered by County thereby, including incidental and consequential damages. If after notice of termination, County determines Contractor was not in default, or if Contractor's default is due to failure of County, termination shall be deemed for the convenience of County. The rights and remedies of County provided in this paragraph shall not be exclusive and are in addition to any other rights and remedies provided by law or under this Agreement as used in this paragraph, the word "Contractor" includes Contractor's sub-suppliers at any tier.

THIS PROVISION IS NOT EXCLUSIVE AND DOES NOT WAIVE THE COUNTY'S OTHER LEGAL RIGHTS AND REMEDIES CAUSED BY THE CONTRACTOR'S DEFAULT/BREACH OF THIS AGREEMENT.

B. In the event a termination for cause notice is issued by the County, the Contractor shall: 1) not incur any further obligations for salaries, services or any other expenditure of funds under this Agreement without written approval of the County; 2) comply with all directives issued by the County in the notice of termination as to the performance of work under this Agreement; and 3) take such action as the County shall direct for the protection, preservation, retention or transfer of all property titled to the County and records generated under this Agreement. Any non-expendable personal property or equipment provided to or purchased by the Contractor with contract funds shall become property of the County upon termination and shall be submitted to the County as soon as practicable.

38. TITLE AND DELIVERY: Title to the materials and supplies passed hereunder shall pass to the County upon acceptance at the FOB point specified, subject to the right of the County to reject. For any exception to the delivery date specified, Contractor shall give prior notification and obtain approval thereto from the County's Purchasing Department. Time is of the essence and the Purchase Order/Agreement is subject to termination for failure to deliver on time.

- 39. WAIVER:** The Contract shall contain a provision that states that no waiver of any breach of the Contract or any terms or conditions thereof shall be held to be a waiver of any other or subsequent breach; nor shall any waiver be valid, alleged or binding unless the same shall be in writing and signed by the party to have granted the waiver.
- 40. WARRANTIES:** Contractor warrants the goods and/or services furnished to be exactly as specified in any resultant Purchase Order/Agreement, free from defects in Contractor's design, labor, materials and manufacture, and to be in compliance with any drawings or specifications incorporated herein and with any samples furnished by Contractor. All applicable UCC warranties express and implied are incorporated herein.
- 41. WORKERS COMPENSATION:** No workers compensation insurance has been or will be obtained by THE COUNTY on account of Contractor or its employees or agents. Contractor shall comply with the workers compensation laws with respect to Contractor and Contractor's employees and agents.
- 42. WORKMANSHIP/COOPERATION:** All work shall be done in a neat, workman-like manner using acceptable equipment and methods consistent with that level of care and skill ordinarily exercised by members of the profession/trade and in accordance with sound professional/trade standards and ethical practice. The Contractor will cooperate with the County and other contractors and coordinate their work involving other contractors through the County's authorized representative.

I. INTRODUCTION

A. PURPOSE OF THIS REQUEST FOR PROPOSALS

The County is seeking a team under a single, responsible lead entity, which includes design and construction, the “Design Build Team.” The County intends to issue one contract to the selected Offeror for the entire scope of work.

Concurrently the county purchase the old Amins Building and are seeking to renovate the building to be the new Sierra County Administration Building. Sierra County now seeks to hire an engineering construction team to perform design, improvements, repairs and remediation construction services, for the new building, location: **Address:** 1712 N Date St, Truth Or Consequences, NM 87901. Previously known as Amins Furniture Store.

Note: All questions pertaining to this RFP shall be directed to the Chief Procurement Officer

The new administration building will house all Sierra County departments: Sierra Administration, Elected Officials, Flood Commission, 911 Facilities (SCRDA), DWI Program and District Attorney’s offices.

Selection of the Engineering-Construction Contractor shall be based on qualifications, experience and record of performance repairing and upgrading infrastructure as described above. The form of agreement shall be as identified in Appendix F.

Relationship of County (“Owner”) and the successful Contractor - The successful Contractor accept a relationship of trust and confidence between itself and Sierra County. The Contractor shall agree to furnish his/her/its’ best skill and best judgment and to cooperate with County and all regulatory agencies, and any design professionals associated with the oversight and funding of each project to be awarded as a result of this Request For Proposal solicitation. The successful Contractor shall furnish efficient Contractor reviews, business administration, field supervision and shall use his/her/its’ best efforts to perform the work in the best and most expeditious, economical manner consistent with the interests of the County, and in strict conformity with State, Federal and local rules, laws and regulations.

This RFP contains specific requests for information. In responding to this RFP, Offerors are encouraged to provide additional information if Offeror believes that information is to be relevant.

II. SUMMARY SCOPE OF WORK

The duties and responsibilities of the successful engineering and construction contractors include, but may not be limited to performing the following services:

The work consists of design and construction services, based on the remodeling of the old Amins Building -Address: 1712 N Date St, Truth Or Consequences, NM 87901 for a new all-inclusive Sierra County Administration Building.

Partnering

The assignment will include a written or/and oral scope of work and anticipate time frame for completion. The work shall have engineered drawings to meet the needs of the construction services. Sierra County desires a cooperative process, the selected Design Build Team that will facilitate close coordination of work throughout all phases of the project. The Design Build Team will define roles and responsibilities, establish line of communication, and confirm project requirements. All work will be paid base on the Contractor's fixed price quote. All possible occurrences should be taken into consideration when providing the cost for services.

Generally, the work is renovating an existing building for the following: Administration, consists of the County Commission Chambers, office spaces for the following: County Manager, Chief Procurement Officer, Human Resources, Finance Director, Accounts Payable, Indigent, GIS, Emergency Services and Flood Commission. The elected official's office spaces will include the Assessors, Treasures, Clerks and Probate Judge. The District Attorney will require office space in addition to DWI and 911 Dispatching.

Code Requirements

The Design Build Team is responsible for compliance with all applicable codes and agency requirements. The project is to conform to code requirements enforced by the State of New Mexico and local jurisdictions.

Roles and Responsibilities

1. The Design Build Team must be composed of experienced and highly regarded professionals who have demonstrated their ability to procure superior facilities in a cost-effective basis.
 - a. The Design Build Team as submitted must include, at minimum:
 - General Contactor
 - Design Professional Team
 - Furniture and Fixture Suppliers

Other team members may be identified in the submittal or proposed for the County approval at a later date. All but one team member shall be considered subcontractors to the Offeror unless they are on a joint legal venture.

2. The responsibilities of the Design Build Team will include:
 - a. Become full informed about the Project and have the experience and ability necessary to perform the required services;
 - b. This will include but not limited to:
 - Coordinating and working closely with the Project Manager and CPO from Sierra County
 - Site development planning
 - Consider Owner's and Using Agency's staff input on conceptual design
 - Making presentations to and obtaining feedback from Owner's and Using Agency's staff
 - Preparing plans, specifications and construction documents (all materials used in construction shall meet all applicable code and regulatory requirements)
 - Provide and obtain approval of the Design from the Owner's Team at the completion of schematic design, design development phases and construction documents phase
 - Proved general architectural/engineering supervision and contract administration during construction and provide **on-site** observation during construction
 - c. Analyze alternatives and design the most suitable improvements consistent with economic feasibility, environmental characteristics, and expected life of improvement, energy conservation, and state-of-the-art technology
 - d. Perform required services in an expeditions manner to coincide with the Project Schedule
 - e. Furnish qualified construction personnel who will keep Owner's Team advised on matters pertaining to the construction of the Project, and who will work towards the goals of obtaining results prescribed by the plans and specifications. This will require cooperation between the Owners' Team and the Project Manager with meetings on a regulatory bases to facilitate such cooperation.
 - f. Possess professional ethics and qualifications and represent Owner in accordance with a high standard of professional conduct
 - g. Secure all applicable building permits
 - h. Provide all materials, supplies and labor for the renovation of the building and site including required furniture, fixtures and equipment
 - i. Perform installation and construction of the renovation in all efficient and safe manner according to the Design Build Team's design, specification and schedule
 - j. Conduct weekly progress meeting with the Owner's Team

Contract Administration

1. Site Design including location of on-site utility systems, off-site utility works, fire protection system drainage system, building orientation, property lines, easements, local setback requirements, site access, land forms and environmental determinates.
2. Architectural Design including facility floor and roof plans, sections, elevations, local height limitations, preliminary selection of building systems and material, net program areas and facility requirements for 911 Dispatch area and temperature control areas located in the building for sensitive equipment's.
3. Structural Design including materials and structural system, alternative structural systems with cost consideration studies. The Design Build Team shall investigate the structural systems and material t they consider suitable for this project in regard to the local and state codes. The Design Build Team shall prepare design sketches, calculations, and cost estimates of the various systems studies and recommendations and justifications of the system proposed to utilize.
4. Mechanical Design Documents setting forth in detail the mechanical construction requirements for heating, ventilating, air condition, refrigeration, fire and safety, plumbing and sanitary engineering.
5. Electrical Design Documents setting forth in detail the electrical construction requirements for transformers, vaults, electrical and telephone closets, power distribution systems, auxiliary power systems, switch gear, generator, lighting, switch, fire and safety and signal system.
6. Cost Estimate (s) - setting forth in detail quantities of materials, labor, profit, overhead, insurance, taxes, etc. for the building renovation, as well as all sight work.
7. Specifications for all sections of the work involved for this renovation setting forth in detail all requirements for the construction fully coordinated with the drawings for this Request for Proposal.

Quality Assurance/Quality Control (QA/QC)

In an effort to reduce construction change orders due to design errors and omissions, the Design Build Team will initiate a Quality Assurance/Quality Control program. The Design Build Team shale develop, execute and demonstrate that the project plans and specifications have gone through a rigorous review and coordination effort. The requirements are as follows:

1. **Fee Proposal:** The Design Build Team shall provide an outline of these actions that the firm will take during the design process along with its associated fee.
2. **2 Weeks after the NTP:** The Design Build Team shall submit a detailed QA/QC Plan describing each step that will be taken during the development of the various phases of design. Each step should have an appropriate space where a senior member of the firm can initial and date when the action is completed. This person will be disclosed in the RFP documents.
3. **100% Submittal:** The Design Build Team shall submit the Completed QA/QC Plan along with the latest marked-up documents (plans, specifications, etc.) necessary to ensure that the thorough review and coordination have been completed.

Shop Drawings and Submittals

The Design Build Team will check with Project Manager and CPO for approval and review of certain submittals and when making recommendations. Such responsibility shall be carried out with reasonable promptness as to cause no delay.

The Design Build Team shall review shop drawings, detail drawings, schedules, descriptive literature and samples, testing laboratory reports, field test data and review the color, texture and suitability of materials for conformity with the design concept and construction documents. The Design Build Team shall recommend approval, disapproval, or other suitable disposition. The Design Build Team shall evaluate the submittals with reference to any companion submittals that constitute a system.

Site Visits and Inspections

During the Design Build Period the Project Manager and or CPO shall make visits to the project site. Should other County Staff or Elected Officials come to the sight making suggestions or changes they are to be referred back to the Project Manager and CPO. None of their recommendations are to be added or omitted. Site visits shall be made as when requested by the Contracting Lead or authorized representative. Such visits shall be made weekly, during intermediates systems, air-conditioning inspections, for partial and final inspection and for special purposes, as a visit to the site by one person per any part of the day.

Only registered architects and engineers thoroughly familiar with the project may make these site visits. The Contracting Lead has the prerogative to determine the professional discipline (s) required for each visit. The Design Build Team shall observe the construction, advice the Resident Engineer of any deviations or deficiencies. A site inspection report which includes the purpose of the inspection, items reviewed, deficiencies observed, recommendations and additional actions required, shall be furnished to the Contracting Lead, Project Manager and CPO within three working day following the site visit.

Transportation

The Contractor's bid shall include any and all delivery costs for equipment delivered to the awarded project. Incudes any and all heavy machinery and supplies.

Wage Rates

The following wage rates apply for projects awarded resulting from this RFP. Labor Rates to be paid to all laborers shall include the wage and fringe benefits of the applicable wage rate decisions. **(SEE EXHIBIT F- WAGE RATES)** *New Mexico Local Public Works Exhibit F* (Projects equal to or greater than \$60,000) are subject to the requirements of 13-4-13.1

Equipment

It is anticipated that not all equipment quoted will be new current year models. All equipment shall be in good operating condition, with all safety devices intact and fully functional. All equipment shall be up to code and insured.

Personnel

Contractor shall employ only competent, trained professional heavy equipment operators capable of working in a safe manner. Contractor shall be responsible for adequate supervision and communicate the work directly to his respective employees. The County will not directly supervise the contractor's employees. The County at their sole discretion may order the contractor to remove any employee, that the County deems un-safe or generally unable to complete the desired work at a reasonable time frame.

Work Areas

Much of the work performed by the Design Build Team is performed on site location. All available efforts will be made to protect damage to private property during ingress and egress of equipment to work areas. The contractor shall not do any work outside the authorized limits of construction ordered by the County. Any trespass or damage to property done by the contractor outside the limits of construction shall be immediately addressed and or repaired by the contractor at the contractor's expense.

Funding and Invoicing

Funding may be from Federal, State or Sierra County, or other funding sources. Contractor shall keep accurate records of all work performed and hours worked for each individual, machinery and location. All statements shall reflect the work order number for tracking. Contractor records shall be available for review by the County daily.

Insurance General Liability

The contractor shall maintain a General Liability insurance policy in the amount of \$1,000,000.00 per occurrence naming Sierra County as an additional insured.

Workers Compensation

The contractor shall maintain Workers Compensation insurance for all employees.

Surety Bonds

Note, a 100 percent, Performance and Labor and Materials Payment Bonds shall be required for each construction project in excess of \$25,000.

Photographs

The contractor will take before, daily progress, and after digital photographs of the work assigned. The photographs will be identified by date, location, and a description of the work. Photographs will be provided to the contract administrator on a weekly basis.

C. CHIEF PROCUREMENT OFFICER

The County has designated a Chief Procurement Officer who is responsible for this procurement and whose name, address, and telephone number are listed below. D. DEFINITION OF TERMINOLOGY

This section contains definitions that are used throughout this procurement document, including appropriate abbreviations.

“*Architect*” means a member of the Design Build Team who is a New Mexico licensed architect and is responsible for architectural services.

“*Board of County Commissioners*” (also “*BCC*”) means the elected board in whom all powers of the municipality are vested and who are responsible for the proper and efficient administration of the municipal government.

"Chief Procurement Officer" (also "CPO") means the person or designee authorized by the County to manage or administer a procurement requiring the evaluation of competitive sealed proposals.

"Close of Business" means 5:00 P.M. Mountain Standard Time (MST) or Mountain Daylight Time (MDT), whichever is in effect on the date specified.

"Contract" or "Agreement" means a written agreement for the procurement of items of tangible personal property or services.

"Contractor" means a successful Offeror who enters into a binding contract.

"County" means the County of Sierra, State of New Mexico.

"Design and Build Project Delivery System" means a procurement process by which a Using Agency/Owner contracts with one firm who has the responsibility for the design, construction and delivery of a project under a single contract with the Using Agency/Owner.

"Design Build Team" or "Firm" as the terms used herein, are synonymous with one another and, within their broad definition mean any offeror, who may be a person, a legal entity, a consortium of experts, a joint venture, a team of persons who, though partnership, general or limited or other legal entity, corporation, association, other organizations, or any combination thereof, formally organized so that it may submit a qualified offer in response to a request for proposals and, as a result, who may be considered for a contract award for a design and build project deliver system with a Using Agency/Owner. No distinction is made between formally organized design/build firms and a project-specific design/build firm.

"Desirable" refers to the terms "may", "can", "should", "preferably" or "prefers" which identify a desirable or discretionary item or factor (as opposed to a "mandatory" item or factor).

"Determination" means the written documentation of a decision of the Chief Procurement Officer including findings of fact required to support a decision. A determination becomes part of the procurement file to which it pertains.

"Engineer" means a member of the Design Build Team who is a New Mexico licensed engineer and is responsible for the engineering services.

"Evaluation Committee" means a body appointed by County management to perform the evaluation of Offeror proposals.

"Evaluation Committee Report" means a report prepared by the Chief Procurement Officer and the Evaluation Committee for submission to appropriate approval authorities for contract award that contains all written determinations resulting from the conduct of a procurement requiring the evaluation of competitive sealed proposals.

"Finalist" is defined as an Offeror who meets all the mandatory specifications of this Request for Proposal and whose score on evaluation factors is sufficiently high to merit further consideration by the Evaluation Committee.

"Mandatory" refers to the terms "must", "shall", "will", "is required" or "are required" which identify a mandatory item or factor (as opposed to a "desirable" item or factor). Failure to meet a mandatory item or factor will result in the rejection of the Offeror's proposal.

"Offeror" is any person, corporation, or partnership who chooses to submit a proposal.

"Page" means one (1) side of an 8 ½ X 11 inch sheet of paper. One (1) 8 ½ X 11 inch sheet of paper printed on both sides constitutes two (2) pages. (See, however, Section III.C for the one exception to the 8 ½ X 11 inch page size limitation.)

"Procuring agency of the County" means the department or other subdivision of the County of Sierra that is requesting the procurement of services or items of tangible personal property.

"Purchase Order" or "PO" means the document which directs a contractor to deliver items of tangible personal property or services pursuant to an existing, valid contract.

"Purchasing" means the County of Sierra Purchasing Office or the Sierra County Chief Procurement Officer.

"Purchasing Agent" or "PA" means the Chief Procurement Officer for the County of Sierra.

"Request for Proposals" or "RFP" means all documents, including those attached or incorporated by reference, used for soliciting proposals.

"Responsible Offeror" means an Offeror who submits a responsive proposal and who has furnished required information and data to prove that their financial resources, production or service facilities, personnel, service reputation and experience are adequate to make satisfactory delivery of the services or items of tangible personal property called for in this proposal.

"Responsive Offer" or "Responsive Proposal" means an offer or proposal which conforms in all material respects to the requirements set forth in the request for proposals. Material respects of a request for proposals include, but are not limited to, price, quality, quantity and delivery requirements.

“Statement of Compliance” and “Statement of Concurrence” mean an express, affirmative statement by the Offeror in their proposal, that they agree with or agree to the stated requirement(s). Possible examples of acceptable responses include; “The [NAME HERE] Company agrees to comply with this requirement.”, “The [NAME HERE] Company concurs with this requirement.” and The [NAME HERE] Company agrees to participate as required.”

The Chief Procurement Officer will determine if an offeror is accepted should the form be completed and part of the packet.

Proposals must be sealed and labeled on the outside of the package to clearly indicate that they are in response to the "Sierra County Design Build Sierra County Admiration Building" Request For Proposals and should reference "RFP #2020-07-011". Proposals submitted by facsimile or other electronic means **WILL NOT BE ACCEPTED. This is not a public opening. RFP's will be reviewed by an Evaluating Committee. Offeror's will be notified at a later date.**

A public log will be kept of the names of all Offerors submitting proposals. Pursuant to Section 13-1-116 NMSA 1978, the contents of any proposal shall not be disclosed to competing Offerors prior to contract award.

7. Proposal Evaluation

The evaluation of proposals will be performed by an Evaluation Committee appointed by County management. The Chief Procurement Officer may at her option initiate discussions with Offerors who submit responsive or potentially responsive proposals for the purpose of clarifying aspects of the proposals; please note proposals may be accepted and evaluated without such discussion. **Discussions SHALL NOT be initiated by the Offerors or Staff.**

8. Notification of Finalists

The Evaluation Committee may select finalists to be invited to participate in the subsequent steps of the procurement. The Evaluation Committee reserves the right not to utilize the finalist process if they deem it in the best interest of the County.

9. Best and Final Offers

Finalists may be asked to submit revisions to their proposals for the purpose of obtaining best and final offers on the date indicated in Section I. A (Sequence of Events), above.

10. Oral Presentations

Finalists may be required to attend and participate in an oral presentation (date (s)) to be determined). Only by request. Potential offerors will be contacted directly by the Chief Procurement Officer.

11. Contract Negotiations

If necessary, contract negotiations shall commence with the most advantageous Offeror(s) no later than the date indicated in Section I.A (Sequence of Events), above. In the event that mutually agreeable terms cannot be reached, the County reserves the right to begin negotiations with the next most advantageous Offeror(s) without undertaking a new procurement process.

12. Contract Award

Any contract awarded shall be awarded to the Offeror(s) whose proposal is most advantageous to the County, taking into consideration the evaluation factors set forth in this RFP. Such awards shall be subject to the prior review and approval of the County Commissioners.

13. Multiple Award

Sierra County reserves the right to issue multiple awards. The firms with the highest overall ranking in each Category from the shortlist after interviews, if applicable, will be recommended for award.

The selected firms will be submitted to the County Commission for approval of award for the applicable categories of work. The County will then enter into construction contract consistent with AIA Document A201 – 2007 and Supplementary Conditions (Appendix F) with each of the awarded firms for the applicable categories of work.

14. Protest Deadline

Any protest by an Offeror must be timely, in conformance with, and will be governed by Sections 13-1-172 through 13-1-176 NMSA 1978 and Sierra County Procurement Policy.

The fifteen (15) day protest period for the submittal of a timely protest shall begin on the day following the contract award. Protests must be written and must include the name and address of the protestor and the Request for Proposals number. It must also contain a statement of grounds for protest including appropriate supporting exhibits, and it must specify the ruling requested from the Chief Procurement Officer. Offerors shall deliver five (5) printed and one (1) electronic copies of their proposal to the location specified for the delivery and receipt of proposals on or before the closing date and time for receipt of proposals. *(Identical copies are defined as the original plus the number of additional copies needed to fulfill the requirement. For example, a requirement for five (6) identical copies would be fulfilled by submitting the original and five [5] copies of the original.)* The original copy should be clearly marked "ORIGINAL" on the front cover and shall contain original signatures

C. PROPOSAL FORMAT

The proposal must be limited in format and length. Format will be 8-1/2 inch x 11 inch, with fold-out sheets allowed up to 11 inch x 17 inch in size. All fold-out sheets, up to a maximum of 11 inch x 17 inch sheets, will be counted as two (2) pages and shall be labeled as such. Length of the proposal shall be limited *to a maximum number of twenty-five (25) pages* (printed sheet faces) of text and/or graphic material *in response to the evaluation criteria both non-weighted and weighted criteria*. Text shall be of font size no smaller than 10 point using font type Times New Roman or equivalent. Any questions regarding format requirements shall be directed to the Procurement Manager prior to submittal of documents.

Provide a list of any projects on which the firm was the Contractor and was terminated, held in default, or failed to complete the work. Include the name of the project, the timeframe of the project and circumstances surrounding the termination or default.

H. Litigation and Claims

Maximum Points: 5

Provide information regarding each and every legal proceeding, administrative proceeding and arbitration pending against the Contractor in the past 5 years.

I. Oral Presentation

Maximum Points: 40

The evaluating committee will select who they would like to see an Oral Presentation on. If no one is selected there will be zero points scored. Only the offerors selected for Oral Presentations will be scored. All others will not be considered for the next phase of this RFP process nor shall they be allowed any points for this section.

PART 2.0 (Re: 1.5 OWNERSHIP AND USE OF DRAWINGS, SPECIFICATIONS AND OTHER INSTRUMENTS OF SERVICE) - SUBSTITUTE THE FOLLOWING FOR THE FIRST SENTENCE OF SUBPARAGRAPH 1.5.1:

“1.5.1 The Drawings, Project Manual Documents and Technical Specifications, notes, and other work developed for the performance of this Contract and copies thereof furnished by the Architect/Engineer shall be the sole property of the Owner with the understanding and agreement that they are to be used only with respect to this Project and are not to be used on any other Project, or for any other purpose.”

PART 3.0 (Re: 3.6 TAXES) - ADD THE FOLLOWING TO PARAGRAPH 3.6:

“The Contractor shall comply with the requirements of the state of New Mexico gross receipts law and shall require all subcontractors to comply with the same. Any increase or decrease in gross receipts and local option taxes enacted after the date the Contract is signed shall result in a similar increase or decrease in the contract sum by appropriate modification.”

PART 4.0 (Re: 3.15 CLEANING UP) - ADD THE FOLLOWING TO SUBPARAGRAPH 3.15.1:

“The Contractor shall thoroughly clean the premises at the completion of the Work.”

PART 5.0 (Re: ARTICLE 4 ARCHITECT) - ADD THE FOLLOWING SUBPARAGRAPH 4.1.4:

“4.1.4 Any dispute in connection with such an appointment shall be considered an aggrievement and subject to the provisions of ARTICLE 15 CLAIMS AND DISPUTES.”

PART 6.0 (Re: ARTICLE 4 ARCHITECT) - ADD THE FOLLOWING SUBPARAGRAPH 4.1.5:

“4.1.5 The Owner may, but is not required, to assist the Architect/Engineer to provide administration of the Contract for Construction.”

PART 7.0 (Re: 4.2 ADMINISTRATION OF THE CONTRACT) - ADD THE FOLLOWING TO SUBPARAGRAPH 4.2.3:

“Should the Architect determine that any portion of the Work varies from the requirements of the Contract Documents, the Architect/Engineer shall promptly notify the Owner and the Contractor of the nature of the non-compliance and the correction of the Work required. The Contractor expressly recognizes that the Architect does not owe him any duty to supervise or direct his work as to protect the Contractor from the consequences of his own acts or omissions.”

PART 8.0 (Re: ARTICLE 7 CHANGES IN THE WORK) - DELETE ARTICLE 7 IN ENTIRETY AND SUBSTITUTE THE FOLLOWING “NEW” ARTICLE 7:

“ARTICLE 7 CHANGES IN THE WORK

7.1 CHANGES

7.1.1 Changes in the Work may be accomplished after execution of the Contract, and without invalidating the Contract, by initiation of a Construction Change Directive or order for a minor change in the Work, subject to the limitations stated in this Article 7 and elsewhere in the Contract Documents.

7.1.2 A Construction Change Directive requires agreement by the Owner and the Architect and shall be prepared by the Owner or the Architect on its own initiative or at the request of the Owner’s representative, or the Contractor. To result in a change in the Work, any change in Contract Time, any change in Contract Sum, or any combination of the foregoing, the Construction Change Directive must be included ultimately in a Change Order. An order for a minor change in the Work, without a change in Contract Time or Contract Sum, may be issued by the Architect alone.

7.1.3 Changes in the Work shall be performed under applicable provisions of the Contract Documents, and the Contractor shall proceed promptly, unless otherwise provided in the Construction Change Directive or order for a minor change in the Work.

7.1.4 If unit prices are stated in the Contract Documents or subsequently agreed upon, and if quantities originally contemplated are so changed in a Construction Change Directive that application of such unit prices to quantities of Work proposed will cause substantial inequity to the Owner or Contractor, the applicable unit prices shall be equitably adjusted.

7.2 CONSTRUCTION CHANGE DIRECTIVES

7.2.1 A Construction Change Directive is a written order signed by the Owner and Architect/Engineer, directing a

change in the Work an stating a proposed basis for adjustment, if any, in the Contract Sum or Contract Time, or both. The Owner may by Construction Change Directive, without invalidating the Contract, order changes in the Work within the general scope of the Contract consisting of additions, deletions or other revisions, the Contract Sum and Contract Time being adjusted accordingly.

7.2.2 If the Construction Change Directive provides for an adjustment to the Contract Sum, the adjustment shall be based on one of the following methods:

- .1 mutual acceptance of a lump sum properly itemized and supported by sufficient substantiating data on costs to permit evaluation;
- .2 unit prices stated in the Contract Documents or subsequently agreed upon; or
- .3 cost to be determined in accordance with Subparagraph 7.2.5 with or without a guaranteed maximum.

7.2.3 Upon receipt of a Construction Change Directive, the Contractor shall acknowledge receipt of it on the document, and , if applicable, the Contractor's agreement to its terms, promptly proceed with the change in the Work involved and advise the Architect/Engineer if the Contractor is in disagreement with the method, if any, provided in the Construction Change Directive for determining the proposed adjustment in the Contract Sum or Contract Time.

7.2.4 A Construction Change Directive signed as agreed to by the Contractor indicates the agreement of the Contractor therewith, including adjustment in Contract Sum and Contract Time or the method for determining them. Such agreement shall be effective immediately, shall remain binding for sixty days and shall ultimately be included in a Change Order.

7.2.5 If the Contractor does not respond promptly or disagrees with the method for adjustment in the Contract Sum, the method and the adjustment shall be determined by the Architect/Engineer on the basis of reasonable expenditures and savings of those performing the Work attributable to the change, including, in case of an increase in the Contract Sum, and a reasonable allowance for overhead and profit as set forth in Table 1 below. In such case, and also under Clause 7.2.2, the Contractor shall keep and present, in such form as the Architect/Engineer may prescribe, an itemized accounting together with appropriate supporting data of costs incurred in performing the change required by the Construction Change Directive. Costs for the purposes of this Paragraph 7.2.5 includes only the following:

- .1 material quantities and unit costs;
- .2 labor amounts and hourly rates (identified with specific items of material to be placed or operation to be performed);
- .3 costs inherent in the use of equipment owned by the Contractor, the Subcontractors, and/or the Sub-subcontractors;
- .4 equipment rental, if any;
- .5 worker's compensation and public liability insurance;
- .6 general administration, overhead, supervision, project insurance, bonds and profit, based on the following schedule (subtotal before applying the percentage shown):

- .7 employment taxes under FICA and FUTA; and

.8 state gross receipts and local option tax (Contractor only).

7.2.6 Pending final determination of cost to the Owner, amounts not in dispute may be included in Applications for Payment. The amount of credit to be allowed by the Contractor to the Owner for a change that results in a net decrease in the Contract Sum shall be the amount of net cost decrease plus an amount equal to the net cost decrease multiplied by a percentage of 3% for general administration, overhead, supervision, project insurance, bonds, and profit as specified in Clause 7.2.5.6.

7.2.7 If the Owner and Contractor do not agree with the adjustment in Contract Time or the method for determining it, the adjustment or the method shall be referred to the Architect/Engineer for determination.

7.2.8 When the Owner and Contractor agree with the determination made by the Architect/Engineer concerning the adjustments in the Contract Sum and Contract Time, or otherwise reach agreement upon the adjustments, such agreement shall be effective immediately and shall be recorded by preparation and execution of an appropriate Change Order.

7.3 CHANGE ORDERS

7.3.1 A Change Order is a written instrument prepared by the Architect/Engineer and signed by the Owner, Contractor, and Architect/Engineer, stating their agreement upon all of the following:

- .1 a change in the Work;
- .2 the amount of the adjustment in the Contract Sum, if any, and
- .3 the extent of the adjustment in the Contract Time, if any.

7.3.2 A Change Order may include more than one Construction Change Directive and will customarily be executed after the completion in the Work.

7.4 MINOR CHANGES IN THE WORK

7.4.1 The Architect/Engineer will have authority to order minor changes in the Work not involving adjustment in the Contract Sum or extension of the Contract Time and not inconsistent with the intent of the Contract Documents. Such changes shall be effected by written order and shall be binding on the Owner and Contractor. The Contractor shall carry out such written orders promptly.”

PART 9.0 (Re: PROGRESS AND COMPLETION) - ADD THE FOLLOWING SUBPARAGRAPH 8.2.4:

“8.2.4 The Contractor agrees that the Work shall be prosecuted regularly, diligently and uninterruptedly at a rate of progress that will insure full completion within the Contract Time specified. It is expressly understood and agreed, by and between the Contractor and the Owner, that the Contract time specified for the completion of the Work is reasonable; taking into consideration the average climate conditions, temperature ranges, and usual industrial conditions prevailing in this locality. If the Contractor shall neglect, fail or refuse to complete the Work within the Contract Time, or any proper extension granted by the Owner, then the Contractor agrees, as a part consideration for the awarding of this Contract, not as a penalty but as liquidated damages for such breach of contract as set forth in the Contract Documents, for each and every calendar day that the Contractor shall be in default after the Contract Time.”

PART 10.0 (Re: 8.3 DELAYS AND EXTENSIONS OF TIME) - ADD THE FOLLOWING SENTENCE TO SUBPARAGRAPH 8.3.1:

“Where individual items or designated portions of the Work require changes in completion time, but are not interrelated with items of work governed by the Contract Time, the Architect/Engineer and the Owner may establish by Change Order separate completion dates with separate Liquidated Damages acceptable to the Contractor and leave the Contract Time unchanged.”

PART 11.0 (Re: 9.2 SCHEDULE OF VALUES) - ADD THE FOLLOWING TO SUBPARAGRAPH 9.2:

"This schedule shall include separate line items for costs pertaining to each Cash Allowance item indicated in the Contract Documents and for a reasonable amount, which shall be designated as 'Final Administrative Closeout', attributable to Contractor completion of the administrative and documentation requirements for Contract Closeout following certification of Substantial Completion."

PART 12.0 (Re: 9.3 APPLICATIONS FOR PAYMENT) - ADD NEW SUBPARAGRAPHS 9.3.1.3 and 9.3.1.4

"9.3.1.3 Retainage: Unless good cause exists, the Owner shall not withhold retainage from any payments due and owing a contractor.

9.3.1.4 Upon completion and acceptance of each separate building, public work, or other division of the contract, on which the price is stated separately in the contract, payment may be made without retention of a percentage."

PART 13.0 (Re: 9.5 DECISIONS TO WITHHOLD CERTIFICATION) - ADD THE FOLLOWING ITEMS TO SUB-SUBPARAGRAPH 9.5.1:

".8 failure to provide an approved progress schedule.

.9 the contract sum has been reduced by change order, and the payment request exceeds the revised Contract Sum."

PART 14.0 (Re: 9.5 DECISIONS TO WITHHOLD CERTIFICATION) - ADD THE FOLLOWING SUBPARAGRAPH 9.5.4:

"9.5.4 The Owner may refuse to make payment of the full amount recommended by the Architect/Engineer in order to protect itself from loss because of Subparagraphs 9.5.1.1 through 9.5.1.8, but the Owner must give the Contractor immediate written notice, with a copy to the Architect/Engineer, stating the reasons for such action."

PART 15.0 (Re: PAYMENTS AND COMPLETION) - ADD THE FOLLOWING PARAGRAPH 9.11:

"9.11 LIQUIDATED DAMAGES

9.11.1 The Contractor and the Contractor's surety shall be jointly and severally liable for and shall pay the Owner the sums hereinafter stipulated in the Contract as liquidated damages for each calendar day of delay until the work is substantially complete. Liquidated damages set forth in the Agreement will be assessed from the Contractor's scheduled completion date."

PART 16.0 (Re: 10.3 HAZARDOUS MATERIALS) - DELETE IN ITS ENTIRETY. Article IX, Section 12 and the similar constitutional debt restrictions for the state and other local governments (N.M. Const. art. IX, §§ 8, 11-13) have been judicially interpreted to preclude a government from entering into an agreement subjecting it to contingent liability, the amount of which is uncertain at the time of the agreement.

PART 17.0 (Re: ARTICLE 11 INSURANCE AND BONDS) - SUBSTITUTE THE FOLLOWING FOR SUBPARAGRAPH 11.1.1:

1. 11.1.1 The contractor shall purchase and maintain, in a company or companies licensed to do business in the State in which the project is located, such insurance as will protect him, the Owner and the Architect from claims set forth below which may arise out of, or result from, the Contractors' operations under the contract, whether such operation be by himself, or by any Sub-contractor, or by anyone for whose acts any of them may be liable. (Subparagraphs .1 through .8 shall remain unchanged.)

2. 11.1.1.9 Liability insurance shall include all major divisions of coverage and be on a comprehensive basis including:

- a) Premises operations.
- b) Independent contractor's protective.
- c) Products and completed operations.
- d) Contractual – Including specified provisions for the Contractor's obligations under paragraph 4.18.
- e) Owned, non-owned, and hired vehicles.
- f) Broad form coverage for property damage.
- g) Personal injury.

3. For the duration of the contract and until all work specified in the contract is completed, the Contractor shall maintain in effect all insurance as required below and comply with all limits, terms, and conditions stipulated therein. Any claims made coverages shall be maintained for two years after the substantial completion.

- a) Work under this contract shall not commence until evidence of all required insurance and bonding is provided to the Owner and the Architect.
- b) All insurance shall be written to conform to the requirements below.
- c) Evidence of such insurance shall consist of a completed certificate of insurance, signed by the insurance agent for the Contractor and returned to the Owner.

4. Certificate of Insurance:

- a) All required insurance is in effect.
- b) The Owner is an additional insured on the Contractor's general liability policy with respect to activities under this contract. The additional insured endorsement shall be ISO form CG 20 10 11 85 or a substitute endorsement providing equivalent coverage.
- c) The general liability insurance afforded applies separately to each insured against whom claim is made or suit is brought except with respect to the limits of the company's liability.
- d) The general liability insurance of the Contractor shall be primary insurance and any insurance or self-insurance of the Owner shall be excess and not contributory insurance.
- e) If for any reason, any material change occurs in the coverage during the course of the contract, such change will not become effective until 30 days after the Owner has received written notice of such change.

5. Contractor shall obtain insurance of the types described below from an insurer with an A.M. Bests rating of not less than A-VIII and authorized to do business in the State of New Mexico.

- a) Commercial General Liability insurance shall be written on ISO occurrence form CG 00 01 or similar and shall cover liability arising from products and completed operations, premises, contractual liability, personal injury, and advertising injury. There shall be no endorsement or modification of the Commercial General Liability insurance limiting coverage for claims arising from explosion, collapse, or underground exposures.
- b) Workers' Compensation Insurance as required by the State.
- c) Automobile Liability Insurance covering all owned, non-owned, hired and leased vehicles. Coverage shall be written on ISO form CA 00 01 or a substitute form providing equivalent liability coverage.
- d) Property Insurance: Not required.

PART 18.0 (Re: ARTICLE 11 INSURANCE AND BONDS) - SUBSTITUTE THE FOLLOWING FOR SUBPARAGRAPH 11.1.2:

A. The limits of liability for the insurance required by Subparagraph 11.1.1 shall provide coverage for not less than the following amounts or greater if required by law:

1. Commercial General Liability insurance shall be written with limits no less than \$1,000,000 each occurrence, a \$2,000,000 general aggregate and a \$2,000,000 products-completed operations aggregate limit.
2. Workers' Compensation Insurance with limits as required by Statute.

3. Automobile Liability Insurance with a combined single limit for bodily injury and property damage of not less than \$1,000,000 per accident.

4. Commercial general liability and automobile liability insurance shall include as additional named insured: The Owner, the Architect, The Architect's consultants and engineers, and each of their officers, employees and agents, and any other persons with an insurable interest designated by the Owner as an additional named insured.

B. Subcontractors:

1. The Contractor shall:

a. Include all subcontractors as insureds under its policies, or
b. Shall furnish separate certificates and endorsements for each subcontractor to the Owner. The Subcontractors' Commercial General Liability insurance shall be written with limits no less than \$1,000,000 each occurrence, a \$2,000,000 general aggregate and a \$1,000,000 products-completed operations aggregate limit.

C. Contractor's Insurance for Other Losses:

1. The Contractor shall assume full responsibility for all loss or damage from any cause whatsoever to any tools, Contractor's employee-owned tools, machinery, equipment, or motor vehicles owned or rented by the Contractor, or the Contractor's agents, suppliers or contractors, as well as to any temporary structures, scaffolding, and protective fences.

PART 19.0 (Re: ARTICLE 11 INSURANCE AND BONDS) - ADD THE FOLLOWING TO SUBPARAGRAPH 11.1.3:

"11.1.3 Furnish one (1) copy of Certificates herein required for each copy of the Agreement, specifically setting forth evidence of all coverage required by subparagraph 11.1.2.

11.1.3.1 Should any of the above described policies be cancelled before the expiration date thereof, the issuing company will mail 30 days written notice to the certificate holder named to the left, but failure to mail such notice shall impose no obligation or liability of any kind upon the company, its agents or representatives."

PART 20.0 (Re: ARTICLE 11 INSURANCE AND BONDS) - ADD THE FOLLOWING SUBPARAGRAPH 11.1.4:

"11.1.4 The Contractor shall have the Owner named as an additional insured on the Comprehensive General Liability form or Commercial Liability form furnished by the Contractor. The certificate of insurance shall state that the coverage provided under the policy is primary over any other valid and collectible insurance."

PART 21.0 (Re: ARTICLE 11 INSURANCE AND BONDS) - MODIFY PARAGRAPH 11.4 IN THE FOLLOWING MANNER:

11.4.1 The General Contractor shall purchase Builder's Risk Insurance per Section 11.4.

11.4.1.2 The General Contractor shall purchase Builder's Risk Insurance.

11.4.1.3 The Contractor is responsible for Builder's Risk deductible.

11.4.2 Delete

PART 22.0 (Re: 11.4.3 LOSS OF USE INSURANCE) - DELETE THE LAST SENTENCE OF SUBPARAGRAPH 11.4.3.

PART 23.0 (Re: 11.5 PERFORMANCE BOND AND PAYMENT BOND) - SUBSTITUTE THE FOLLOWING FOR SUBPARAGRAPHS 11.5.1 and 11.5.2 and add 11.5.3 and 11.5.4:

"11.5.1 The Contractor shall post a one hundred percent (100%) Performance Bond and a one hundred percent (100%) Labor and Material Payment Bond, forms attached hereto with amount payable conforming to the terms of the Contract. Surety shall be a company licensed to do business in the State of New Mexico and executed by such sureties as are named in the current list of Companies Holding Certificates of Authority as Acceptable Sureties on Federal Bonds as published in federal circular 570 by the Audit Staff Bureau of Accounts, U.S. Treasury Department.

11.5.2 Special attention is called to the requirements of §13-4-18 through §13-4-20, NMSA 1978, regarding a Contractor who does not have his principal place of business in the State of New Mexico for all taxes due arising out of construction services rendered under the Contract.

11.5.3 The right to sue on this Bond accrues only to the Owner and the parties to whom §13-4-18 through §13-4-20, NMSA 1978, grant such right; and any such right shall be exercised only in accordance with the provisions and limitations of said statutes.

11.5.4 Subcontractor Bonding Requirements

11.5.4.1 It is the responsibility of each subcontractor submitting a bid to a contractor to be prepared to submit a faithful performance and payment bond if the subcontract exceeds \$50,000.

11.5.4.2 In the event any subcontractor is submitting a bid to a contractor does not, upon the request of the contractor and at the expense of the contractor at the established charge or premium therefore, furnish to the contractor a bond issued by a corporate surety authorized to do business in New Mexico in accordance with the New Mexico Insurance Code (59A-1-1 to 591-A-18, NMSA 1978) and listed in the United States Treasury Department circular 570 where in the contractor is named the obligee, guaranteeing prompt and faithful performance of the subcontract and the payment of all claims for labor and materials furnished or used in and about the work to be done and performed under the subcontract, the contractor may reject the bid and make a substitution of another subcontractor subject to the provisions of Section 13-4-36, NMSA 1978. Such bond may be required at the expense of the subcontractor only if the contractor has in his written or published request for subcontract bids:

- .1 Specifies that the expense for the bond shall be borne by the subcontractor; and
- .2 Clearly specifies the amount and requirements of the bond."

PART 24.0 (Re: 13.5 TESTS AND INSPECTIONS) - ADD THE FOLLOWING SUB-SUBPARAGRAPH TO SUBPARAGRAPH 13.5.1:

"13.5.1.1 All sampling, transportation, and storage of samples; testing; and reporting shall be undertaken by representatives of the testing laboratory. No sampling, transportation, and storage of samples; testing; or reporting shall be undertaken by the Architect/Engineer, the Owner, or the Subcontractors."

PART 25.0 (Re: 13.5 TESTS AND INSPECTIONS) - SUBSTITUTE THE FOLLOWING SUBPARAGRAPH 13.5.4:

"13.5.4 Two copies of all test reports shall be furnished directly to the Owner, the Architect/Engineer, and the Contractor by the testing laboratory. All test reports shall be sequentially numbered and labeled in accordance with industry standards."

PART 26.0 DELETE PARAGRAPH 13.6 IN ITS ENTIRETY.

PART 27.0 (Re: TERMINATION OR SUSPENSION OF THE CONTRACT) - ADD THE FOLLOWING TO ARTICLE 14:

"14.4.4 The terms of this Contract are contingent upon sufficient appropriations and authorization being made by the governing body for the performance of this Contract. If sufficient appropriations are not made by the governing

body, this Contract shall terminate upon written notice being given by the County to the Contractor. The County's determination as to whether sufficient appropriations are available shall be accepted by the Contractor and shall be final."

PART 28.0 (Re: ARTICLE 15 CLAIMS AND DISPUTES) - SUBSTITUTE THE FOLLOWING FOR THE FIRST SENTENCE OF SUBPARAGRAPH 15.1.2:

"15.1.2 NOTICE OF CLAIMS

All claims, disputes, and other matters in question between the Owner and the Contractor shall be referred to the Architect/Engineer for formal decision pursuant to the relevant paragraphs and clauses of ARTICLE 15 CLAIMS AND DISPUTES."

PART 29.0 (Re: PARAGRAPH 15.3 MEDIATION AND PARAGRAPH 15.4 ARBITRATION) - SUBSTITUTE THE FOLLOWING FOR PARAGRAPH 15, INCLUSIVE OF ALL SUBPARAGRAPHS AND FOR PARAGRAPH 15.4, INCLUSIVE OF ALL SUBPARAGRAPHS:

"15.3 AGGRIEVEMENT PROCEDURE DURING CONTRACT ADMINISTRATION

15.3.1 Any claim, dispute, or other matter in question between the Contractor and the Owner, except those relating to artistic effect as provided in Subparagraph 4.2.13 and except those which have been waived by the making or acceptance of final payment as provided in Subparagraph 9.10.4, shall be presented in the form of a written request accompanied by supporting data to the Architect/Engineer for formal decision, with a copy to the other party. Such formal decision of the Architect/Engineer is binding upon the Contractor and the Owner unless either or both parties notify each other and the Architect/Engineer in writing within fifteen days of their receipt of the decision that they are unwilling to abide by the Architect/Engineer's decision, and are thereby aggrieved in connection with the decision and are separately exercising such rights as either may have under the Contract Documents or by law and regulation. If the Architect/Engineer fails to provide a written decision or a reasonable schedule to issue a written decision or a reasonable schedule to issue a written decision with ten days after the Owner or the Contractor has presented his request, that party may consider himself aggrieved and may proceed to exercise his rights.

15.3.2 A settlement agreement signed by the Owner and the Contractor shall supersede and cancel any other dispute resolution proceedings regarding the same matter.

15.3.3 Mediation and arbitration of controversies and claims. Should the procedures for dispute resolution stated in Subparagraph 15.3.1 fail to adequately resolve the claim, dispute or other matter in question, any such claim, dispute or matter in question shall be resolved by binding arbitration governed by the provisions of this Paragraph 15.3.3 and the New Mexico Uniform Arbitration Act. Before submitting a dispute to arbitration the parties shall make a good faith effort to resolve the dispute through formal mediation or other agreed upon alternative dispute resolution technique. The arbitration shall be before a single arbitrator chosen by mutual agreement of the parties. If they cannot agree, then a list of seven potential arbitrators will be obtained from the New Mexico Association of Counties and the parties shall utilize a striking process until an arbitrator is agreed upon. In the event this Contract results in dispute, mediation, arbitration litigation, or settlement, the prevailing party of such action shall NOT be entitled to an award of attorneys' fees and costs.

15.3.4 Unless work is stopped or payment withheld in accordance with the conditions of the Contract, or unless otherwise agreed in writing, the Contractor shall carry on the Work and maintain its progress during any grievement proceedings, and the Owner shall continue to make payments to the Contractor in accordance with the Contract Documents."

◆ ADDITIONAL CONDITIONS ◆

PART 1.0 EQUAL OPPORTUNITY

1.1 The Contractor, all Subcontractors, and all Sub-subcontractors shall not discriminate against any employee or applicant for employment because of race, religion, color, sex, or national origin. The Contractor shall take affirmative action to ensure that applicants are employed and that employees are treated during employment without regard to their race, religion, color, sex, or national origin. Such action shall include, but not be limited to, the following: employment, recruitment or recruitment advertising, upgrading, layoff or termination, demotion, rates of pay or other forms of compensation, transfer, selection for training (including apprenticeship)

1.2 The Contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices setting forth the policies of nondiscrimination.

1.3 The Contractor, all Subcontractors, and all Sub-subcontractors shall, in all solicitation or advertisement for employees placed by them or on their behalf, state that all qualified applicants will receive consideration for employment without regard to race, religion, color, sex, or national origin.

PART 2.0 MINIMUM WAGE RATES

2.1 The Contractor warrants and agrees that he will comply and will require all Subcontractors and Sub-subcontractors to comply with all applicable provisions of the New Mexico Public Works Minimum Wage Act as outlined in the Contract Documents. Wage rates are not applicable to projects costing less than \$20,000. The Contractor and his Subcontractors shall deliver by mail copies of certified weekly payroll in accordance with the regulations under "Minimum Wage Rates" to the office of the State Labor Commission, Santa Fe, New Mexico 87503, address as stated in the Determination and to the Owner.

PART 3.0 CONTRACT AUDIT

3.1 The Owner shall be entitled to audit the books and records of a Contractor or any Subcontractor under any negotiated contract or subcontract other than a firm fixed-price contract to the extent that such books and records relate to the performance of such contract or subcontract. Such books and records shall be maintained by the Contractor for a period of three years from the date of final payment under the prime Contract and by the Subcontractor for a period of three years from the date of final payment under the subcontract, unless a shorter period is otherwise authorized in writing (§13-1-16 NMSA 1978).

PART 4.0 DEBARRED OR SUSPENDED CONTRACTORS

4.1 A business (Contractor, Subcontractor, or Supplier) that has either been debarred or suspended pursuant to the requirements of Sections 13-1-177 through 13-1-180, and 13-4-11 through 13-4-17 NMSA 1978, shall not be permitted to do business with the State and shall not be considered for award of contract during the period for which it is debarred or suspended.

PART 5.0 BRIBES, GRATUITIES, AND KICKBACKS

5.1 It is illegal in the State of New Mexico for any public employee to solicit or accept anything of value in connection with award of contract for this Bid and for any person to offer or pay anything of value to any such public employee (§ 30-24-1 and 30-24-2 NMSA 1978).

5.2 Pursuant to Section 13-1-191 NMSA 1978, reference is hereby made to the Criminal Laws of New Mexico

(including §§ 30-24-1, 30-24-2, and 30-41-1 through 30-41-3 NMSA 1978), which prohibit bribes, kickbacks, and gratuities, and violation of which constitutes a felony. Further, the Procurement Code (§§ 13-1-28 through 13-1-199 NMSA 1978) imposes civil and criminal penalties for its violation.

PART 6.0 NONRESIDENT CONTRACTOR'S REQUIREMENTS: GROSS RECEIPTS TAX SURETY BOND

6.1 Section 7-1-55A NMSA 1978 provides that any person (as defined in § 7-1-3 NMSA 1978) engaged in the construction business who does not have his principal place of business in this state and enters into a prime construction contract to be performed in this State shall, at the time such contract is entered into, furnish the Director of the Revenue Division, Taxation and Revenue Department, or his delegate with a surety bond or other acceptable security in a sum equivalent to the gross receipts tax to be paid under the contract multiplied by the applicable rate of the gross receipts tax imposed by Section 7-9-4 NMSA 1978 to secure payment of the tax imposed on the gross receipts from the Contract. The person shall obtain a certificate from the Director of the Revenue Division, Taxation and Revenue Department, or his delegate that the requirements of this paragraph have been met.

6.2 If the total sum to be paid under the Contract is changed by ten percent (10%) or more after the date the surety bond or other acceptable security is furnished to the Director or his delegate, such person shall increase or decrease, as the case may be, the amount of the bond or security within 14 days after the change (§ 7-1-55B NMSA 1978).

6.3 In addition to the above requirements, the Contractor will be subject to all the requirements of Section 7-1-55 NMSA 1978.

PART 7.0 CONTRACTOR'S GROSS RECEIPTS TAX REGISTRATION

7.1 Section 7-10-4 NMSA 1978 provides that any person (as defined in § 7-10-3 NMSA 1978) performing services for the State, as those terms are used in the Gross Receipts and Compensating Tax Act (§§ 7-10-1 through 7-10-5 NMSA 1978), must be registered and be issued an identification number with the Revenue Division of the Taxation and Revenue Department to pay the gross receipts tax.

7.2 The identification number is needed to properly complete the approval process of the Contract; therefore, so as to cause no delay in the processing, the Contractor must register with the Division. For information, contact: Revenue Division, Taxation and Revenue Department, Manuel Lujan Sr., Building, 1200 St. Francis Drive, Santa Fe, New Mexico 87503, Telephone: (505) 988-2290.

7.3 If any person who performs services for the State is not registered to pay the gross receipt tax, the State shall withhold payment of the amount due until the person has presented evidence of registration with the Revenue Division to pay the gross receipts tax.

PART 8.0 ASSIGNMENT OF ANTITRUST CLAIMS

8.1 The Contractor agrees that any and all claims that the Contractor may have or that may inure to the Contractor for overcharges resulting from antitrust violations as to goods, services, and materials purchased in connection with this Bid are hereby assigned to the State of New Mexico, but only to the extent that such overcharges are passed on to the State. The Contractor further agrees to require each of its Suppliers, Subcontractors, and Sub-subcontractors to assign any and all such claims for overcharges to the State by executing an assignment on the form provided by the Owner for such purpose. The executed form (see Section 00600) shall be submitted prior to the commencement of the Work or the supplying of any materials by the Supplier, Subcontractor, or Sub-subcontractor. The submission of this executed form may be waived by the Owner upon a showing of a good-faith effort by the Contractor to obtain agreement in writing from his Supplier, Subcontractor, or Sub-subcontractor. Waiver by the Owner may not unreasonably be denied.

8.2 It is agreed that the Contractor retains all rights to any such antitrust claims to the extent of any overcharges

not passed on to the State, including the right to any treble damages attributable thereto.

PART 9.0 CONTRACTS WITH NONRESIDENT PERSONS OR PARTNERSHIPS OR UNADMITTED FOREIGN CORPORATIONS; AGENT FOR SERVICE OF PROCESS

9.1 Special attention of Bidders is called to requirements of Sections 13-4-21 through 13-4-24 NMSA 1978, whereby a public works contract with a nonresident person or partnership or foreign corporation not authorized to do business in the State shall contain a specific provision designating an agent resident within the State, and his address, upon whom process and writs in any action or proceeding against such business may be served in any action arising out of such contract.

PART 10.0 ADDENDA AND MODIFICATIONS

10.1 All Addenda and Modifications issued in writing during the Bidding period will become part of the Contract Documents.

THIS AGREEMENT is made and entered into by and between the County of Sierra, hereinafter referred to as the "County" and CONTRACTOR, Inc., hereinafter referred to as the "DESIGN BUILD TEAM", and is effective as of the date set forth below upon which it is executed by the Board of County Commissioners.

WHEREAS, the County issued a Request for Proposals (RFP) to provide Design Build Construction Management Services under RFP No.2020-07-011 and

WHEREAS, the DESIGN BUILD TEAM submitted its original proposal and was selected under RFP No.2020-07011 and

WHEREAS, the County desires to engage the DESIGN BUILD TEAM to render certain Construction Management services, as needed, and the DESIGN BUILD TEAM is willing to provide such services and to enter into this Master Professional Construction Management Services Agreement; and

WHEREAS, this Master Agreement including all Exhibits and any subsequently awarded Task Orders for Professional Services form the Contract Documents and are all as fully a part of the Contract as if attached to this Agreement; and

WHEREAS, the DESIGN BUILD TEAM was selected to provide and perform such Construction Management Services as provided for within this Agreement; and

NOW, THEREFORE, in consideration of the premises and mutual obligations herein, the parties hereto do mutually agree as follows:

costs including construction costs, consulting fees, permit fees, testing and inspection fees, equipment, inflation and contingencies.

3. **Develop a Project Delivery Strategy:** The DESIGN BUILD TEAM, in consultation with Sierra County and the Project Team, will analyze project requirements and develop a pre-construction and construction strategy that addresses requirements for funding compliance, function, cost, quality, time and logistics.

4. **Develop a Project Master Schedule:** The DESIGN BUILD TEAM, in consultation with Sierra County and the Project Team, will develop a Project Master Schedule that establishes duration and responsibility for all major activities during all phases of the project.

5. **Monitor the Project Master Schedule:** The DESIGN BUILD TEAM will monitor and report on progress during the pre-construction phase. The DESIGN BUILD TEAM will update the Project Master Schedule monthly, will notify Sierra County and the Project Team of any delays or problems, and will recommend any corrective action necessary to meet the schedule.

6. **Perform Value Construction Management Studies:** The DESIGN BUILD TEAM will perform a minimum of two (2) Value Construction Management Studies: one (1) at the beginning of schematic design to evaluate systems, and one (1) at the completion of the design phase to evaluate details and finishes. A report will be generated for each study including recommendations on the selection of systems, details and finishes. The final selections shall be made in consultation with Sierra County and the Project Team, prior to the preparation of final construction documents.

7. **Perform Cost Estimating:** The DESIGN BUILD TEAM will prepare a minimum of three (3) detailed cost estimates for all construction site development work. One (1) estimate will be provided at the completion of schematic design, one (1) at the completion of the design phase, and one (1) at the completion of construction documents. The final estimate shall conform to the final bid package configuration.

8. **Perform Constructability Reviews:** The DESIGN BUILD TEAM will review design documents, as they are developed in order to avoid potential problems and to minimize potential change orders. The DESIGN BUILD TEAM will provide recommendations on contract provisions that establish contractor performance requirements to promote quality cost effectiveness and schedule compliance.

9. **Provide Monthly Reports:** The DESIGN BUILD TEAM will prepare and distribute monthly reports to Sierra County and the Project Team on the project budget, the status of the project schedule, and on general project information.

10. **Conduct Design Coordination Meetings:** The DESIGN BUILD TEAM will conduct design coordination meetings on a regular basis (minimum of two per month) with Sierra County, the Project Team, and other consultants to discuss and review all items pertinent to the design phase. The DESIGN BUILD TEAM will prepare and distribute minutes of the meetings in a timely manner.

C. Bidding Phase

1. **Develop Informal Bid Packages:** The DESIGN BUILD TEAM will develop informal bid packages to establish the categories of work into separate contracts that promote competition and provide well-defined and manageable divisions of work.

2. **Develop Construction Schedule:** The DESIGN BUILD TEAM will develop a construction schedule that meets the needs of Sierra County for inclusion in the contract documents.

3. **Develop Contractor and Supplier Interest:** The DESIGN BUILD TEAM will solicit quotes from each of the four contractors that have been pre-qualified by the County Sierra County to perform the required construction services for each project identified to insure a fair and competitive bidding environment. The DESIGN BUILD TEAM will investigate each of the pre-qualified contractors to determine their ability to meet project requirements.

4. **Establish Informal Bidding Procedures:** The DESIGN BUILD TEAM in conjunction with the Project Team will establish and implement procedures for the informal bidding process including the distribution of quote/bid documents, the issuance of addenda, the holding of pre-bid conferences, the receipt of quotes/bids, and the bidding schedule.

5. **Distribute Quote/Bid Documents:** The DESIGN BUILD TEAM will distribute all informal bid documents to contractors and maintain accurate records of distribution activities.

6. **Conduct Pre-Bid Conferences:** The DESIGN BUILD TEAM, in consultation with Sierra County and the Project Team, will schedule, organize, and conduct pre-bid conferences in a manner consistent with the bid schedule.

7. **Receive and Evaluate Bids:** The DESIGN BUILD TEAM, in consultation with Sierra County and the Project Team, will receive and evaluate the bids and recommend the award of contracts.

8. **Prepare Construction Contracts:** The DESIGN BUILD TEAM, in consultation with Sierra County and the Project Team, will prepare and coordinate the processing of all construction documents.

D. Construction Phase Conduct Pre-Construction Conferences

For each project to be managed under this RFP, the successful DESIGN BUILD TEAM(s) shall function as an independent contractor. Construction services may include, but are not limited to the following:

1. **Open Book Policy:** The CM will maintain total financial and transaction transparency. All financial records shall be subject to random independent third party audits.
2. **The DESIGN BUILD TEAM** will hold and administer all subcontracts and shall be responsible for all project administration including but not limited to; scheduling the work, verifying and approval of all required shop drawings and submittals, ordering and ensuring timely delivery of all required materials, enforcement of all OSHA safety regulations and approval of all material invoices and subcontractor pay requests. The DESIGN BUILD TEAM will handle all bonding for sub-contracts and materials.
3. **Labor and Materials Payment Bonds:** The DESIGN BUILD TEAM shall be required to provide a Labor and Material Payment Bond and a Performance Bond, both in the form of AIA Document A311, for each project when required by New Mexico State Statutes and/or Sierra County. Each bond shall be issued in an amount equal to 100% of the cost/expense associated with each construction project. The Bonding Company (Surety) must be listed on the Federal Register, licensed to do business in the State of New Mexico, and a minimum A.M. Best rating of A11.
4. **Wage Rate Determinations:** The DESIGN BUILD TEAM shall be responsible for attaining and posting all applicable Wage Rate determinations for each of the construction projects to be managed under this solicitation.
5. **General and Liability Insurance:** The DESIGN BUILD TEAM shall be required to obtain proof of insurance coverage from all contractors prior to the assignment and authorization of work to be performed by each contractor.
6. **Builders Risk Insurance:** The DESIGN BUILD TEAM shall be required to obtain and provide proof of Builder's Risk Insurance from each contractor for each project assigned and authorized by the CM.
7. **Construction Contingency:** The DESIGN BUILD TEAM shall report to Sierra County all construction contingency allocations and shall update and submit to the County a log of contingency allocations no less than once a month.
8. **Pre-Construction Meetings:** The DESIGN BUILD TEAM, in consultation with the Project Team, will organize and conduct pre-construction meetings with contractors, consultants,

and Sierra County. The meetings shall include a review of project management, project schedule, and project procedures.

9. **Maintain On-Site Staff:** The DESIGN BUILD TEAM will provide and maintain a qualified, on-site field staff sufficient to manage the project, conform to the scope of services, and insure that the work is performed in compliance with the contract documents.

10. **Process Shop Drawings:** The DESIGN BUILD TEAM, in consultation with the Project Team, will establish and implement procedures for processing and approving shop drawings, product data, samples, and other submittals from the contractors and will coordinate the processing and approval of all submittals with the Project Team. The DESIGN BUILD TEAM will establish and maintain a submittal log to insure contractor compliance with the contract documents.

11. **Project Coordination:** The DESIGN BUILD TEAM will be responsible for managing the site and coordinating all construction activities. The DESIGN BUILD TEAM will provide administration, management, and related services necessary to coordinate the construction activities of the contractors with each other and with those of the DESIGN BUILD TEAM, the Project Team, and Sierra County.

12. **Develop Detailed Construction Schedule:** Prior to commencing construction, the DESIGN BUILD TEAM shall be required to submit an overall project schedule to Sierra County for its' prior review and approval. The schedule shall include start and finish dates for procurement and construction activities and major milestones for each segment of the work and shall provide adequate detail to establish an acceptable and realistic construction sequence to achieve the required completion for each project. The schedule shall be updated and submitted to Sierra County, Sierra County, no less than once a month upon construction commencement.

13. **Monitor Construction Progress:** The DESIGN BUILD TEAM will review contractor's construction schedules, observe construction progress, and report deviations from the schedule that might delay project completion. The DESIGN BUILD TEAM will consult with contractors to develop and implement corrective actions necessary to meet the project schedule.

14. **Control Construction Quality:** The DESIGN BUILD TEAM will monitor and inspect all work in progress to insure the quality of the work and compliance with the contract documents. The DESIGN BUILD TEAM will document and report all deficiencies and make recommendations for corrective actions.

15. **Maintains Construction Records:** The DESIGN BUILD TEAM will maintain current and orderly records of all construction documents including contracts, drawings, specifications, submittals, samples, schedules, correspondence, meeting minutes, catalog data, directives, change orders, etc.

16. **Process Applications for Payment:** The DESIGN BUILD TEAM, in accordance with the Project Team, will develop and implement a procedure for the review and processing of contractor payment applications. The DESIGN BUILD TEAM will evaluate the contractor's schedule of values to insure accurate and appropriate payments in contractors.

17. **Maintain Construction Accounting System:** The DESIGN BUILD TEAM will establish and maintain an accurate and up-to-date construction cost accounting system.

18. **Conduct Project Meetings:** The DESIGN BUILD TEAM, in consultation with Sierra County and the Project Team, will conduct bi-monthly meetings at the job site to discuss job progress, resolve problems, and make decisions. The DESIGN BUILD TEAM will prepare and distribute accurate meeting minutes in a timely manner.

19. **Conduct Construction Superintendent Meetings:** The DESIGN BUILD TEAM will conduct bi-monthly meetings at the job site with the construction superintendents to coordinate construction activities and discuss project progress. The DESIGN BUILD TEAM will prepare and distribute accurate meeting minutes in a timely manner.

20. **Prepare and Maintain Field Reports:** The DESIGN BUILD TEAM will prepare and maintain daily job site reports including weather conditions, number of workers, equipment in use, contractor activities, general activities, and special occurrences.

21. **Process Change Orders:** The DESIGN BUILD TEAM, in consultation with Sierra County and the Project Team, will develop and implement a system for review and processing of change orders. The DESIGN BUILD TEAM will estimate the cost of all change orders, insure the validity of change orders, and negotiate the cost of change orders with the contractors on behalf of Sierra County.

22. **Coordinate Inspections and Testing:** The DESIGN BUILD TEAM will determine the requirements and make recommendations for inspections and testing. The DESIGN BUILD TEAM, in consultation with Sierra County and the Project Team, will coordinate the selection of independent inspection and testing agencies, review inspection and testing reports, and make recommendations regarding the results of inspections and testing activities.

23. **Recommend Construction Changes:** The DESIGN BUILD TEAM will evaluate work in progress and make recommendations for changes in the work on the basis of field conditions, improved quality, cost savings, or time savings.

24. **Maintain Photographic Records:** The DESIGN BUILD TEAM will coordinate and maintain photographic and/or videotape records of construction activities and project progress on a regular basis.

25. **Provide Monthly Reports:** The DESIGN BUILD TEAM will prepare and distribute a monthly report to Sierra County and the Project Team including information on schedule, budget, quality, safety, logistics, and general project information.

26. **Monitor Contractors' Safety Programs:** The DESIGN BUILD TEAM will review and monitor the safety program developed by each contractor, record any safety violations, and make recommendations for improving safety conditions.

E. Close-Out Phase

1. **Develop Close-Out Program:** The DESIGN BUILD TEAM, in consultation with Sierra County and the Project Team, will develop a detailed program of close-out activities in compliance with the contract documents. The program will include a close-out schedule, inspections, testing, start-up procedures, warranty processing, and occupancy.

2. **Coordinate Inspection and Testing:** The DESIGN BUILD TEAM will schedule and coordinate any and all required testing and inspections.

3. **Process Warranties:** The DESIGN BUILD TEAM will collect, log, review, and submit to Owner all warranty documentation.

4. **Coordinate Substantial and Final Inspections:** The DESIGN BUILD TEAM, in consultation with the Project Team, will schedule and coordinate substantial completion and final inspections. The DESIGN BUILD TEAM will assist the Project Team in the preparation of a list of deficiencies (punch list) and will coordinate all correction action by contractors.

5. **Coordinate Construction Close-Out:** The DESIGN BUILD TEAM will coordinate close-out activities including the completion of deficiencies, submittal of close-out documents, resolution of change orders, and recommendations for payment of retainage.

6. **Submit Project Documentation:** The DESIGN BUILD TEAM will submit all project documentation including files, records, drawings, submittals, samples, and other information to Sierra County in an organized and usable form.

7. **Coordinate Warranty Work:** The DESIGN BUILD TEAM will coordinate the warranty work by contractors to insure that their obligations are fulfilled in a timely manner.

8. **Certificates:** The DESIGN BUILD TEAM, upon completion of the project, will be responsible for certifying that, to the best of his professional knowledge, the building conforms to the approved plans, specifications, and shop drawings.

2. Compensation.

A. The County agrees to pay the DESIGN BUILD TEAM in full payment for the services and work contemplated under the terms of this Agreement and satisfactorily performed under the individual Task Orders to be negotiated based on FEMA allowable reimbursement percentages. In no event will the DESIGN BUILD TEAM be paid any amount in excess of the specified total amount payable in the individual task order without the task order being amended in writing.

B. New Mexico Gross Receipts Tax will be billed as a separate added amount at the time of each pay request at the percentage applicable at the time of billing.

C. Reimbursable services of the DESIGN BUILD TEAM will include the following items when approved in writing by the Owner: Cost of reproduction of drawings and specifications required for bidding. Payment of reimbursable expenses to the DESIGN BUILD TEAM will be paid by the Owner at the direct cost to the DESIGN BUILD TEAM. All requests for reimbursable expenses will be accompanied by copies of original invoices.

D. Payment is subject to availability of funds pursuant to the Appropriations Paragraph set forth below and to any negotiations between the parties from year to year pursuant to Article 1, Scope of Work.

E. DESIGN BUILD TEAM must submit a detailed statement accounting for all services performed, as specified in the individual task order. If the County finds that the services are not acceptable, within thirty days after the date of receipt of written notice from the DESIGN BUILD TEAM that payment is requested, it shall provide the DESIGN BUILD TEAM a letter of exception explaining the defect or objection to the services, and outlining steps the DESIGN BUILD TEAM may take to provide remedial action. The County will continue to pay DESIGN BUILD TEAM for any undisputed amounts pursuant to Article 2(A). Upon certification by the County that the services have been received and accepted, payment shall be tendered to the DESIGN BUILD TEAM within thirty days after the date of acceptance. If payment is made by mail, the payment shall be deemed tendered on the date it is postmarked.

F. The payment of taxes due for any money received under this Agreement shall be the DESIGN BUILD TEAM's sole responsibility and shall be reported under the DESIGN BUILD TEAM's Federal and State tax identification number(s).

3. Term.

This Agreement is for one (1) year from the date of approval by the Sierra County Board of County Commissioners. This Contract will automatically renew on an annual basis, for up to three (3) additional one (1) year terms unless terminated pursuant to Article 4 (Termination for Convenience), Article 5 (Termination for Cause), or Article 6 (Appropriations). In accordance with Section 13-1-150 NMSA 1978, no term for a professional services contract, including extensions and renewals, shall exceed four years, except as set forth in Section 13-1-150 NMSA 1978.

4. Termination For Convenience.

A. Termination. This Agreement may be terminated by either of the parties hereto upon written notice delivered to the other party at least thirty (30) days prior to the intended date of termination. Except as otherwise allowed or provided under this Agreement, the County's sole liability upon such termination shall be to pay for acceptable work ordered and performed prior to the DESIGN BUILD TEAM's receipt of the notice of termination, if the County is the terminating party, or the DESIGN BUILD TEAM's sending of the notice of termination, if the DESIGN BUILD TEAM is the terminating party; provided, however, that a notice of termination shall not nullify or otherwise affect either party's liability for pre-termination defaults under or breaches of this Agreement. The DESIGN BUILD TEAM shall submit an invoice for such work within thirty (30) days of receiving or sending the notice of termination. Notwithstanding the foregoing, this Agreement may be terminated immediately upon written notice to the DESIGN BUILD TEAM if the DESIGN BUILD TEAM becomes unable to perform the services contracted for, as determined by the County or if, during the term of this Agreement, the DESIGN BUILD TEAM or any of its officers, employees or agents is indicted for fraud, embezzlement or other crime due to misuse of government funds or due to the Appropriations paragraph herein.

THIS PROVISION IS NOT EXCLUSIVE AND DOES NOT WAIVE THE COUNTY'S OTHER LEGAL RIGHTS AND REMEDIES CAUSED BY THE DESIGN BUILD TEAM'S DEFAULT/BREACH OF THIS AGREEMENT.

B Termination Management. Immediately upon receipt by either the County or the DESIGN BUILD TEAM of notice of termination of this Agreement, the DESIGN BUILD TEAM shall: 1) not incur any further obligations for salaries, services or any other expenditure of funds under this Agreement without written approval of the County; 2) comply with all directives issued by the County in the notice of termination as to the performance of work under this Agreement; and 3) take such action as the County shall direct for the protection, preservation, retention or transfer of all property titled to the County and records generated under this Agreement. Any non-expendable personal property or equipment provided to or purchased by the DESIGN BUILD TEAM with contract funds shall become property of the County upon termination and shall be submitted to the County as soon as practicable.

5. Termination For Cause.

A. County may by written notice terminate this Agreement in whole or in part for DESIGN BUILD TEAM's default if the DESIGN BUILD TEAM fails to comply with the provisions of this Agreement or fails to make progress so as to endanger performance and does not cure such failure within a reasonable period of time. In such event, County may otherwise secure the materials, supplies or services ordered, and DESIGN BUILD TEAM shall be liable for damages suffered by County thereby, including incidental and consequential damages. If after notice of termination, County determines DESIGN BUILD TEAM was not in default, or if

DESIGN BUILD TEAM's default is due to failure of County, termination shall be deemed for the convenience of County. The rights and remedies of County provided in this paragraph shall not be exclusive and are in addition to any other rights and remedies provided by law or under this Agreement as used in this paragraph, the word "DESIGN BUILD TEAM" includes DESIGN BUILD TEAM's sub-suppliers at any tier.

B. In the event a termination for cause notice is issued by the County, the DESIGN BUILD TEAM shall: 1) not incur any further obligations for salaries, services or any other expenditure of funds under this Agreement without written approval of the County; 2) comply with all directives issued by the County in the notice of termination as to the performance of work under this Agreement; and 3) take such action as the County shall direct for the protection, preservation, retention or transfer of all property titled to the County and records generated under this Agreement. Any non-expendable personal property or equipment provided to or purchased by the DESIGN BUILD TEAM with contract funds shall become property of the County upon termination and shall be submitted to the County as soon as practicable.

6. Appropriations.

The terms of this Agreement are contingent upon sufficient appropriations and authorization being made by the Board of County Commissioners for the performance of each task order assigned under this Agreement. If sufficient appropriations and authorization are not made by the Board of County Commissioners, this Agreement shall terminate immediately upon written notice being given by the County to the DESIGN BUILD TEAM. The County's decision as to whether sufficient appropriations are available shall be accepted by the DESIGN BUILD TEAM and shall be final. If the County proposes an amendment to the Agreement to unilaterally reduce funding, the DESIGN BUILD TEAM shall have the option to terminate the Agreement or to agree to the reduced funding, within thirty (30) days of receipt of the proposed amendment.

7. Status of DESIGN BUILD TEAM.

The DESIGN BUILD TEAM and its agents and employees are independent DESIGN BUILD TEAMS performing professional services for the County and are not employees of the County of Sierra. The DESIGN BUILD TEAM and its agents and employees shall not accrue leave, retirement, insurance, bonding, use of county vehicles, or any other benefits afforded to employees of the County of Sierra as a result of this Agreement. The DESIGN BUILD TEAM acknowledges that all sums received hereunder are reportable by the DESIGN BUILD TEAM for tax purposes, including without limitation, self-employment and business income tax. The DESIGN BUILD TEAM agrees not to purport to bind the County of Sierra unless the DESIGN BUILD TEAM has express written authority to do so, and then only within the strict limits of that authority.

8. Assignment.

The DESIGN BUILD TEAM shall not assign or transfer any interest in this Agreement or assign any claims for money due or to become due under this Agreement without the prior written approval of the County.

9. **Subcontracting.**

The DESIGN BUILD TEAM shall not subcontract any portion of the services to be performed under this Agreement without the prior written approval of the County. Subcontractors listed in an approved task order constitute approval of the County. No such subcontract shall relieve the DESIGN BUILD TEAM from its obligations and liabilities under this Agreement, nor shall any subcontract obligate direct payment from the County. In all cases, the DESIGN BUILD TEAM is solely responsible for fulfillment of this Agreement.

10. **Release.**

Final payment of the amounts due under each task order issued under this Agreement shall operate as a release of the procuring agency of the County, its officers and employees, and the County of Sierra from all liabilities, claims and obligations whatsoever arising from or under this Agreement.

11. **Confidentiality.**

Any confidential information provided to or developed by the DESIGN BUILD TEAM in the performance of this Agreement shall be kept confidential and shall not be made available to any individual or organization by the DESIGN BUILD TEAM without the prior written approval of the County.

12. **Product of Service -- Copyright.**

All materials developed or acquired by the DESIGN BUILD TEAM under this Agreement shall become the property of the County of Sierra and shall be delivered to the County no later than the termination date of this Agreement. Nothing developed or produced, in whole or in part, by the DESIGN BUILD TEAM under this Agreement shall be the subject of an application for copyright or other claim of ownership by or on behalf of the DESIGN BUILD TEAM.

13. **Conflict of Interest; Governmental Conduct Act.**

A. The DESIGN BUILD TEAM represents and warrants that it presently has no interest and, during the term of this Agreement, shall not acquire any interest, direct or indirect, which would conflict in any manner or degree with the performance or services required under the Agreement.

B. The DESIGN BUILD TEAM further represents and warrants that it has complied with, and, during the term of this Agreement, will continue to comply with, and that this Agreement complies with all applicable provisions of the Governmental Conduct Act, Chapter 10, Article 16 NMSA 1978. Without in anyway limiting the generality of the foregoing, the DESIGN BUILD TEAM specifically represents and warrants that:

1) in accordance with Section 10-16-4.3 NMSA 1978, the DESIGN BUILD TEAM does not employ, has not employed, and will not employ during the term of this Agreement any County employee while such employee was or is employed by the County and participating directly or indirectly in the County's contracting process;

2) this Agreement complies with Section 10-16-7(B) NMSA 1978 because (i) the DESIGN BUILD TEAM is not a public officer or employee of the County; (ii) the DESIGN BUILD TEAM is not a member of the family of a public officer or employee of the County; (iii) the DESIGN BUILD TEAM is not a business in which a public officer or employee or the family of a public officer or employee has a substantial interest; or (iv) if the DESIGN BUILD TEAM is a public officer or employee of the County, a member of the family of a public officer or employee of the County, or a business in which a public officer or employee of the County or the family of a public officer or employee of the County has a substantial interest, public notice was given as required by Section 10-16-7(B) NMSA 1978 and this Agreement was awarded pursuant to a competitive process;

3) in accordance with Section 10-16-8(C) NMSA 1978, (i) the DESIGN BUILD TEAM is not, and has not been represented by, a person who has been a public officer or employee of the County within the preceding year and whose official act directly resulted in this Agreement and (ii) the DESIGN BUILD TEAM is not, and has not been assisted in any way regarding this transaction by, a former public officer or employee of the County whose official act, while in County employment, directly resulted in the County's making this Agreement;

4) in accordance with Section 10-16-13 NMSA 1978, the DESIGN BUILD TEAM has not directly participated in the preparation of specifications, qualifications or evaluation criteria for this Agreement or any procurement related to this Agreement; and

5) in accordance with Section 10-16-3 and Section 10-16-13.3 NMSA 1978, the DESIGN BUILD TEAM has not contributed, and during the term of this Agreement shall not contribute, anything of value to a public officer or employee of the County.

C. DESIGN BUILD TEAM's representations and warranties in Paragraphs A and B of this Article 13 are material representations of fact upon which the County relied when this Agreement was entered into by the parties. DESIGN BUILD TEAM shall provide immediate written notice to the County if, at any time during the term of this Agreement, DESIGN BUILD TEAM learns that DESIGN BUILD TEAM's representations and warranties in Paragraphs A and B of this Article 13 were erroneous on the effective date of this Agreement or have become erroneous by reason of new or changed circumstances. If it is later determined that DESIGN BUILD TEAM's representations and warranties in Paragraphs A and B of this Article 13 were erroneous on the effective date of this Agreement or have become erroneous by reason of new or changed circumstances, in addition to other remedies available to the County and notwithstanding anything in the Agreement to the contrary, the County may immediately terminate the Agreement.

D. All terms defined in the Governmental Conduct Act have the same meaning in this Article 13(B).

14. Amendment.

This Agreement shall not be altered, changed or amended except by instrument in writing executed by the parties hereto and all other required signatories. Executed task orders are amendments to this agreement.

15. Merger.

This Agreement incorporates all the Agreements, covenants and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, Agreements and understandings have been merged into this written Agreement. No prior Agreement or understanding, oral or otherwise, of the parties or their agents shall be valid or enforceable unless embodied in this Agreement.

16. Penalties for Violation of Law.

The Procurement Code, Sections 13-1-28 through 13-1-199, NMSA 1978, imposes civil and criminal penalties for its violation. In addition, the New Mexico criminal statutes impose felony penalties for illegal bribes, gratuities and kickbacks.

17. Equal Opportunity Compliance.

The DESIGN BUILD TEAM agrees to abide by all federal, state and county laws and rules and regulations, pertaining to equal employment opportunity. In accordance with all such laws, the DESIGN BUILD TEAM assures that no person in the United States shall, on the grounds of race, religion, color, national origin, ancestry, sex, age, physical or mental handicap, or serious medical condition, spousal affiliation, sexual orientation or gender identity, be excluded from employment with or participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity performed under this Agreement. If DESIGN BUILD TEAM is found not to be in compliance with these requirements during the life of this Agreement, DESIGN BUILD TEAM agrees to take appropriate steps to correct these deficiencies.

18. Applicable Law.

In any action, suit or legal dispute arising from this Agreement, the DESIGN BUILD TEAM agrees that the laws of the State of New Mexico shall govern and that venue will lie in the Seventh Judicial District Court in Sierra County. By execution of this Agreement, DESIGN BUILD TEAM acknowledges and agrees to the jurisdiction of the courts of the State of New Mexico over any and all lawsuits arising under or out of any term of this Agreement.

19. Workers Compensation.

The DESIGN BUILD TEAM agrees to comply with state laws and rules applicable to workers compensation benefits for its employees. If the DESIGN BUILD TEAM fails to comply with the Workers Compensation Act and applicable rules when required to do so, this Agreement may be terminated by the County.

20. Records and Financial Audit.

The DESIGN BUILD TEAM shall maintain detailed time and expenditure records that indicate the date, time, nature and cost of services rendered during the Agreement's term and effect and retain them for a period of three (3) years from the date of final payment under this Agreement. The records shall be subject to inspection by the County, the County's auditor, the New Mexico Department of Finance and Administration and the New Mexico State Auditor. The

County shall have the right to audit billings both before and after payment. Payment under this Agreement shall not foreclose the right of the County to recover excessive or illegal payments

21. Disclaimer and Hold Harmless.

Sierra County shall not be liable to the DESIGN BUILD TEAM, or the DESIGN BUILD TEAM's successors, heirs, administrators, or assigns, for any loss, damage, or injury, whether to DESIGN BUILD TEAM's person or property, occurring in connection with DESIGN BUILD TEAM's performance of DESIGN BUILD TEAM's duties according to this Agreement. DESIGN BUILD TEAM shall hold Sierra County harmless from all loss, damage, and injury, including court costs and attorney fees, incurred by Sierra County in connection with the performance by DESIGN BUILD TEAM of DESIGN BUILD TEAM's duties according to this Agreement.

22. Indemnification.

The DESIGN BUILD TEAM shall defend, indemnify and hold harmless the County of Sierra from all actions, proceeding, claims, demands, costs, damages, attorneys' fees and all other liabilities and expenses of any kind from any source which may arise out of the performance of this Agreement, caused by the negligent act or failure to act of the DESIGN BUILD TEAM, its officers, employees, servants, subcontractors or agents, or if caused by the actions of any client of the DESIGN BUILD TEAM resulting in injury or damage to persons or property during the time when the DESIGN BUILD TEAM or any officer, agent, employee, servant or subcontractor thereof has or is performing services pursuant to this Agreement. In the event that any action, suit or proceeding related to the services performed by the DESIGN BUILD TEAM or any officer, agent, employee, servant or subcontractor under this Agreement is brought against the DESIGN BUILD TEAM, the DESIGN BUILD TEAM shall, as soon as practicable but no later than two (2) days after it receives notice thereof, notify the legal counsel of the County of Sierra and the New Mexico Association of Counties by certified mail.

23. Invalid Term or Condition.

If any term or condition of this Agreement shall be held invalid or unenforceable, the remainder of this Agreement shall not be affected and shall be valid and enforceable.

24. Enforcement of Agreement.

A party's failure to require strict performance of any provision of this Agreement shall not waive or diminish that party's right thereafter to demand strict compliance with that or any other provision. No waiver by a party of any of its rights under this Agreement shall be effective unless expressed in writing, and no effective waiver by a party of any of its rights shall be effective to waive any other rights.

25. Authority.

If DESIGN BUILD TEAM is other than a natural person, the individual(s) signing this Agreement on behalf of DESIGN BUILD TEAM represents and warrants that he or she has the power and authority to bind DESIGN BUILD TEAM, and that no further action, resolution, or approval from DESIGN BUILD TEAM is necessary to enter into a binding contract.

26. Lobbying.

No federal appropriated funds can be paid or will be paid, by or on behalf of the DESIGN BUILD TEAM, or any person for influencing or attempting to influence an officer or employee of any County, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with the awarding of any Federal contract, or the making of any Federal grant, the making of any federal loan, the entering into of any cooperative agreement, or modification of any Federal contract, grant, loan, or cooperative agreement. If any funds other than federal appropriated funds have been paid or will be paid to any person influencing or attempting to influence an officer or employee of any County, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection of this federal contract, grant, loan, or cooperative agreement, the DESIGN BUILD TEAM shall complete and submit Standard Form LLL, "Disclosure Form to Report Lobbying," in accordance with its instructions.

27. Approval of DESIGN BUILD TEAM Personnel.

Personnel proposed in the DESIGN BUILD TEAM's written proposal to the County are considered material to any work performed under this Agreement. No changes of personnel will be made by the DESIGN BUILD TEAM without prior written consent of the procuring agency of the County. Replacement of any DESIGN BUILD TEAM personnel, if approved, shall be with personnel of equal ability, experience and qualifications. The DESIGN BUILD TEAM will be responsible for any expenses incurred in familiarizing the replacement personnel to insure their being productive to the project immediately upon receiving assignments. Approval of replacement personnel shall not be unreasonably withheld. The procuring agency of the County shall retain the right to request the removal of any of the DESIGN BUILD TEAM's personnel at any time.

28. Survival.

The agreement Articles titled "Patent, Copyright, Trademark, and Trade Secret Indemnification" and "Indemnification" shall survive the expiration of this agreement. Software licenses, leases, maintenance and any other unexpired agreements that were entered into under the terms and conditions of this agreement shall survive this agreement.

29. Succession.

This agreement shall extend to and be binding upon the successors and assigns of the parties.

30. Force Majeure.

A party shall be excused from performance under this agreement for any period that the party is prevented from performing as a result of an act of God, strike, war, civil disturbance, epidemic, or court order, provided that the party has prudently and promptly acted to take any and all steps that are within the party's control to ensure performance. Subject to this provision, such non-performance shall not be deemed a default or a ground for termination.

31. Mediation.

In the event a dispute arises as to the rights and obligations among the parties hereto, the parties agree to attempt to resolve the dispute through mediation as a condition precedent to seeking legal and equitable remedies. The parties agree to evenly split the costs of any such mediation services. The parties shall mutually agree upon the choice of mediator. In the event the parties have not agreed upon a mediator within twenty (20) days of written notice to the other regarding the dispute, then a list of seven potential mediators will be obtained from the New Mexico Association of Counties and the parties shall utilize a striking process until a mediator is agreed upon.

32. Notice to Proceed.

It is expressly understood that this Agreement is not binding upon the County until it is executed by the Board of County Commissioners after voting on the contract at a public meeting. The DESIGN BUILD TEAM is not to proceed with its obligations under the Agreement until the DESIGN BUILD TEAM has received a fully signed copy of the Agreement. Further, each individual task order must be fully executed prior to proceeding with any work.

33. Attorney's Fees.

In the event this Agreement results in dispute, mediation, litigation, or settlement between the parties to this Agreement, the prevailing party of such action shall NOT be entitled to an award of attorneys' fees and court costs.

34. Cooperation.

All parties hereto will fully cooperate with the other and their respective counsel, accountant, and agents in connection with any steps required to be taken under this Agreement.

35. Incorporation and Order of Precedence.

Request for Proposals #RFP 2015-11001 and the DESIGN BUILD TEAM's proposal are incorporated by reference into this agreement and are made a part of this agreement. In the event of any conflict among these documents, the following order of precedence shall apply:

1. Any contract amendment(s), in reverse chronological order; then
2. this contract itself; then
3. the Request for Proposals; then
4. the executed task orders with the scope of work, timeframe for completion, and compensation, in reverse chronological order; then
5. the DESIGN BUILD TEAM's proposal.

36. Patent, Copyright, Trademark and Trade Secret Indemnification.

A. The DESIGN BUILD TEAM shall defend, at its own expense, the County of Sierra against any claim that any product or service provided under this agreement infringes any patent,

copyright or trademark in the United States or Puerto Rico, and shall pay all costs, damages and attorneys' fees that a court finally awards as a result of any such claim. In addition, if any third party obtains a judgment against the County of Sierra based upon the DESIGN BUILD TEAM's trade secret infringement relating to any product or service provided under this agreement, the DESIGN BUILD TEAM agrees to reimburse the County of Sierra for all costs, attorneys' fees and the amount of the judgment. To qualify for such defense and/or payment, the County of Sierra shall:

- i. give the DESIGN BUILD TEAM prompt written notice of any claim;
- ii. allow the DESIGN BUILD TEAM to control the defense or settlement of the claim; and
- iii. cooperate with the DESIGN BUILD TEAM in a reasonable way to facilitate the defense or settlement of the claim.

B. If any product or service becomes, or in the DESIGN BUILD TEAM's opinion is likely to become the subject of a claim of infringement, the DESIGN BUILD TEAM shall at its option and expense:

- i. provide a procuring agency of the County the right to continue using the product or service;
- ii. replace or modify the product or service so that it becomes non-infringing; or
- iii. accept the return of the product or service and refund an amount equal to the depreciated value of the returned product or service, less the unpaid portion of the purchase price and any other amounts, which are due to the DESIGN BUILD TEAM. The DESIGN BUILD TEAM's obligation will be void as to any product or service modified by the procuring agency of the County to the extent such modification is the cause of the claim.

37. Professional Liability Insurance.

DESIGN BUILD TEAM agrees to maintain in full force throughout the duration of the Agreement a liability insurance policy with a minimum coverage of : Comprehensive General Liability - \$1,000,000 per occurrence, \$2,000,000 General Aggregate; Professional liability- \$1,000,000 per occurrence, \$2,000,000 General Aggregate. Occurrence type, if available; if not "Claims Made" type with a minimum of a six (6) year tail. The County will be named as an additional insured on said policy, and will be provided an updated certificate of insurance on an annual basis.

38. Compliance With Laws

In providing the scope of services outlined herein, the DESIGN BUILD TEAM and the County shall comply with all applicable laws, ordinances, and codes of the Federal, State, and local governments.

39. Construction and Severability

If any part of this Agreement is held to be invalid or unenforceable, such holding will not affect the validity or enforceability of any other part of this Agreement so long as the remainder of the Agreement is reasonably capable of completion.

The Contractor shall furnish to the Owner copies of limits. The Certificate of Insurance shall be in the form of AIA Document G-705 or similar format acceptable to the Owner. Such certificates shall be filed with the Owner and shall also contain the following statements:

“Sierra County Commissioners, Sierra County its agents, servants and employee are held as additional insured.”

“The insurance coverage certified herein shall not be canceled or materially changed except after forty five (45) days written notice has been provided to the owner.”

COMPENSATION INSURANCE:

The Contractor shall procure and shall maintain during the life of this contract Worker’s Compensation as required by applicable State law for all Contractor’s employees to be engaged at the site of the project under this project and in case of any such work sublet the Contractor shall require the subcontractor or sub subcontractor similarly to provide Worker’s Compensation Insurance for all the subcontractor’s or sub subcontractor’s Workers which are covered under the Contractor’s Worker’s Compensation Insurance. Partnering

The assignment will include a written or/and oral scope of work and anticipate time frame for completion. The work shall have engineered drawings to meet the needs of the construction services. Sierra County desires a cooperative process, the selected Design Build Team that will facilitate close coordination of work throughout all phases of the project. The Design Build Team will define roles and responsibilities, establish line of communication, and confirm project requirements. All work will be paid base on the Contractor's fixed price quote. All possible occurrences should be taken into consideration when providing the cost for services.

Generally, the work is renovating an existing building for the following: Administration, consists of the County Commission Chambers, office spaces for the following: County Manager, Chief Procurement Officer, Human Resources, Finance Director, Accounts Payable, Indigent, GIS, Emergency Services and Flood Commission. The elected official's office spaces will include the Assessors, Treasures, Clerks and Probate Judge. The District Attorney will require office space in addition to DWI and 911 Dispatching.

Code Requirements

The Design Build Team is responsible for compliance with all applicable codes and agency requirements. The project is to conform to code requirements enforced by the State of New Mexico and local jurisdictions.

Roles and Responsibilities

3. The Design Build Team must be composed of experienced and highly regarded professionals who have demonstrated their ability to procure superior facilities in a cost-effective basis.

The Design Build Team shall review shop drawings, detail drawings, schedules, descriptive literature and samples, testing laboratory reports, field test data and review the color, texture and suitability of materials for conformity with the design concept and construction documents. The Design Build Team shall recommend approval, disapproval, or other suitable disposition. The Design Build Team shall evaluate the submittals with reference to any companion submittals that constitute a system.

Site Visits and Inspections

During the Design Build Period the Project Manager and or CPO shall make visits to the project site. Should other County Staff or Elected Officials come to the sight making suggestions or changes they are to be referred back to the Project Manager and CPO. None of their recommendations are to be added or omitted. Site visits shall be made as when requested by the Contracting Lead or authorized representative. Such visits shall be made weekly, during intermediates systems, air-conditioning inspections, for partial and final inspection and for special purposes, as a visit to the site by one person per any part of the day.

Only registered architects and engineers thoroughly familiar with the project may make these site visits. The Contracting Lead has the prerogative to determine the professional discipline (s) required for each visit. The Design Build Team shall observe the construction, advise the Resident Engineer of any deviations or deficiencies. A site inspection report which includes the purpose of the inspection, items reviewed, deficiencies observed, recommendations and additional actions required, shall be furnished to the Contracting Lead, Project Manager and CPO within three working day following the site visit.

Transportation

The Contractor's bid shall include any and all delivery costs for equipment delivered to the awarded project. Includes any and all heavy machinery and supplies.

Wage Rates

The following wage rates apply for projects awarded resulting from this RFP. Labor Rates to be paid to all laborers shall include the wage and fringe benefits of the applicable wage rate decisions. **(SEE EXHIBIT F- WAGE RATES)** *New Mexico Local Public Works Exhibit F* (Projects equal to or greater than \$60,000) are subject to the requirements of 13-4-13.1

Equipment

It is anticipated that not all equipment quoted will be new current year models. All equipment shall be in good operating condition, with all safety devices intact and fully functional. All equipment shall be up to code and insured.

Personnel

Contractor shall employ only competent, trained professional heavy equipment operators capable of working in a safe manner. Contractor shall be responsible for adequate supervision and communicate the work directly to his respective employees. The County will not directly supervise the contractor's employees. Contractor records shall be available for review by the County daily.




