SCOPE OF WORK

To provide Uniforms and Accessories for purchase to Franklin County as outlined below.

SPECIFIC REQUIREMENTS

1. The vendor shall provide law enforcement uniforms; clothing (trousers and shirts), hats, ties and accessories, as specified herein which meets or exceeds the specifications contained in this document.
2. In addition to law enforcement clothing, associated services (e.g., making some alterations, sewing patches and chevrons on clothing, etc.) shall be provided on an as needed/ if needed basis if requested by the County.
For the alterations the Vendor will have one of the following:
 - Location not beyond a 60mile radius
 - A Rep to come on site
 - A third party location not beyond a 60mile radius
3. All products and services shall be provided by the vendor in accordance with specifications presented herein for the purpose of serving the needs of Franklin County.
4. The Vendor shall provide/conduct clothing measurements of officers on-site at no additional charge to the County upon the County's request with no minimum limit restrictions on employees measured.
5. Measurements to include, but not limited to new hire employees at the time of hire.
6. All products shall be in current production and easily accessible to the vendor in order to ensure the County adequate service.
7. The County will specify at the time of order items and quantities.
8. Quality Assurance and Control; the contractor shall have adequate internal control mechanisms for monitoring compliance with specifications contained herein. The contractor shall ensure accuracy and consistency in production, color, size, and packaging of products sold to the County under the contract. Items not meeting specifications shall not be accepted by the County.
9. Prices are ALL INCLUSIVE: (Shipping, Handling, and Delivery).
10. Uniforms are for both men and women, brands and colors may vary.
11. Vendor to provide samples of clothing at the Vendor's cost.
12. Vendor must complete the included price sheet.
13. Vendor shall notify customer if items are on backorder and keep in contact regularly with customer with updated order status.
14. Vendor shall be able to accept orders via email or phone and a purchase order is required.
15. The vendor shall notify the customer contact when orders are ready either by phone call or by email. (Contact info will be provided upon awarding of Bid.)
16. No substitutions shall be allowed unless approved by the County.

17. Method of delivery shall be determined at the time of order and will not exceed Franklin County Boundaries.

**Contract period one year, from date of award, with two, one year optional renewals, subject to annual appropriation. Price increase for renewal years not to exceed 5%.*
