Additional Work/Product Specifications

- 1. Carpet tile and glue will be provided.
- 2. Respondent will provide vehicles and labor to pick up carpet tile and glue from our warehouse at 201 E.Tyler Street, Dalton, GA 30721 and deliver to job site at New Hope Elementary School, 1175 New Hope Road, Dalton, GA 30720.
- 3. New Hope Elementary does NOT have a loading dock.
- 4. Respondent will provide labor to remove existing approximately 3,500 sq. yds. of broadloom carpet from rooms and dispose of according to all local, state and federal regulations.
- 5. Furniture in rooms must be removed before installation and then replaced after installation.
- 6. New carpet tile is to be installed under existing cove base. Do NOT remove base from wall.
- 7. Install carpet tile according to industry standard methods.
- 8. Clean up to allow for area usage after completion.
- Work is to be performed during Spring break March 30-April 3, evenings after 4:00pm and weekends. Work must be scheduled around school functions. Get prior approval from Beau Martin.
- 10. Job must be completed and invoiced before June 30, 2020.
