8. Are there any chemicals that you need more storage of, or want to change to (i.e. switch chlorine gas for bleach)? Are there any challenges with chemical deliveries?

Answer:

Hooper WPP - Currently the Hooper plant has an active project for chemical storage tank replacement. CCWA does not anticipate any changes for this location.

Hicks WPP – CCWA wants to have a minimum of 45 days of storage for Sodium Hypo and Alum (or main coagulant). In addition, due to the increase in flow and usage, CCWA wants to replace its tote system with new bulk storage facilities.
