The City of Waycross (OWNER) will receive sealed bids for all material, labor and equipment necessary for the construction of *FY 17 Multimodal Safety & Access Project – SR 520 Sidewalk Extension* at the OWNER's address listed above until *9:00 AM* prevailing local time on Thursday April 12, 2018 at which time and place bids will be opened and read. All interested parties are invited to attend. Proposals may be mailed or delivered to the attention of Jessica King Deal, City Engineer at the OWNER's address. Proposals received after the designated date and time will not be considered. No bid may be withdrawn after the closing time for receipt of bids for a period of sixty (60) days. Detailed instructions for the preparation and submission of a bid may be found in the Specification Section 00200 - Instructions to Bidders. The City of Waycross may select a successful low bidder after evaluation of all bids.

The work of this contract consists of **Sidewalk Extensions** along both sides of SR 520 (Corridor Z) from **Garlington Avenue to George Street/Victory Drive** in the City of Waycross. More specifically the work includes, but is not limited to, *mobilization/demobilization, demolition of conflicting curbs and other obstructions, approximately 4,700 LF of 5' wide by 4" thick concrete sidewalk, HC curb ramps, pedestrian crossings, median crossings, approximately 25 LF 18" RCP culvert, concrete flared end sections, traffic control, necessary utility relocations, erosion control and grassing, complete surface restoration, and all other work and appurtenances required.* 

All work must be completed within **90** consecutive calendar days from receipt of written Notice to Proceed.

to be considered certified. Bids from non-certified bidders will not be considered. Contract documents may be examined at the Waycross City Hall – Office of the City Engineer.

Bids must be accompanied by a bid bond or certified cashier's check in an amount not less than 5% of the base bid. Performance and Payment Bonds, each in an amount equal to 100% of the contract amount, shall be required of the successful bidder, if contract is awarded. All bonds shall be by a surety licensed in the State of Georgia with an "A" minimum rating of performance and a financial strength of at least five (5) times the contract price. Each bond shall be accompanied by a "Power of Attorney" authorizing the attorney-in-fact to bind the surety and certified to include the date of the bond. The bid bond shall be forfeited to the City of Waycross as liquidated damages if successful bidder fails to execute a Contract and provide Performance and Payment bonds within ten (10) days after being notified of contract award.

Bidders are encouraged to examine the site of the work and to inform themselves fully as to the conditions present at the site. A **pre-bid conference** will be held at the Waycross City Hall on **March 29, 2018** at 9:00 A.M. Attendance is **not mandatory**, however all Bidders are encouraged to attend.
