A. PROJECT MANUAL

B. RESPONSES TO CONTRACTOR QUESTIONS

The questions received via email are addressed as follows (responses are in **bold/italics**):

1. Instruction to Bidders Article 3.01 indicates qualifications statements are required. Is there a format or list of specific data that should be included?

Disregard Section 3.01 of the Instruction to Bidders. Please reference Section 15.01 for documents required for bid submittal. The pink sheets which include your bid, bid security bond, list of subcontractors, and NMDOT forms are required.

2. The lighting control cabinet indicates on sheet 9-2 that the cabinet is unmetered, please confirm.

Correct. The existing meter used for the signals will be utilized.

3. Are the contract days working or calendar, it did not specify (just said days)?

The contract days shown in the agreement are calendar days.

4. There is also only a federal wage decision in the documents, not a state, is this project only subject to federal wage rates or will a state of NM wage decision be issued as well?

State wage rates were not issued for this project because the estimate is below the \$60,000 threshold. Please use the federal wage rates only.

5. The contract docs list the below project special provisions but they were not inclusive, will these project specific special provisions be provided?

Please see Section A. Project Manual, Paragraph 1 above. There are no Project Specific Special Provisions for this project.

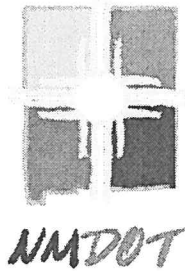
