ADVERTISEMENT FOR BIDS

1. Sealed Bids: Sealed bids for construction of the project entitled **Daniel Street & Brunswick Avenue Improvements** will be received until 2:00 PM, January 10, 2020 at the City Manager's Office, 417 Pendleton Street, Waycross, GA 31501, at which time and place they will be publicly opened and read. No bid may be withdrawn after the closing time for the receipt of bids for a period of sixty (60) days.

2. Work To Be Done: The Work to be completed for the **Daniel Street & Brunswick Avenue Improvements** is described briefly as follows:

This project includes improvements to two separate sites: Daniel Street and Brunswick Ave. The improvements to Daniel Street include, but are not limited to, the replacement of approximately 60 LF of 54" storm drainage culverts and two flared end sections, the construction of approximately 200 LF of curb and gutter, 300 SY of asphalt milling and overlay, erosion control, and other associated construction items. The improvements to Brunswick Ave include, but are not limited to, the construction of approximately 750 SY of asphalt roadside parking, pavement striping, traffic signage, erosion control, traffic control, and other associated construction items.

3. Plans, Specifications and Contract Documents: Copies of Bidding Documents may be obtained from ESG Engineering- contact Margaret Hildebrand at mhildebrand@esgengineering.com to procure Bidding Documents and to be added to the Bidder's List. Digital documents will be provided upon a non-reimbursable payment of \$100 and hard copies will be provided upon non-reimbursable payment of \$200. **Prospective bidders must be on the official plan holders list in order for their bid to be considered responsive.**

4. Contractor License: Any Contractor submitting a bid must be licensed by the State of Georgia. See Instructions to Bidders for additional bidding requirements.

5. Bonds: Bids shall be accompanied by a bid bond or certified cashier's check in an amount not less than 5% of the base bid. All bonds shall be by a surety company licensed in Georgia with an "A" minimum rating of performance and a financial strength of at least five (5) times the contract price as listed in the most current publication of "Best's Key Rating Guide Property Liability". Performance and Payment Bonds, each in an amount equal to 100% of the contract price shall be required of the successful bidder if contract is awarded. Each Bond shall be accompanied by a "Power of Attorney" authorizing the attorney-in-fact to bind the surety and certified to include the date of the bond.

6. No permits required for the construction of this project.

7. No Acquisition of property for easements, right of way, etc. needed.

8. Reservation of Rights: Owner reserves the right to reject any or all Bids, including without limitation, the rights to reject any or all nonconforming, nonresponsive, unbalanced or conditional Bids and to reject the Bid of any Bidder if Owner believes that it would not be in the best interest of the Project to make an award to that Bidder, whether because the Bid is not responsive or the

Bidder is unqualified or of doubtful financial ability or fails to meet any other pertinent standard or criteria established by the Owner.
