The City and Contractor, agree as follows:

- 1) **Scope of Work** (Describe project and list location): Install concrete disc golf tee pads meeting the following specs. 4" concrete with an 18"x18" 3/8" rebar grid on a 12" sand base. Locates must be filed prior to performing any work. The City must be made aware of any work to be performed at least 5 days prior to starting work. Insurance, and a signed contract must also be on file prior to starting any work. The contractor will need to get approval from the city on equipment that will be used, access to the course, and overall project plan.

Insurance Requirements:

- 3) **Insurance.** The Contractor shall not commence work under this contract until he/she has obtained all insurance required under this agreement and such insurance has been approved by the City. Nor shall the Contractor allow any subcontractor to commence work on a subcontract until all similar insurance required of the subcontractor has been so obtained and approved.

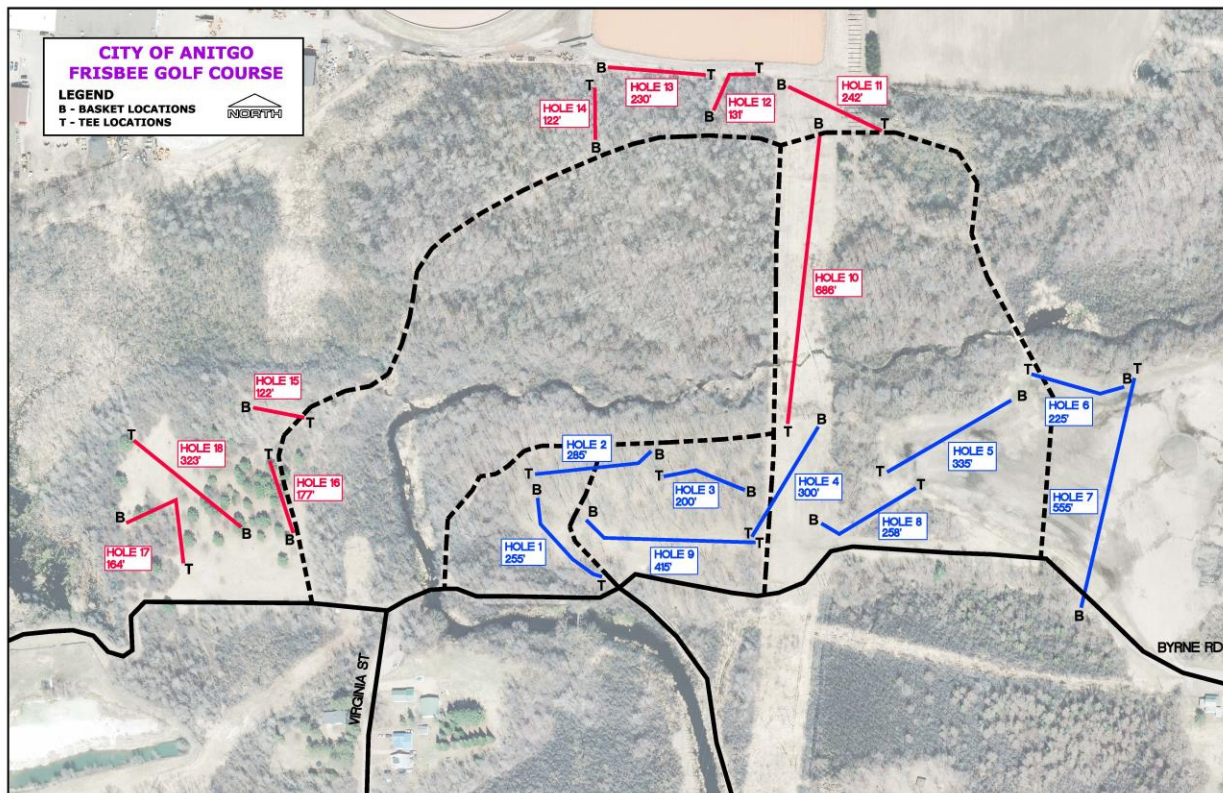
The **City of Antigo** must be named as an **additional insured** with the following format:

Endorsement: A copy of the endorsement must be forwarded to the City Clerk-Treasurer's Office. No insurance shall be canceled without notifying the City in writing thirty (30) days prior to cancellation.

- 4) **Proof of Insurance.** The Contractor shall furnish the City with proof of insurance which shall consist of a certificate of insurance.

- 5) **Performance/Payment Bond.** The City requires a Performance Bond in the amount of the estimated work to be completed for the faithful performance of this contract and for the payment of all persons performing labor and furnishing materials in connection with this contract.
- 6) **Hold Harmless.** Contractor hereby agrees to defend, indemnify, and hold harmless City, its officers, agents, and employees from and against any and all claims, demands, causes of action, suits, and costs in any way connected with Contractor's performance of work related to this contract.
- 7) **Owner's Right.** The City may utilize their employees and equipment to perform any part of the work described in this contract upon proper verbal notification and approved by the contractor.
- 8) **Term.** The term of this contract shall be effective beginning on _____, **2021** and shall continue until **October 1, 2021.**
- 9) **Termination.** The City may also terminate this agreement for any reason.
