The Contractor must furnish all supervision, labor, materials, tools, equipment, and perform all operations required to perform the Emergency Repair of Sanitary Sewer in accordance with the Contract Documents and as described in the Construction Sketches.

Work includes, but is not limited to, the Emergency Repair of Sanitary Sewer as per the bid sketches, including all labor, supervision, material, tools, and equipment.
