GENERAL INFORMATION

This specification is for the purchase of spare pipe and fittings for use at the Moccasin Bend Wastewater Treatment System. The Plant is located at 455 Moccasin Bend Road, Chattanooga, Tennessee 37405.

SPECIFICATIONS GENERAL

All ductile iron pipe shall be Class 250 DI pipe. The pipe shall be push on type joints with locking gaskets. Standard push on gaskets will not be accepted. Pipe and gasket specifications shall be included in all bid packages. Pipe shall be lined internally with a coating resistant to standard sanitary sewer contaminants including hydrogen sulfide corrosion and sulfuric acid corrosion. The material specified will be stored outside under cover, a minimum 3 year warranty shall be provided on the coating when stored in these conditions. Acceptable coatings are Ceramapure PL90 by Induron Protective Coatings, Permox, Tenemec 431 or equal. Coating specifications shall be included in all bid packages.
