SCOPE OF SERVICES:

The Escambia County Correction's Department desires to retain instructors to provide instructions for (GED) General Education Development and (ABE) Adult Basic Education classes for incarcerated inmates at the (MJ) Main Jail Facility and the Work Annex. The Main Jail facility is located at 3080 N Pace Blvd, Pensacola FL 32505 and the Work Annex Facility is located at 601 County Road 297A, Cantonment FL 32533.

All instructors are qualified to render such services and have records to show their experience with instructing incarcerated students. Student inmates will be instructed on an up-to-date GED/ABE computer programs as well as personal instruction from the instructors. Instructors will maintain accurate attendance records, provide proficiency of completion certificates to qualified recipients, and prepare students to test for the GED diploma.

Main Jail Hours:

Class sessions will be held (4) four times per week (Monday – Thursday), (2) two sessions per day from 8:30 am to 11:30 pm and from 12:30 pm to 3:30 pm or as determined by Detention Center Operations. In the Main Jail facility there will be classes held for female and male inmates on alternating days, the 5th day will be for the ABE students. Total class time for both class sessions will not exceed 30 hours per week, to consist of 1 hour of planning time for each class.

Work Annex Hours:

Class session will be held 6 hours per week; 3 hours on Wednesday and Thursday, from 6pm to 9pm for a total of 24 hours a month. Two hours a month will be compensated for teacher planning times. No more than 26 hours (teaching and planning) will be invoiced for GED per month.

JOB DESCRIPTION

The instructor will maintain a classroom environment and facilitates the teaching of Adult Basic Education, English Language Development, and basic subjects required to pass the GED or equivalent examination. The instructor will teach one or more subjects including, but not limited to reading, mathematics, science, social studies and language arts.

PRIMARY DUTIES AND RESPONSIBILITIES

Provide classroom instruction in the areas of basic education subjects including career planning, social adjustment and general life skills information. May instruct conversational English along with ideas and customs in English to students with limited English proficiency. Maintains records including testing, daily inmate/detainee work, and attendance.

The Instructor will be required to provide an invoice on a monthly basis with dates and times of classes as well as how many students

attended each session.

The invoice will also include a unique invoice number, a completed remit to field and billed to field.

The invoice with the above criteria will be turned in within the first five (5) working days of the following month to the Escambia County Jail's Programs Coordinator for the Main Jail Facility and to Commander Snow for the Work Annex for review. Payment will be submitted for all hours worked during the previous month.

TESTING:

Testing will be provided by an online testing service certified by the State of Florida. Test will be administered by a certified testing proctor or through an approved secure website provided by State of Florida.

JOB QUALIFICATIONS

- Bachelor's degree from an accredited college or university
- Two (2) years of relevant teaching experience
- Two (2) year working/teaching in a correctional facility
- Experience and Knowledge working with Aztec Learning System.

FACILITIES AND EQUIPMENT:

It is understood and agreed that the County shall provide essential equipment and supplies for the inmate GED/ABE classes. The supplies will include, but not limited to, the cost of classroom computers to be also used for the computer class, textbooks, class supplies and instructional tools for the instructor's use.
