SCOPE OF WORK: Springfield Electric Department (SED) has identified approximately 250 Three Phase meters that it would like to have field tested for accuracy. All of these meters are Current Transformer meter sites with some having Potential Transformers. The Contractor will need to test and verify all the metering equipment is working properly and record the field manufacturer and model number of the equipment and also take a photograph of this equipment. Once the field check is completed, the Contractor will review the billing information in the SED Customer Information System for accuracy. The Contractor will assist SED in rectifying any irregularities identified in the field check and billing record errors.

TIME PERIOD: SED believes that this project can be completed within 30 days. However, the Contractor should identify their proposed time period. Due to the nature of this work, SED requires all work to be performed during normal work hours Monday through Friday.
