ADDENDUM # 2: June 2, 2022

Unless explicitly noted herein, all requirements will remain as originally prepared. Any variations or claims of equality or superiority must be demonstrated, proven and evaluated to the satisfaction of ABI.

1. **QUESTION:** If an artist is commissioned for the Public Art Exhibition, would they be able to accept funding through their organization or would it only be directed to the artist? For example, if an artist recently established a nonprofit organization (incorporated in GA, obtained IRS EIN etc.), and is in the process of completing and applying for 501c3 status from the IRS, would they be able to receive funding through their nonprofit organization (pending 501c3), instead of directly to themselves (i.e. the artist)?

ANSWER: ABI does not provide advisement to artist or firms in regard to their organization's funding and/or business structure.

2. **QUESTION:** As referenced in the Request for Qualifications (RFQ), what is tombstone information? Can you give examples to show what kind of information is required and in what format? Do you want an image or description?

Answer: A "tombstone" is the artist's name, title of the piece, dimensions, medium, and year. Please review the RFQ for information required. Also, there is a template that can be utilized as well at https://vrapp.vendorregistry.com/Bids/View/Bid/Odb6b3a1-0931-4e97-b832-81d7be267c7a.

3. **QUESTION:** Is the Request for Qualifications (RFQ) document (in whole or in part) to be included in the submission of the Statement of Qualifications (SOQ)?

4. **QUESTION:** Can you elaborate on the community outreach efforts expected of an awarded artist/organization? What is the agenda of community meetings? How many and where are they held?

ANSWER: There is no community outreach requirement listed in the RFQ outside of the residency program. We do not dictate artist's social practice.

ANSWER: Yes. It is the decision of the artist or firm who submits the Statement of Qualifications (SOQ) to determine self, firm, or artist as the authorized representative to sign the cover letter and contract (if awarded).

7. **QUESTION:** I am entering the Mural component. I do not have an online portfolio, but I do have an Instagram dedicated solely to my art. Can I submit that link?

ANSWER: No. Please include in your submission a link to either a slide deck, Canva, Google slides, power point, or website portfolio. You may also submit an attached document portfolio.

8. **QUESTION:** Where do I obtain help to register on the Vendor Registry (VR) platform before I submit to the Art on the Atlanta BeltLine Open Call?
