The City of Springfield is requesting sealed bids for the replacement of the existing golf car fleet at The Legacy Golf Course. The Legacy currently has a fleet of sixty-six (66) 2020 EZ-GO TXT EX1 gasoline powered fleet golf cars on a 48-month municipal lease with a \$2,006/car balloon payment. The City of Springfield will trade that fleet in to the successful bidder who will, in turn, pay off the balloon payment and apply the remaining residual value to the lease of the new fleet. The city intends to structure the procurement of the new golf car fleet with one of the following options:

- 48-month municipal lease with a balloon payment of \$2,000/car (or)
- 60-month municipal lease with a balloon payment of \$2,000/car (or)
- Outright purchase.

The new fleet will consist of sixty-six (66) gas powered golf cars. The city is requesting bids for both lease and purchase options. Desired delivery date of the new fleet is March 1, 2024.

The bid must include the following:

1. Residual value of the existing fleet to be applied to new fleet after the balloon payment has been satisfied.
2. Golf car fleet monthly lease payment based on a 48-month municipal lease with a \$2,000/car balloon payment.
3. Golf car fleet monthly lease payment based on a 60-month municipal lease with a \$2,000/car balloon payment.
4. Golf car fleet purchase price.
5. Complete specs and warranty details for golf cars.
6. Proposed lease agreement.
7. Expected delivery date of the new fleet.
