## **SPECIFIC REQUIREMENTS**

- 1. Contractor must be able to provide Fuel to the requesting departments, which meet or exceed the specifications contained in this document.
- 2. Fuel should be priced per gallon.
- 3. Fuel requested will be in varying quantities.
- 4. The types of requesting fuel are 87 octane gasoline, #2 low sulfur diesel, and #2 low sulfur diesel with winter additive.
- 5. Diesel with winter additive shall contain winter additive at the rate specified by the manufacturer.
- 6. Franklin County has two locations with above ground fuel storage tanks utilizing a quick coupler system.

- 7. Each location has a 1,000 gallons unleaded fuel tank and a 3,000 gallons diesel tank.
- 8. Franklin County additional needs may include an onsite tank and/or fuel tanker on stand-by at various locations within the County.
- 9. The average price published by O.P.I.S. each Thursday shall be in effect for purchases from Monday through Sunday of the following week. If O.P.I.S. does not publish a price for the type of fuel required in the current week, the most recent published price shall prevail. The Vendor shall e-mail this report weekly on Thursdays, no later than to the Purchasing Dept. purchasing@franklinmo.net and the HWY dept. hwydept@franklinmo.net. Sales tax is not to be included.
- 10.Contractor must be able to provide service to all locations/departments necessary. Normal business hours are Monday through Friday 7:00 a.m. 3:30PM (CST). However, these times must be verified with the requesting department. County observed holidays will be provided upon request.
- 11. Franklin County, at its own expense, reserves the right to sample any material for the purpose of having an independent laboratory rest of the material for conformance to specifications as listed above. Product that does not meet the above listed specifications will cause all of the shipment to be returned at the Contractor's expense.
- 12.Contract Period: The contract period shall be for one year January 1, 2022 thru December 31, 2022. This Contract will have the option to renew on a year by year basis, up to three years in total. The County also reserves the right to terminate and/or cancel the contract in writing prior via a formal contract amendment issued by the Purchasing Department.

# **INSURANCE REQUIREMENTS**

- 1. The Contractor shall furnish County with a certificate of insurance indicating proof of the following insurance from company's license in the State of Missouri:
  - A. Worker's Compensation and Employers' Liability: Worker's Compensation Statutory in compliance with the Compensation law of the Sate and Employers' Liability Insurance with a limit no less than \$1,000,000.00 each accident.
  - B. Comprehensive or Commercial General Liability with a minimum limit of \$1,000,000.00 per occurrence, \$3,000,000.00 aggregate combined Single Limit for Bodily Injury and Property Damage Liability. This insurance shall include, but not be limited to, the following coverage.
    - 1. Premises Operations
    - 2. Products and Completed Operations
    - 3. Broad Form Property Damage
    - 4. Contractual
    - 5. Personal Injury
  - C. Automobile Liability with a minimum limit of \$1,000,000.00 per occurrence, \$3,000,000.00 aggregate Combined Single Limit for Bodily Injury and Property Damage Liability. This insurance shall include coverage for all the following:
    - 1. Owned Automobiles
    - 2. Hired Automobiles
    - 3. Non-Owned Automobiles
  - D. The certificate shall list the Certificate Holder and Address as follows: Franklin County, 400 E Locust Street, Room 206, Union, Mo 63084. The services provided to Franklin County shall be listed under "Description of Operations."

- E. Such insurance shall include under the General Liability and Automobile Liability policies Franklin County, its employees, elected officials, representatives, and members of its board and/or commissioners as "Additional Insured's".
- 2. The Agreement of Insurance shall provide for notice to the County of amendment or cancellation of insurance policies 30 days before such amendment or cancellation is to take effect.

# **ADDITIONAL REQUIREMENTS**

#### 1. E-Verify

Completion of Affidavit of Work Authorization and provide acceptable documentation of enrollment in the program.

- 2. Employment of Unauthorized Aliens Prohibited
  - a.) Vendor agrees to comply with Missouri Revised Statute Section 285.530.1 in that it shall not knowingly employ, hire for employment, or continue to employ an unauthorized alien to perform work within the State of Missouri.
  - b.) As a condition for the award of this contract, the Vendor shall, by sown affidavit and provision of documentation, affirm its enrollment and participation in a federal work authorization program with respect to the employees working in connection with the contracted services.
