1. Question: What Learning Management System (LMS) does APS currently use?

Response: Canvas, SeeSaw, Google Classroom are used with no curriculum pre-built

Response: Not Cloud Hosted, will not work on a Chromebook

Response: The number of staff to be trained is variable. The District will be giving schools the

Question: The RFP mentions district-issued devices and lists Chromebooks and iPads. Will students
exclusively use those types of devices, or are laptops assigned for student use as well?
Response: Chromebooks and iPads are what are what APS will issue; however, students may use
their own personal laptops.

Response: No.

24. Question: Does this Call include ELD materials? If so, for which grade levels?

Response: APS is seeking a comprehensive program for either K-12 or primary or secondary levels, with the ability to differentiate coursework.

25. **Question:** If our 9-12 materials have already been recently adopted and K-8 is in the process of been adopted by the NM BOE, do you still want publishers to participate with the same materials for this Call?

Response: APS is seeking a comprehensive program for either K-12 or primary or secondary levels, not single content area titles or programs.

26. **Question**: In response to the disclosure form #13, can we have the list of bonding companies approved by the district? We would need to be able to share that information with our broker in order to assist in facilitating the bonding, should it be needed.

Response: We do not have a list of bonding companies, however you can check with the State of New Mexico to locate a list of bonding companies approved by the State of New Mexico.

27. **Question:** As a privately held corporation, our company's financial information is strictly confidential. However, we will agree to provide this information to APS upon the execution of an applicable non-disclosure agreement (NDA). Are we permitted to 1) send you an NDA now for APS's signature and return prior to the due date so that we can provide these statements in our proposal or 2) should we provide said NDA with our proposal?

Response: Provide NDA with proposal. Please be aware that it is mandatory that APS follow the Freedom of Information Act and may not agree to NDA and statements may be required before award.

28. **Question**: From the Requirements (pages 14-15) – the bullet below appears twice in the list of requirements. Is this a duplicate or should one of the bullets read differently?

"Supports best practices for K-12 hybrid and online blended learning — this includes traditional, flipped, station rotation, and fully online learning"

Response: This is a duplicate.

29. **Question:** Would you please clarify what the District is seeking with regard to the requirement below (bottom of page 14):

"Cascading"

Response: The ability to change the pacing guide upon length of semesters/ trimesters/ summer

30. **Question:** Due to the current pandemic, our office continues to operate remotely, including our authorized signers. Would it be acceptable to have the required bid forms signed electronically via secure DocuSign instead of a wet signature?

Response: Electronic signatures will be accepted.

31. **Question:** The Mandatory Qualifications documentation, specified on page 17 of the RFP, includes either proprietary or confidential information which could affect our commercial position in future competitions. Will the District treat the Financial Statements and contract award documentation, which is required for the Mandatory Qualifications, as proprietary or confidential information and protect this documentation from disclosure to the public?

Response: It is mandatory for APS to follow the Freedom of Information Act.

Response: Please review the Uniform Commercial Code.
