The City of Daytona Beach will receive bids for the “DAYTONA BEACH GOLF CLUB NORTH GREENS RENOVATION REBID”, Invitation to Bid No. 19273, at the City of Daytona Beach Purchasing Division, City Hall Room 146, 301 S. Ridgewood Ave., Daytona Beach, Florida 32114, until **2:00 p.m., on February 4, 2019**, at which time bids will be opened publicly and read aloud. Bids received after said time will be returned unopened.

The work generally consists of converting the Daytona Beach Golf Course; North Course greens to a homogeneous strand of ultra-dwarf Bermuda grass that will provide a year-round quality putting surface. The putting greens on the North Course of Daytona Beach Golf Course are approximately 25 years old with significant off-type Bermuda grass contaminants which compromise the quality and integrity of a playable putting surface. The project will return the greens areas to the originally designed size and configuration. The putting greens, collars, bunkers and green-side irrigation of the North Course of Daytona Beach Golf Course (DBGC) will be renovated, restored and modified.

Each bid must be accompanied by **Bid Security** in an amount not less than 10% of the total bid.

A MANDATORY PRE-PROPOSAL CONFERENCE will be held at the Daytona Beach Golf Club, 600 Wilder Ave., Pro Shop Conference Room, Daytona Beach, Florida 32114, on **January 15, 2019 at 9:00 AM**. Interested contractors are **required** to attend.

The successful contractor will be required to furnish separate 100% Performance and Payment Bonds unless the Contract price is less than \$100,000.

The City reserves the right to reject any and all bids, or any portion of any bid, or to waive any informalities in the bidding.

Bids may be held by the City for a period not to exceed 60 days from the date of opening of bids for the purpose of reviewing the bid and investigating the qualifications of bidders prior to awarding the contract.
