PARKING LOT IMPROVEMENTS - SANITATION AND PUBLIC WORKS

Scaled bids for **Parking Lot Improvements - Sanitation & Public Works - Bid No.: 023-010** will be received by the **City of Prattville** at City Hall, 101 West Main Street, Prattville, AL 36067, until 3:30 pm, Thursday, August 3, 2023, and at that time publicly opened and read aloud at said location.

The bracket estimate on this project is from \$275,000 to \$300,000. This bracket range is shown only to provide general financial information to contractors and bonding companies concerning the project's complexity and size. This bracket should not be used in preparing a bid, nor will this bracket have any bearing on the decision to award the contract. The principal items of work are approximate as follows:

2,600 SY of Parking Lot Grade, Drain, Base, and Pave
1,015 LF of Concrete Curb & Gutter

The entire project shall be completed in 30 working days.

To be eligible for consideration, bids must be submitted on complete original proposals made available by the owner. Bid documents (including plans and proposals) are available through the digital plan room at Alabama Graphics, www.algraphicplanroom.com. Bid documents are on file at Prattville Public Works, 530 Doster Road, Prattville, AL 36067. No bid documents will be distributed later than 24 hours prior to the scheduled opening of bids.

Guarantee will be required with each bid for at least 5% of the amount of the bid filed in the form of a certified check or Bid Bond payable to the City of Prattville. Bid Bonds shall include certification that the bonding company is listed in Circular 570 of the U.S. Treasury Department. Each bidder must submit with his bid, security in the amount, form, and subject to the conditions provided in the Information for Bidders. The successful bidder will be required to submit 100% performance bond and a 50% payment bond.

Each bidder must be licensed as a Contractor in the State of Alabama in accordance with provisions of Chapter 8 of Title 34 of the Code of Alabama, 1975, and must submit with this bid satisfactory evidence of such license.

The City of Prattville is an equal opportunity employer and encourages the participation of women and minority owned businesses (OMBES) and Section 3 qualified contractors in all project contract procurements.

The right to reject any or all proposals or bids and to disregard any minor irregularities is reserved.
