Sealed bids will be accepted by the City of Lake City, Florida until **Thursday, February 27, 2020 at 11:00 a.m.** local time in the Procurement Department located on the 2<sup>nd</sup> floor of City Hall, 205 N Marion Avenue, Lake City, Florida 32055. **Any bids delivered to any other location will not be considered received by the Procurement Department**. Bids received after the above time will not be accepted under any circumstances. Any uncertainty regarding the time a bid is received will be resolved against the Bidder. Bids will not be accepted via fax. Bid opening will be promptly at **11:15 a.m.** in the City Council Chambers located on the 2<sup>nd</sup> floor of City Hall, at which time all bids will be publicly opened and read aloud for:

#### JET A 15,000 GALLON BOTTOM LOAD FUEL TANK SYSTEM

All bid proposals which are submitted through delivery services such as Federal Express, UPS, or United States Postal Service Express Mail, must be marked on the <u>OUTSIDE of the delivery package</u> with the company or Bidder's name, address, phone number, bid number (ITB-008-2020), bid title <u>JET A 15,000 GALLON BOTTOM LOAD FUEL TANK SYSTEM date and time February 27, 2020</u> @ 11:00 AM). The bid proposal must be in a sealed envelope INSIDE the delivery package with the same information as listed above. All bid proposals which are hand delivered or delivered through regular mail by the United States Postal Service must have all the same information as listed above on the OUTSIDE of the sealed envelope. Failure to comply may be reason to reject the bid.

One (1) original plus one (1) copy of your bid must be sealed and plainly marked on the outside of the envelope with the bid number, the bid name and opening date. Bids must be addressed to the following:

Bids must be completed in English language, signed with ink, in spaces provided on the enclosed bid forms and submitted in duplicate or bid will be subject to rejection.

Any deviation from the specifications must be explained in detail on sheets attached to the bid form and labeled "Clarifications and Exceptions," and each deviation must be itemized by number and must specifically refer to the applicable specification paragraph and page. Otherwise it will be considered that items offered are in strict compliance with these specifications and the successful Bidder will be held responsible for meeting the specification.

All questions must be in writing and directed to the Director of Procurement. All questions will be answered in writing. Any answers which may alter the scope of work will be answered in the form of addenda. Any and all Addenda must be signed and returned with the original response to be considered responsive. Deadline for receiving questions is **Thursday**, **February 20**, **2020** at **4:00** p.m. Questions received after this date and time will not be considered. Questions may be submitted via e-mail to procurement@lcfla.com or by mail to City of Lake City, Procurement Department, 205 N. Marion Avenue, Lake City, FL 32055.

Bidder may not withdraw his/her bid for a period of sixty (60) days.

The City of Lake City is exempt from State Use Tax, State Retail Tax and Federal Excise Tax. The bid price must be net, exclusive of taxes. Bidder's proposal must be dated, signed by authorized representative, title, firm name, address and telephone number.

Local Vendor Preference: City of Lake City Administrative Policy #18 states that the bid of a resident of Columbia County, Florida will have a 5% preference over the bid submitted by any non-resident of Columbia County. A resident is defined as an individual whose primary residence is within Columbia County, Florida, a partnership whose principals are all residents of Columbia County, Florida, partnership or other business entity whose principal place of business is within Columbia County, Florida, or which maintains a full time business office open to the public within Columbia County, Florida. With these and other contributing factors the City Council reserves the right to award a bid or contract in the best interest of the City.

Respondents to this solicitation or persons acting on their behalf may not contact, between the release of the solicitation and the end of the 72-hour period following the agency posting the notice of intended award, excluding Saturdays, Sundays, and city holidays, any employee or officer of the executive or legislative branch concerning any aspect of this solicitation, except in writing to the Procurement Department or as provided in the solicitation documents. Violation of this provision may be grounds for rejecting a response.

Any Bidder desirous of protesting a bid for any reason must file a written notice of bid protest with the City Manager's office within 72 hours following posting of notice of intended award. All protest will be in writing stating the bid being protested and the specific reason of the protest. All protest will be signed by the Protestor and include all detail for a complete and thorough review. The decision of the City Manager, after consultation with the City Attorney will be issued within five (5) working days of the receipt of the protest, unless additional time is agreed upon by all parties involved should circumstance warrant such a delay.

By submission of his/her bid, the Bidder certifies that:

A. The bid has been arrived at by the Bidder independently and has been submitted without collusion with any other vendor of materials, supplies or equipment described in the Invitation to Bid.

B. The contents of the bid have not been communicated by the Bidder, his/her employees or agents, to his/her best knowledge and belief, to any person not an employee or agent of the Bidder or his surety in any bond furnished herewith and will not be communicated to any such person prior to the official opening of the bids.

The City of Lake City reserves the right to accept or reject any/all bids and to award the contract in the best interest of the City of Lake City, Florida.

#### "SPECIFICATIONS"

This Invitation to Bid is for all labor, equipment, and materials to complete the purchase and installation of a 200 GPM Jet-A Fuel Tank System complete which includes a 15,000-gallon bottom load Steel Aboveground, double walled Jet-A Fuel tank with an attached 200 GPM Bulk-Loading system. The systems must be Factory Assembled, self-contained, pre-wired, pressure tested, with all required labels, decals, permits and mounted to the concrete pad. The proposed bid must meet the specifications listed herein.

Requests for consideration for products other than those listed must be <u>submitted for approval prior to the</u> <u>deadline for questions</u>.

#### 1. JET-A BOTTOM LOAD TANK SYSTEM

One (1) 15,000 gallon, bottom load, Flameshield Steel Aboveground Jet-A Tank System, Doublewall, meeting all UL-142 and SWRI 97-04 Standards for Steel Aboveground Tanks for Flammable and Combustible Liquids, internally epoxy coated and exterior coated with white epoxy paint, with the tank mounted on stationary sloped steel saddles welded to tank and mounted to the concrete pad, having an attached bottom loading system built on a 96 inch equipment deck with a covered canopy the following equipment:

#### TANK COMPONENTS

- a. The eastside tank there needs to have a 96-inch equipment deck with a 96-inch canopy over the equipment deck for bottom loading equipment
- b. Three-inch *OCV* automatic high-level shut-off system at 95% tank capacity with pre-check, (shut-off valve to be fully assembled and finish painted)
- c. Aluminum floating suction system with stainless steel test cable
- d. Three-inch Emergency fire safety valve
- e. Two (2) 10" Morrison emergency vents, one emergency primary vent and one emergency secondary vent
- f. Two-inch atmospheric vent 6' high with pressure/vacuum atmospheric vent for primary tank
- g. Two four-inch vents for our fuel monitoring system
- h. Three-inch floating suction assembly inside tank connected to 3" bulkhead fitting on tank head
- i. Interstitial space visible monitor
- j. Clock level gauge
- k. Inlet adaptor with locking dust cover
- 1. Sump bowl located at the slope end of the tank with a hand operated sump pump
- m. Explosion proof motor starter with start-stop switch

- n. Twenty (20) gallon aluminum sump fuel recovery/reclaim unit
- o. Total Controls meter with whole gallon register
- p. Side mounted ladder with cage next to the twenty-four-inch man-way located closest to the bulk-loading bottom load system tank end, painted yellow
- q. Standard OSHA ladder rungs on 12-inch center mounted on opposite end of fuel tank from bulk-loading skid system with grab rails
- r. Two (2) Twenty-Four inch bolted man-way located on top of tank with each man-way being located one-third of the way from each tank end on top of the tank
- s. Includes all site electric/components supply and installation for the Jet-A tank system
- t. Complete, submit, and pay for all required Florida Department of Environmental Protection (DEP) and local building inspections forms/permits and permission notification forms as required by Florida codes as they pertain to Fuel Storage Systems
- u. The 15,000 gallon, bottom load, aboveground, double-wall tank Jet-A Fuel Tank System, fully operational with all permits and appropriate agency approvals, including complete installation and two (2) year complete warranty and operating manual for equipment data

## BOTTOM LOAD SYSTEM COMPONENTS

- a. One (1) 200 GPM Bottom Loading system complete.
- b. The bottom loading system should be built on a 96-inch equipment deck with canopy cover.
- c. The bottom loading equipment needs to be setup to off/on load fuel from/to the East.
- d. The bottom loading system equipment needs to meet all required NFPA standards and all required PEI publication.
- e. Provide bottom load system equipment specifications, design drawing and submittal package consisting of equipment deck, bottom load equipment, P&ID and electrical schematic.
- f. *Gorman Rupp* 3" 03C31-B pump or equal, with explosion proof motor, 7.5 HP., 230 volts 3 phase
- g. *Facet* 243 GPM EI 1581, 7<sup>th</sup> Edition Filter Separator or equal, with air eliminator, pressure relief, GTP-534-PB-30A differential pressure gauge, 0-160 psi 4" face pressure gauge, electrical float water defense system, Millipore sample connections, and stainless steel spring closed manual drain valve
- h. Thirty-Second Static Relaxation with air eliminator, pressure relief, and stainless steel spring closed manual drain valve, (ref. NFPA-407 4.1.5.9)
- i. Four-inch Camlock tank inlet adaptor with locking dust cover
- j. Three-inch Wafer check valve
- k. Complete pressure test of the Bottom Load System
- 1. Three-inch pump inlet strainer with stainless steel basket.
- m. Three-inch Viton lug type butterfly shut-off valves API-609.
- n. Three-inch Fire safe flanged tank shut-off ball valves.
- o. Cla-Val 347GF or equal bottom loading coupler
- p. Electric Deadman control with GTP mini Deadman control with 25' SJPW cord with complete motor shut off control
- q. Static grounding reel with 25' stainless steel coated, military ground clip, stop assembly
- r. 2.5" X 18' Bottom Loading Hose API-1529 with 3 lug bottom load nozzle

- s. One M*orrison* 918S-0400-AG or equal ground level reading tank gauge with high level alarm at 90% tank capacity
- t. Total Control 70030SPA meter or equal with 1/1USG register (outbound)
- u. All fuel to be metered in and out
- v. All fuel to be filtered in and out
- w. Unit set-up to off-load transport, bottom load refueler, and recirculate at 200GPM
- x. Operating manual with equipment data
- y. Explosion proof NEMA 7-9 enclosure with size one motor starter and start-stop switch
- z. The bulk-loading bottom load system should have all fuel filters side mounted to allow the fuel filters to be changed from the side and not the top

#### 2. Materials and Products

#### 2.1 MATERIALS

All materials and equipment used in this project shall be new and shall meet or exceed the following specifications.

#### 2.1.1 STEEL PLATE

All steel plate used in the construction of the multi-hazard, protected AST and related accessories must conform to ASTM A36.

#### 2.1.2 STEEL SHEET

All steel sheet used in the construction of the multi-hazard, protected AST and related accessories must conform to ASTM A570 Grade 33.

#### 2.1.3 PIPING AND TUBING

All pipe used in the construction of the multi-hazard, protected AST and related accessories must conform to ASTM A179. All couplings, unions, elbows, tees, and fittings used shall conform to the ASTM standard appropriate for the pipe or tubing being connected. The piping system shall include a 2" stage 1 vapor recovery pipe with vapor recovery fittings. All piping will be stainless steel, washed and oil-free before installation.

#### 2.1.4 TANK EQUIPMENT

The equipment, indicated on the manufacturer's drawings used on the multi-hazard, protected AST as part of its listing requirements or as part of the fuel transfer, storage, or dispensing systems must meet the following requirements:

- a. All applicable standards of section 2.1.2 above.
- b. All equipment installed shall be designed for use in fuel storage and dispensing systems and shall be compatible with other tank components and with the fuel to be dispensed.
- c. Except for the fuel filters, all equipment that is part of the tank pumping or dispensing system must be UL listed for use with flammable and combustible liquids.

#### 2.2 PRODUCTS

#### 2.2.1 ABOVEGROUND STORAGE TANK (AST)

The AST must be constructed with materials conforming to the specifications found in Section 2.1 and the entire assembly must be listed by a nationally recognized testing laboratory meeting the following requirements:

- a. Tank must be Flameshield<sup>TM</sup>, 2-hour 2000° Fire tested double-wall aboveground storage tank.
- b. Tank must bear the Steel Tank Institute Flameshield<sup>™</sup> identification label. 2. Aboveground tank must bear Southwest Research Institute 97-04 label.
- c. Tank must be manufactured in accordance with Steel Tank Institute Flameshield<sup>™</sup> Standard for Aboveground Tanks.
- d. Aboveground tank primary and secondary containment (inner and outer walls) must be manufactured in accordance with Underwriters Laboratories UL 142, Standard for Steel Aboveground Tanks for Flammable and Combustible Liquids.
- e. Integral secondary containment must be tested and provide access for interstitial leak detection monitoring.
- f. The tank assembly must be constructed with integral supports using stationary sloped steel saddles welded to tank to provide the capability to rigidly anchor the tank to its concrete foundation for resistance to seismic loads.
- g. The interior and external surface of the tank preparation must meet the Society for Protective Coatings (SSPC) and the National Association of Corrosion Engineers International (NACE) standards.
- h. The interior of the tank must be prepared to meet SSPC-SP10/NACE 2 Near-White Blast Cleaning standards using a high performance industrial epoxy primer and with epoxy lining.
- i. The external surfaces of the outer tank, bulk-loading skid components, nozzles, and supports items must be protected from the elements. All of these surface preparations must meet the of SSPC-SP6/NACE 3 Commercial Blast Cleaning standards. For painting must use a high performance industrial epoxy primer and two (2) coats of polyurethane top coat protective high gloss finish, white in color. The total minimum dry film thickness must be 4 mils.
- j. Except for the vent riser pipe and access assembly, if any items used on the tank must be fabricated and assembled at the manufacturer's facility.
- k. The complete system will be pressure tested and calibrated.

#### 2.2.2 TANK VENTS

- a. Normal Vents, each compartment of the primary tank must be equipped with a normal venting device sized in accordance with the requirements of NFPA 30. The venting device(s) must be installed so that it exhausts upward at an elevation no less than 12 feet above the ground.
- b. Emergency vents. Each compartment of the primary tank must be equipped with and emergency vent sized in accordance with NFPA 30.

#### 2.2.3 GAUGING

The tank must be equipped with a float actuated level gauge capable of indicating the approximate fluid level in the tank.

#### 2.2.4 MONITOR PORT

- a. The tank must be equipped with a monitor port that may be utilized for the detection of leaks from the primary tank into the secondary containment tank. The monitor port must be a minimum of 2" steel pipe rigidly attached to the tank and suitable for manual or automatic electronic monitoring.
- b. The monitor port shall be furnished with a lockable cap and shall be marked to clearly indicate that it is not a fill port.

#### 2.2.5 GROUND LEVEL FILL SYSTEM

If the tank fill adaptor is located higher than 3'6" above the ground surface. The access platform must meet the following requirements:

- a. The access platform must provide a working surface no less than 20 inches in width and 20 inches in length.
- b. The access platform must be no more than 36" below the top of the tank.
- c. The design of the steps and platform shall conform with all applicable requirements of OSHA.

The ground level fill system must meet the following specifications:

- a. All piping must be welded, unitized construction.
- b. A "dry-break" style camlock adaptor must be used to prevent spills or riser pipe drain back upon disconnection.
- c. A fuel return swing check valve shall be used to allow fuel to be transferred from the spill containment pan to the fill piping.
- d. The drop tube must have a built-in anti-siphon device.

#### 2.2.6 TANK SIGNAGE

Signage must be affixed to the exterior of the tank in the proper location and configuration to meet applicable code requirements.

#### 2.2.7 TANK LOCATION

The tank must be provided with minimum setback and clearances in accordance with local fire codes.

- a. The tank pad size is 49 feet long, (running east to west) by 15 feet wide, (running north to south) with two footer supports for the tank saddle.
- b. Each footer is 3 feet wide and 2 feet deep with five each number 5 rebar in each footer.
- c. The first footer to the west is centered 7 feet from the west retaining curb, with the second footer being centered 21 feet to the east from the center of the first footer.

#### 3. Execution

#### 3.1 TANK INSTALLATION

Aboveground tank must be installed as recommended by the tank manufacturer and approved by the owner's representative. The tank must be installed in accordance with the manufacturer's installation procedure. The tank, bottom load system, pump, and appurtenances must result in a complete working system.

3.2 Contractor at their own expense will connect the new system to the existing electrical supply.

3.3 The installation of any associated electrical connections to existing power supply including sub panel emergency stop system will be at the contractor own expense for installation of tank.

3.4 Deliver and install new Jet-A tank and system meeting all FDEP requirements with all required permit approvals.

- 3.5 Contractor will provide Start-up and training of City's chosen operators on all pump systems and operations.
- 3.6 Contractor will provide at their expense a Crane and needed equipment to place Tank-Bulk-Loading Skid system in place.
- 3.7 Once the fuel tank is installed the contractor must complete a Soak Test and Fuel Samples per *JIG* bulletin #35 at their expense. The Jet-A fuel required for the soak test will be provided by

the airport. If the soak test fails it is the responsibility of the contractor to remove, depose of the failed fuel and replace it with new Jet-A fuel until the tank passes the soak test and is approved for service.

3.8 Electrical service and fuel piping to the pump unit must be installed in accordance with the manufacturer drawings and the requirements within these specifications, as well as all applicable codes.

#### 3.9 SUBMITTALS

- a. The contractor must provide with their bid the PDF copies of the manufacturer's product datasheets, drawings, installation instructions, and certificates of compliance with testing requirements, engineering data, and equipment specifications for permitting. Shop Drawings: Include plans, elevations, sections, details, and attachments.
- b. Contractor must obtain all necessary permits.
- c. Contractor must complete all required FDEP facility registration forms and accomplish all required DEP notifications.

#### 3.10 PROTECTED FUEL STORAGE TANK

Contractor must provide an aboveground steel fuel storage as specified in section 2 above in the quantity, and size, included with the delivery of the tank must be the manufacturer's certification of listing and compliance with NFPA30.

The completed installation shall comply with the requirements of the NFPA 30 and the conditions of approval stated on the permits. The tank must carry a label from a nationally recognized independent test laboratory stating that fire, hose steam, ballistics and impact tests were all performed on a single fully-assembled test tank.

#### 3.11 WARRANTY

The tank manufacturer must furnish in writing a minimum of a two (2) years warranty.

#### "TERMS AND CONDITIONS"

#### A. <u>LICENSES/QUALIFICATIONS:</u>

All Contractor's together with any Sub-Contractor's must be qualified and licensed under the laws, rules and regulations of the State of Florida and the City of Lake City, Florida to perform the work required by these contract documents. Contractor must be prepared to demonstrate, through previous experience and references, the ability to safely and successfully perform this size and type of project.

#### B. <u>PERMITS:</u>

The awarded bidder shall secure permits and arrange for inspections as required.

#### C. <u>CONTRACT/AWARD:</u>

- 1. The successful Contractor will execute the contract within ten (10) calendar days after Notice of Award. Upon receipt of required documents, a Notice to Proceed will be issued.
- 2. Award shall be made to the most responsive responsible bidder.

#### D. <u>SCHEDULE:</u>

1. Once the Jet A Fuel Tank system is delivered to site for installation work must be completed within 60 calendar days.

#### E. <u>SPECIAL CONDITIONS:</u>

- 1. Extended time may be allowed for the completion of this project due to inclement weather.
- 2. Decisions to allow days added to the contract due to inclement weather will be based upon weather records as recorded with the State of Florida, Division of Forestry located in Lake City, Florida and approved by the Airport Manager.
- 3. In the event additional days are awarded the contractor must notify the City of Lake City Procurement department at the beginning of work stoppage and each succeeding day until work can be safely resumed.

#### F. <u>LIQUIDATED DAMAGES:</u>

In the event the bidder is awarded the contract and fails to complete the work within the time limit or extended time limit agreed upon, liquidated damages will be paid to the City of Lake City at the sum of actual damages per day for all work awarded under the contract until the work has been satisfactorily completed and accepted by the City.

#### G. <u>PAYMENT:</u>

Payment for work completed will be based on: (a) City's acceptance of work, and (b) submitted evidence satisfactory to the City that all payrolls, materials, bills, and indebtedness connected with the work have been paid. The City may withhold an amount as may be necessary to pay such claims

for labor and services rendered and materials involved with the work. It is the expectation of the City that one invoice will be submitted by the Contractor upon completion and acceptance of work. Payment to Contractor will be made within thirty (30) calendar days of receipt of invoice, assuming there are no contested amounts with the invoice.

#### H. <u>DISPOSAL OF WASTE:</u>

The successful Contractor shall be responsible for the daily disposal of all waste materials, debris, and any and all excess materials, containers, etc. at an off-site location in accordance with local, state and federal regulations. The City dumpsters are not to be used by the Contractor. Disposal of waste materials shall be in a proper manner in accordance with all environmental guidelines and regulations.

#### I. <u>OR EQUAL:</u>

Any manufacturers' names, trade names, brand names or catalogue numbers used in the specifications are for the purpose of describing and establishing general performance and quality levels. Such references are not intended to be restrictive. Bids are invited on these and comparable brands or products provided the quality of the proposed products meet or exceed the quality of the specifications listed for any item. All requests for "or equal" consideration must be received prior to the deadline for receiving questions.

#### J. <u>CHANGE ORDERS:</u>

- 1. Notify the City of Lake City of any conditions in the project area that are not addressed within the specifications which may require a change order.
- 2. Change orders to the scope of work or additional work requested by the City of Lake City must be in written form, initiated by the contractor.
- 3. All changes or additions will be approved by the City of Lake City Council via a Resolution prior to work being initiated.

#### K. <u>EXPERIENCE/REFERENCES:</u>

Bidders must provide a statement of qualifications and include with their proposal a minimum of five (5) references for similar project in the last three (3) years. The list of references must be attached with the bid proposal on the form provided within these specifications. All reference materials provided become the property of the City of Lake City and also become public record.

#### L. <u>INFORMATION:</u>

Any questions in regards to the specifications or submission of this bid must be submitted in writing to the Procurement Department via fax at 386-755-6112 or emailed to procurement@lcfla.com.

#### M. <u>ADDENDUM:</u>

It will be the sole responsibility of the bidder to contact the Procurement Department prior to submitting a bid to determine if any addenda have been issued, to obtain such addenda, and to acknowledge addenda with their bid. Failure to submit acknowledgement of any addendum that affects the bid price is considered a major irregularity and will be cause for rejection of the bid.

#### N. <u>REQUIRED DOCUMENTS:</u>

The enclosed documents must be executed and returned with bid proposal or the proposal may be considered non-responsive. (Conflict of Interest Statement, Disputes Disclosure Form, Drug Free Workplace Certificate, Non-Collusion Affidavit of Proposer, Reference, Public Entity Crime Statement and E-verify Affirmation Statement.)

#### O. <u>INSURANCE:</u>

- 1. Without limiting Contractor's indemnification, it is agreed that the successful Contractor will purchase at their expense and maintain in force at all times during the performance of services under this agreement the following insurance. Where specific limits are shown, it is understood that they must be the minimum acceptable limits. If successful Contractor's policy contains higher limits, the City of Lake City will be entitled to coverage to the extent of such higher limits. Certificates of Insurance must be furnished to the City naming the City of Lake City as additional insured. These certificates must provide a ten (10) calendar day notice to the City in the event of cancellation, non-renewal or a material change in the policy.
- 2. Statutory Workers Compensation insurance as required by the State of Florida.
- 3. Commercial General Liability insurance to provide coverage of not less than \$1,000,000.00 combined single limit per occurrence and annual aggregates where generally applicable and must include premises-operations, independent contractors, products/completed operations, broad form property damage, blanket contractual and personal injury endorsements.
- 4. Business Vehicle/Umbrella Liability insurance with a minimum limit of \$200,000 per occurrence, and \$300,000 for all claims arising out of the same incident or occurrence, for property damage and personal injury. Notice, these limits may change according to Florida law and the protections afforded to the City pursuant to sovereign immunity for liability.

#### P. <u>INDEMNITY:</u>
