Municipal Stadium Raker Beam Rehabilitation - ITB 21033

The City of Daytona Beach will receive electronic sealed bids for "MUNICIPAL STADIUM RAKER BEAM REHABILITATION-21033", until 2:00 p.m., on 10/26/2020, at which time bids will be opened publicly and read aloud. Bids received after said time will be rejected. NO PAPER BIDS WILL BE ACCEPTED.

A NON-MANDATORY PRE-PROPOSAL CONFERENCE will be held via Goto meeting, on 10/05/2020 at 10:00 AM. Interested Contractors are *urged* to attend by logging on to https://www.gotomeet.me/DaytonaBeachPurchasing or call into 571-317-3122 and use access code 434-309-917.

The work generally consists of the installation of externally bonded Fiber Reinforced Polymer (FRP) strengthening to designated Raker Beams and the repair of delaminated areas in accordance with the Plans.

PARTICIPATION.
