- All bids must be typed or hand written in ink on the attached Bid Proposal Form. Please place
  the Bid Proposal Form in front of all other documents included in the bid packet. Bids
  submitted in pencil and bids not submitted on the Bid Proposal Form will not be considered.
  All corrections shall be initialed and dated by the bidder representative. Bids that are
  submitted without being signed will automatically be rejected.
- Bid envelopes must be sealed and must indicate clearly the appropriate bid number, bid item, and bid opening date, as indicated on the cover sheet of the bid packet. Bids by Facsimiles and emails will not be accepted. The commission will not be responsible in the event the U.S.
   Postal Service or any other courier system fails to deliver the proposal to the Commission office by the deadline stated in the bid request.
- The Commission provides equal opportunities for all businesses and does not discriminate against any vendor regardless of race, sex, creed, age, disability, national origin or religion in consideration for an award. Bidders must abide by the provision of the American with Disabilities Act of 1990 and assure that in connection with the performance of work under this agreement that they are an equal opportunity employer and do not discriminate on the basis of race, sex, creed, age, disability, national origin or religion.

When responsive and responsible bids are equal, a local vendor shall be favored. # BID SPECIFICATIONS TO EXTEND FENCE HEIGHT FOR MORGAN COUNTY PARKS & RECREATION AT SOUTH PARK IN FALKVILLE, ALABMA

# Extension is 10' from Dugout to Dugout, Raising both the side fencing and backstop

#### SIDE FENCE:

Install 10' extension fence to existing 10' fence from the backstop fence to the dugouts approx. 64' per run; (2) runs per field.

- Add extensions to existing 2 ½" posts to make posts 20' tall
- Run 15/8" toprail on top of fence extension
- (4) fields 512' total
- 9 gauge chain link

#### **BACKSTOP FENCE:**

Install 10' extension fence to existing 20' fence on all backstop fences

- Add extensions to existing 3" posts to make posts 30' tall
- Run 15/8" toprail on top of fence extension
- (4) fields 328' total
- 9 gauge chain link

#### **TIME REQUIREMENTS**

Successful bidder must begin installation within 6 Weeks of Notice to Proceed (after bid accepted and contract agreed upon). Failure to do so will void contract.

Project must be started and completed with all work performed within traditional work week (Monday-Friday).

#### **ADDITIONAL REQUIREMENTS**

All materials and equipment need to be removed from ballfield area (but can stay on site) at the end of each work day by 5:00pm.

All bidders are required to meet with Parks & Recreation Director, Sean Dailey or his designee, at South Park prior to bidding. A signed Certificate of Attendance will be provided after meeting and must be included with each submitted bid. Bids offered without this signed certificate shall be rejected without further review.
