The outside of the proposal envelope shall indicate the name and address of the proposer, shall be addressed to City Clerk, City of Kingman, at the above address and shall be marked: “SEALED BID – “KFD21-004 Kingman Fire Department Uniforms” and shall contain one (1) original and three (3) copies of the bid proposal.
