### RFP # 20-060 Office 365 Email Migration

Georgetown County is seeking bids for migrating into the Microsoft Office 365 (O365) environment using Exchange Online Plan 1 licenses for each seat. The county will purchase these seats independently from SC State Contract as provided by SHI.

#### **I. BACKGROUND & SCOPE OF WORK:**

##### **ISSUE**

The county is looking to reduce management of exchange and/or email related services. The current environment includes an on-premises Microsoft Exchange 2007 server (see build version below) with roughly 600 mailboxes. This system currently resides within an Active Directory operating at 2008R2 Forest level. All desktop and/or laptop computers have Microsoft Office 2013 with Outlook installed.

##### **GOAL**

The County's goals is to have all active mailboxes migrating into O365 with all connecting devices such as desktops, laptops and/or phones properly sending and receiving email into the new environment. The expectation is that email will be migrated over within 1-2 weeks with an agreed upon cutover date for a go-live into the new environment. Incremental updates for emails received into the old environment during the migration period should be applied to the new environment such that no missing emails are to be had. This should include automating the connecting of Outlook via any means necessary for reconfiguration of the client with O365.

##### **SPAM FILTERING**

The county currently operates with spam filtering as provided by Barracuda – Email Secure Gateway 300 with running firmware at 8.1.0.003. In order to reduce licensing costs, the county would like to continue services with Email Secure Gateway by having all incoming emails routed through this device before delivery into O365. The vendor of choice will be expected to make configuration changes in support of spam filtering. This device will remain onsite at the county.

##### **EMAIL ARCHIVING**

The county currently operates with email archiving as provided by Barracuda – Message Archiver 450 with running firmware at 5.0.1.012. In order to reduce licensing costs, the county would like to continue services with email archiving as provided through Message Archiver by having all emails delivered to this

device. The vendor of choice will be expected to make configuration changes in support of archiving emails. This device will remain onsite at the county.

### **DNS RECORDS**

The vendor of choice will need to work with the current IT provider (VC3 Inc) for making modifications to the county's DNS records around MX, SPF, DMARC and/or DKIM in support of the o365 migration.

### **MULTI-FUNCTION PRINTERS**

The vendor of choice will need to update all 72 of the county's multi-function printers in support of scan-to-email via o365. A list of management IPs will be provided along with credentials for managing these devices.

## **II. PROPOSAL SUBMITTAL REQUIREMENTS:**

### A. General

The Request for Proposals (RFP) must be complete, clear and concise (not to exceed thirty (30) 8 ½" X 11" pages). The "Mandatory Bid Submittal Forms" pages required by the County will not be counted as part of the thirty (30) page total. The offeror shall submit the following information in the order listed below and clearly identified in separate sections of the RFP.

### B. Content

Proposals submitted in response to this RFP shall be in the following order and shall include:

#### 1. Cover Letter

Include a 1 page cover letter with the following items:

- a) Legal name and address of company
- b) Legal form of company (partnership, corporation, joint venture, etc.). If joint venture, identify the members of the joint venture and provide all information required within this section for each member.
- c) Name, title, email, address and telephone number of the person to contact concerning submittal questions.
- d) If different from item c) above, name, title, email, address and telephone number of the person(s) able to sign contracts & bind the RFP submittal.

#### 2. Experience & References

Describe your company's background and history, including number of years in business and the scope of service currently provided to clients. Describe your company's experience in completing similar Office 365 Email Migration services. Proposer shall list at least three (3) projects of a similar nature within the last five years. Provide at least three (3) references listing names of client, contact name, telephone number, email address, the type of work performed, and the value of the contract.

Describe your company's experience working with Government agencies such as Local, State, and Federal agencies and your firm's familiarity with the local, state, and federal laws regarding the work.

The Consultant shall describe the involvement it has established for maintaining

communication with clients.

3. Key Personnel

- a) Provide a discussion of your company's staffing plan and level of personnel to be involved, their qualifications, experience, resumes, roles, and the name of the individual who will be in charge and responsible for coordination with the County. Provide the names of the persons who will assist in performing the Work including a description of qualifications, skills, and their responsibilities in this project.
- b) List your closest office in proximity to Georgetown County. Identify proposed sub-consultants (if any) that will be retained to perform any items of work. Provide a list of the tasks, responsibilities, and qualifications of any sub-consultants proposed to be used.

The County's evaluation of the proposal will consider consultant's entire team. Once proposed, no changes in the team composition will be allowed without prior written approval of the County.

- c) Bidder shall disclose any current adverse business circumstances, including litigation that might adversely affect this project.

4. Methodology

Outline your company's basic technical procedures and managerial approaches to accomplish the Work required by this contract. Describe your present workload capacity and your ability to meet the needs of the County. Include any limitations you would foresee in your firm's ability to handle the Work, or work capacity limitations and how you might overcome them. Demonstrate your firm's ability to provide adequate project efficiency. Provide a proposed timeline of the work and transition plan.

5. Service Plan

Outline plan to provide support during go-live and post support. This should include details of support contacts and/or numbers to include any special instructions.

6. Cost/Revenue Proposal

Provide an itemized schedule of fees for services, including as applicable:

- a) Office 365 Email Migration planning costs
- b) Office 365 Email Migration Licensing costs (tools for migration)
- c) Office 365 Email Migration Labor costs to include go-live and post support
- d) Office 365 Email Migration Travel costs
- e) Total project cost

7. Mandatory Bid Submittal Forms

Provide all mandatory bid submittal forms. Failure to provide the necessary forms may cause the bidder to be marked as non-responsive. The County has the right to waive minor informalities at the County's discretion.

Upon receipt by the County, each submittal will become the property of the County, without compensation to the offeror, for disposition or usage by the County at its discretion. The County reserves the right to reject any and all submittals and is not bound to accept any submittal if it is contrary to the best interest of the County.

**III. EVALUATION & AWARD:**

An evaluation committee will be selected and approved by the County Administrator. The committee will review all responses and evaluate in detail those offerors whose proposals appear to best meet the requirements of the County based on the below provided matrix. At the discretion of the County, the evaluation committee may then choose to conduct discussions/presentations with apparent responsive offerors for the purpose of clarification to assure full understanding of the requirements of the request for proposal. The procuring department may in its sole discretion and not subject to challenge through a protest, proceed in negotiations as indicated in procurement ordinance 20-32 Sec. 2-51. Award shall be made to the offeror whose proposal is considered to be most advantageous to Georgetown County.

Once a final determination has been made, a notice of intent to award letter will be mailed out to all respondents. The County of Georgetown is not required to furnish a statement of the reason(s) why a proposal was not deemed to be the most advantageous.

### **1. Submission of Questions**

Questions must be submitted in writing via electronic mail, facsimile or postal mail to the Issuing Officer no later than the “Deadline for Questions” cutoff identified in the Bid Timeline on page three (3) in order to generate an official answer. All written questions will receive an official written response from the Georgetown County Purchasing Office (GCPO) and will become addenda to the solicitation.

GCPO reserves the right to reject or deny any requests made by the Consultant.

Impromptu, unwritten questions are permitted and verbal answers may be provided, but are only intended as general direction and will not represent the official GCPO position. The only official position of GCPO is that which is stated in writing and issued in the solicitation as addenda thereto.

No other means of communication, whether oral or written, shall be construed as a formal or official response/statement and may not be relied upon. **SEND QUESTIONS TO:**

2. Written sealed Request for Proposals to provide **Office 365 Email Migration** shall be received in the Purchasing Office, Second Floor, Suite 239, 129 Screven Street, Georgetown, SC until the cut-off time shown in the bid timeline on page three (3) of this document. Bids will then be publicly and promptly opened at the designated time by the Purchasing Officer. Bids that are not in the Purchasing Officer’s possession prior to the stated opening date and time will be considered **NON RESPONSIVE** and returned unopened. An official authorized to bind the offer must sign all proposals submitted.
3. **Incident Weather/Closure of County Courthouse**  
**Due to the current COVID-19 situation, County offices at the time of this bid posting remain open but are limited to the public. Bid openings may occur from an alternate secure and/or remote location as needed.**
4. This solicitation does not commit Georgetown County to award a contract, to pay any cost incurred in the preparation of the bid, or to procure or contract for goods or services. It is the responsibility of each bidder to see that the Georgetown County Purchasing Office receives bids on, or before, the date and time specified for the bid opening. No bid will be accepted thereafter. The County assumes no responsibility for delivery of bids that are mailed. Georgetown County reserves the right to reject any or all bids and to waive any informalities and technicalities in the bid process.
5. **NON EXCLUSIVITY**  
Nothing herein is intended nor shall be construed as creating any exclusive arrangement with Contractor. Any resulting contract shall not restrict the County from acquiring similar, equal or like

goods and/or services from other entities or sources, when Staff determines internally that this resulting action is in the best interest of Georgetown County.

6. No Bidder may submit more than one bid. Multiple bids for different manufacturers but represented by the same firm will not be accepted. Bids offered directly from manufacturers shall indicate if a local dealer/representative will be involved.

7. Definitions:

- a) The terms “Consultant”, “Company”, “Firm”, “Proposer”, “Offeror”, “Vendor” or “Bidder” refer to those parties who are submitting sealed responses for the work set forth in this document to the OWNER, as distinct from a sub-bidder who provides a bid to the Bidder.
- b) The term “Office 365 Email Migration”, “Project” or “Services” refers to the **complete set of services** as specified in this document, in every aspect.
- c) The terms “Owner” and “County” refer to the County of Georgetown, South Carolina.
- d) Where the words “shall” or “must” are used, it signifies an absolute minimum function or capacity that, if not satisfied, may result in disqualification.
- e) Where the words “should”, “may”, or “is desirable” are used, it signifies desirable, but not mandatory functions or capacities. Bidders who are able to provide these functions or capacities may be evaluated more favorably than those who cannot.

8. Correction or Withdrawal of Bids; Cancellation of Awards

An offeror must submit in writing a request to either correct or withdraw a bid to the Procurement Officer. Each written request must document the fact that the offeror’s mistake is clearly an error that will cause him substantial loss.

- a) Correction of awards : An offeror shall not be permitted to correct a bid mistake after bid opening that would cause such offeror to have the low bid unless the mistake in the judgment of the Procurement Officer is clearly evident from examining the bid document; for example, extension of unit prices or errors in addition.
- b) Cancellation of awards prior to performance: When it is determined after an award has been issued but before performance has begun that Georgetown County’s requirements for the goods or services have changed or have not been met, the award or contract may be canceled and either re-awarded or a new solicitation issued.

**9. Faxed or E-mailed bids will not be accepted by Georgetown County. Electronic bid submissions must be submitted through the Georgetown County Purchasing Vendor Registry page to ensure they remain sealed until the scheduled bid opening date and time.**

10. If you need any reasonable accommodation for any type of disability in order to participate in this procurement, please contact the purchasing office as soon as possible.

11. Title VI of the Civil Rights Act of 1964: Georgetown County hereby gives public notice that it is the policy of the agency to assure full compliance with Title VI of the Civil Rights Act of 1964, the Civil



Rights Restoration Act of 1987, Executive Order 12898 on Environmental Justice, and related statutes and regulations in all programs and activities. Title VI requires that no person in the United States of America shall, on the grounds of race, color, or national origin, be excluded from the participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity for which Georgetown County receives federal financial assistance. Any person who believes they have been aggrieved by an unlawful discriminatory practice under Title VI has a right to file a formal complaint with Georgetown County. Any such complaint must be in writing and filed with Georgetown County's Title VI Coordinator within one hundred and eighty (180) days following the date of the alleged discriminatory occurrence. For more information, or to obtain a Title VI Discriminatory Complaint Form, please see our website at <http://www.gtcounty.org/about/faqs.html>.

12. Any deviations from the specifications or modification of this bid and any extra or incidental work or reductions in work shall be set forth in writing and signed by both parties prior to making such change. Any increase or decrease in the bid price resulting from such change shall be included in writing.
13. Exceptions: The bidder shall list on a separate sheet of paper any variations from, or exceptions to, the conditions and specifications of this bid. This sheet shall be labeled "Exception(s) to Bid Conditions and Specifications," and shall be attached to the bid. When Proposers find instances where they must take exception with certain requirements or specifications of the bid, all exceptions shall be clearly identified. Written explanations shall include the scope of the exceptions, the ramifications of the exceptions for the County of Georgetown, and a description of the advantage to be gained or disadvantages to be incurred by the County as a result of these exceptions. If none, write "NONE".
14. Georgetown County reserves the right to reject any or all bids, and to waive as an informality any irregularities contained in any bid as may be deemed in the best interest of the County. Georgetown County further reserves the right to reject any bid submitted, at its sole option, that the vendor may not be able to meet the service requirements of the bid.
15. Publicity releases: contractor agrees not to refer to award of any resulting contract in commercial advertising in such a manner as to state or imply that the products or services provided are endorsed or preferred by the user.
16. Material Safety Data Sheets: The County of Georgetown will not receive any materials, products, or chemicals which may be hazardous to an employee's health unless accompanied by a Material Data Sheet when received.
17. Ownership of Copyright: All right, title and interest in all copyrightable materials which vendor shall create in the performance of its obligations hereunder shall be the property of the procurer. Vendor agrees to assign and hereby does assign any and all interest it has in and to such material to procurer. Vendor agrees, upon the request of procurer to execute all papers and perform all other such acts necessary to assist procurer to obtain and register copyrights on such materials. Where applicable, works of authorship created by the vendor in the performance of its obligations hereunder, shall be considered "works for hire" as defined in the U.S. Copyright Act.
18. Ownership of Documents: Any reports, studies, photographs, negatives or other documents prepared by vendor in the performance of its obligations shall be the exclusive property of the procurer and all such material shall be remitted to the procurer by the vendor upon completion, termination or cancellation of this order. Vendor shall not use, willingly allow or cause to have such material used for any purpose other than performance of its obligations under this order without the prior written consent of the procurer.

19. Affirmative Action: The contractor will take affirmative action in complying with all Federal and State requirements concerning fair employment and employment of the handicapped, and concerning the treatment of all employees, without regard or discrimination by reason of age, race, color, religion, sex, national origin or physical handicap. The following are incorporated herein by reference: 41 C.F.R. 60-1.4, 60-250.4 and 60-741.4.
20. Inclusion and participation of disadvantaged, small, and local business entities is strongly encouraged, but minimum participation standards are not in effect for this project.
21. All Federally Funded Construction Contracts Over \$2,000:
- a) Davis-Bacon Requirements. These contracts need to include a provision for compliance with the Davis-Bacon Act (40 USC 276a to a—7) and the Department of Labor implementing regulations (29 CFR Part 5). Under this Act, Contractors are required to include the contract provisions in Section 5.5 (a) of 29 CFR Part 5, and to pay wages to laborers and mechanics at a rate not less than the minimum wages specified in the wage determination made by the Secretary of Labor. In addition, Contractors shall be required to pay wages not less than the minimum wages specified in the wage determination made by the Secretary of Labor.   - b) Contract Work Hours and Safety Standard Act Requirements. The contracts must include a provision for compliance with Sections 103 and 107 of the Contract Work Hours and Safety Standards Act (40 USC 327-330) as supplemented by the Department of Labor regulations (29 CFR Part 5). Under Section 103 of the Act, each Contractor shall be required to compute the wages of every mechanic and laborer on the basis of a standard workweek of 40 hours. Work in excess of the standard workweek is permissible provided that the worker is compensated at a rate not less than one times the basic rate of pay for all hours worked in excess of 40 hours in the workweek. Section 107 of the Act is applicable to construction work and provides that no laborer of mechanic shall be required to work in surroundings or under working conditions which are unsanitary, hazardous, or dangerous to health and safety as determined under construction, safety and health standards promulgated by the Secretary of Labor. These requirements do not apply to the purchases of supplies, materials, or articles ordinarily available on the open market, or contracts for transportation or transmission of intelligence.
  - c) Copeland “Anti-Kickback” Act Requirements. All construction contracts over \$2,000.00 must include a provision for compliance with the Copeland “Anti-Kickback” Act (18 U.S.C. 874) as supplemented in Department of Labor regulations (29 CFR Part 3). This act provides that each Contractor shall be prohibited from inducing, by any means, persons employed in the construction, completion, or repaid of public work to give up any part of their compensation.
22. Bidders must clearly mark as "confidential" each part of their bid which they consider to be proprietary information that could be exempt from disclosure under section 30-4-40, Code of Laws of South Carolina 1976, as amended (Freedom of Information Act). If any part is designated as confidential, there must be attached to that part an explanation of how this information fits within one or more categories listed in section 30-4-40. The County reserves the right to determine whether this

information should be exempt from disclosure and no legal action may be brought against the County or its agents for its determination in this regard.

23. CERTIFICATION REGARDING DRUG-FREE WORKPLACE:

The contractor certifies that the vendor(s) will provide a “drug-free workplace” as that term is defined in Section 44-107-30 of the Code of Laws of South Carolina, 1976, as amended, by the complying with the requirements set forth in title 44, Chapter 107.

24. Certification of Non-Segregated Facilities

The federally-assisted construction contractor certifies that he does not maintain or provide, for his employees, any segregated facilities at any of his establishments and that he does not permit his employees to perform their services at any location, under his control, where segregated facilities are maintained. The federally-assisted construction contractor certifies that he will not maintain or provide, for his employees, segregated facilities at any of his establishments and that he will not permit his employees to perform their services at any location under his control where segregated facilities are maintained. The federally-assisted construction contractor agrees that a breach of this certification is a violation of the Equal Opportunity Clause in this Contract.

As used in this certification, the term "segregated facilities" means any waiting rooms, work areas, restrooms, and washrooms, restaurants and other eating areas, time clocks, locker rooms and other storage or dressing areas, parking lots, drinking fountains, recreation or entertainment areas, transportation, and housing facilities provided for employees which are segregated on the basis of race, color, religion, or national origin because of habit, local custom, or any other reason. The federally assisted construction contractor agrees that (except where he has obtained identical certifications from proposed subcontractors for specific time periods) he will obtain identical certifications from proposed subcontractors prior to the award of subcontracts exceeding \$10,000 which are not exempt from the provisions of the Equal Opportunity Clause and that he will retain such certifications in his files.

The purpose is to establish a Contract with firm pricing and delivery. The right is reserved to extend the use of this contract to any County Department as needed.

28. **TERMS OF AGREEMENT / RENEWAL**

The County reserves the right to negotiate with the successful bidder, after contract award, for an additional discount.

29. **PRICE ESCALATION/DE-ESCALATION:**

Prices are to remain firm for the first contract period. In subsequent terms, the contractor may request, in writing at least sixty (60) days in advance of the contract ending date, an increase/decrease. Should the County elect to exercise the option to renew the contract for additional year(s), the contract prices for the additional years shall not exceed the percentage increase/decrease of the "Services" category of the CPI-W SECTION OF THE CONSUMER PRICE INDEX of the United States Bureau of Labor Statistics for the latest twelve month for which statistics are available. Should the price change be granted and the County elects to renew the contract, the purchase order will reflect the changes.

31. Insurance

36. Invoicing and Payment

All such invoices will be paid within thirty (30) days unless any items thereon are questioned, in which event payment will be withheld pending verification of the amount claimed and the validity of the claim. 37. South Carolina Sales Tax

The County of Georgetown, SC is not exempt and pays the appropriate SC sales tax on all applicable purchases.

38. Assignment of Contract

This contract may not be assigned in whole or part without the written consent of the Purchasing Officer.

39. Termination

Subject to the provisions below, the contract may be terminated by the County upon sixty (60) days advance written notice to the other party; but if any work or service hereunder is in progress, but not completed as of the date of termination, then this contract may be extended upon written approval of the County until said work or services are completed and accepted.

a. Termination for Convenience

In the event that this contract is terminated or canceled upon request and for the convenience of the County, without the required sixty (60) days advance written notice, then the County shall negotiate reasonable termination costs, if applicable.

b. Termination for Cause

Termination by the County for cause, default or negligence on the part of the contractor shall be excluded from the foregoing provision; termination costs, if any, shall not apply. The sixty (60) days advance notice requirement is waived in the event of Termination for Cause.

c. Non-Appropriation:
