Shepherd Bus Shelter Project

OPEN CALL TO ARTISTS: Request for proposals

Deadline: March 16th, 2017, 4:00 PM EST

Honorarium: \$2,000

Installation Duration: Two Years (minimum)

OVERVIEW:

Public Art Chattanooga (PAC) is seeking proposals for original, two-dimensional designs that will be printed and installed on two school bus shelters in the Shepherd neighborhood in Chattanooga, Tennessee. Two designs will be selected for production and installed beginning in spring 2017. The selected artists/designers will receive a \$2,000 honorarium for their design.

PROJECT DETAILS:

Artists/designers are invited to submit original 2-D images for the back panels of two school bus shelters that provide warmth and shelter to neighborhood school children. While theme, colors and forms are at the discretion of the artists, they should be mindful of the Shepherd Community and the area surrounding specific bus shelter locations.

SITE: School Bus Shelter Locations:

- Frontage Road & Talladega Avenue, Chattanooga, TN (Map <u>HERE</u>)
- Dixson Street & Talladega Drive, Chattanooga, TN (Map <u>HERE</u>)

Two designs will be selected to be reproduced on wraps that will cover the six back glass panels of the school bus shelters. Artists must submit designs according to the specifications detailed on pages 5-7 of this document and in consideration of the template on page 10. Selected artists must be available to collaborate with the local company that will be fabricating and installing the wraps, ensuring that designs conform to the specifications of the bus shelter. Images of the bus shelter can be seen on page 10 of this document, and examples of other shelter designs in Chattanooga can be seen on page 11.

ARTWORK GOALS:

- Serve as a strong visual anchor.
- Speak to rebirth, revitalization, and renewal.
- The Shepherd community has a reputation for being close-knit. Artwork may speak to the importance of family and community.
- Many of the streets in Shepherd are named for historically black college and universities. Artists may want to emphasize themes of education and advancement.
- Speak to the district's renewed spirit.
- Add to the diversity of the City of Chattanooga's growing public art collection.

ABOUT SHEPHERD:

The Shepherd Community is one of the oldest historically black communities in Chattanooga, Tennessee. The Shepherd Community Action Council was initiated in 1967 and continues to the present day. They have sought to develop public programs, including artistic and beautification programs that improve the civic spirit of the community and express their unique history. These programs are held in public spaces around the neighborhood. As with many Chattanooga neighborhoods, there is a generational divide between those who engage in civic activities and younger generations who are future leaders of the community.

Members of the Shepherd Community Action Council hope that public art projects in the neighborhood will bridge generations and engage the youth of community. In addition to wrapping an existing shelter with artwork, a new multi-use shelter will be installed on the opposite perimeter of the community and will beautify the neighborhood while strengthening students' understanding of Shepherd history. Additionally, the neighborhood hopes that this project will demonstrate how to conceive of, develop and implement a civic project to neighborhood youth. The proposed installation will serve a recently developed Habitat for Humanity community in Shepherd, comprised of about fifty homes. The area has seen a growth in the number of public school students in residence. These students do not currently have shelter while waiting for the school bus near their homes.

ELIGIBILITY:

This RFP is open to all visual and graphic artists and artist teams over the age of 18, who currently reside in the United States. Local artists are strongly encouraged to apply.

APPLICATION DEADLINE:

Applications must be received (electronically, hand delivered, or mailed) no later than March 16th, 2017, 4:00 pm EST. Refer to pages 5 and 6 for application procedures. ANSWERS TO QUESTIONS:

Questions must be submitted by e-mail to Deidre Keylon <u>no later than 4:30 p.m. on March 6, 2017</u>. All questions will be answered by an Addendum which will be posted to the website with the solicitation document soon after the deadline for questions.

SELECTION PROCESS & CRITERIA:

An ad hoc selection panel including representatives from the Shepherd Community Action Council, the Public Art Committee, and neighborhood residents and business owners will review all proposals for the project and will select the top two proposals to be awarded the honorarium.

Panelists will use the following criteria in the selection process:

- Submittal of all required application materials as outlined in this announcement;
- Artistic merit and graphic strength of the proposed design;
- The ability of the design to be successfully translated into large format;
- Consideration of appropriate content and themes for the children who will be utilizing the shelters;
- Appropriateness for placement in an urban environment.

PROJECT BACKGROUND:

Through PAC's Art in the Neighborhoods program, the Shepherd Community Action Council was awarded funding to develop meaningful public art project(s) in their community. PAC has worked actively with the Shepherd Community Action Council, gathering community input and laying the groundwork for public art projects within Shepherd.

Public Art Chattanooga has previously partnered with CARTA and River City Company to wrap CARTA Electric Shuttles with artist designed wraps. Similarly, PAC partnered with Glass House Collective to wrap three CARTA bus shelters with artist designed wraps. These projects have successfully animated the streets of Chattanooga with colorful and creative artwork for several years. Public Art Chattanooga will continue by

wrapping two bus shelters to complement revitalization efforts in the community and bring contemporary art into the daily lives of passengers and passers-by.

ABOUT ART IN THE NEIGHBORHOODS:

Art in the Neighborhoods (AIN) is a pilot program within the City of Chattanooga's department of Economic and Community Development (ECD). Because public art is a proven a tool for positive economic and community impact, the purpose of AIN is to help neighborhoods generate unique public art projects in their community that have the ability to beautify and enliven streets, parks and community centers; enhance and improve public spaces; and create neighborhood identity and community pride. AIN is co-produced by ECD's Neighborhood University and Public Art Chattanooga (PAC), managed by PAC, and funded by the City of Chattanooga, the Benwood Foundation and the Footprint Foundation.

APPLICATION GUIDELINES AND SPECIFICATIONS:

Please note the following IMPORTANT specifications:

- Artists may submit up to **TEN** designs for consideration.
- Materials not requested will not be reviewed.
- In the creation of designs, please consider the template on **page 10** of this document. Only areas in gray will contain artwork.
- Designs that incorporate commercial advertisement for a company, entity or individual will not be considered.

SUBMISSION REQUIREMENTS:

Proposals may be submitted electronically, by mail, or by hand delivery and must include <u>two copies</u> of all printed materials. ANY PART OF ANY PROPOSAL SUBMITTED BY E-MAIL WILL CAUSE THE PROPOSAL TO BE ELIMINATED. <u>Materials should be single-sided and must include ALL OF the following</u>:

- Completed and signed RFP cover page (included on page 1), completed and signed application form
 (included at the end of this RFP on page 8), AND completed and signed addenda cover pages.
 (Addenda are additional instructions that can be added to a solicitation until 48 hours before the due
 date/time. Each proposer must check the website 48 hours before the due date/time to see if addenda
 have been added. Questions and Answers will be addressed by addendum. Signed addenda pages
 are the only part of the proposal that can be sent by e-mail and will be accepted. They can also be sent
 by fax or mail, or they can be delivered.
- 2. Current Résumé (two-page limit).
- 3. Letter of Interest briefly addressing how you addressed this project. This document should be no longer than one page (single-spaced, 1-inch margins, 12 pt. font).

- b. If your design proposal is selected for production, the following format will be required:
 - TIF file with resolution of 100 dpi at 100% of print size (flattened RGB). Assuming art is a single contiguous image, the file should be provided as a single file, sized appropriately to account for center trim plus a 1" bleed around the outside edges.
 - If the selected artist is unable to provide his or her artwork in the above format, PAC can make arrangements to assist with formatting print-ready files.
- 6. If you are submitting electronically, you must either use the shared Google folder (instructions included below) or send a flash drive. We do not have readers for any other type of electronic storage, including CD discs. To submit electronically using a Google folder, a Google account (which is free of charge) is required. If you are not willing to set up a Google account, you must submit your proposal by other means.
- 7. All flash drives must be labeled with the applicant's name.
- 8. Every image file must be titled first with the number of the image in the order to be viewed (use "0" in front of single-digit numbers), followed by the artist's last name [for example: 01_Smith; 02_Smith]. The numbers must correspond to the annotated image list.
- 9. Annotated Image List: Please include the artist's name as a heading, and a brief description of each image, including title and original medium.
- 10. Iran Divestment Act form, completed and signed
- 11. Please do not submit paper materials in plastic covers, binders, or folders. Use only paper clips to bind your materials.
- 12. Please write "**REQUISITION# 139882**" on the outside lower left-hand corner of the envelope before mailing application materials.


