All equipment below shall be quoted as listed (separate price list must be provided). Any exception shall be noted on the bid with the equivalent listed along with specifications for the excepted item. Items identified can be purchased individually or as a complete package.

Bidders shall provide full warranty/extended warranty, separate of the manufacturer, of all items purchased

Bidders shall ensure all parts and instructions are bundled and delivered at the same time
