**INTRODUCTION**

Georgetown County is soliciting proposals for a contractor to provide the following: Transport Services for the Georgetown County Coroner’s Office, “As Required.” Interested firms are invited to submit a proposal in accordance with the enclosed requirements.

The objective of this Invitation for Bid (IFB) is to solicit interest, capabilities and costs from qualified firms to provide transport services for the Georgetown County Coroner’s Office to include the proper pick-up and transportation of deceased bodies as so directed by the Coroner. The transportation will be to Grand Strand Regional Medical Center and Medical University of South Carolina (MUSC). There may also be a need for providing transport services to or from morgue facilities that may be located outside of Georgetown County. It is the Coroner’s intent to contract with a firm who can provide professional delivery services for Georgetown County 24-hours a day, 7-days per week, 52-weeks per year. There may also be a need for providing transport services to or from morgue facilities that may be located outside of Georgetown County.

This IFB describes the required scope of services, the qualifications the county is seeking, the minimum information that must be included in a proposal response and the proposal selection process. Compensation would be paid to the firm at a per body transport rate. All respondents to this Invitation for Bid (IFB) are requested to propose one rate for each and every transport (fee for services).

**LOCATIONS:**

The Coroner’s Office is located at the Georgetown County Courthouse, 129 Screven St, Georgetown, SC.

**CONTRACT AWARD:**

The term of any resulting professional services agreement shall be for one (1) year from the date the contract is signed, with optional one (1) year renewals thereafter, not to exceed a maximum of 5 years total.

Upon receipt by the County, each submittal will become the property of the County, without compensation to the offeror, for disposition or usage by the County at its discretion. The County reserves the right to reject any and all submittals and is not bound to accept any submittal if it is contrary to the best interest of the County.

Award will be made to the responsible organization offering the lowest price to the county. The County further reserves the right not to make any award as a result of this solicitation.

Offerors are required to meet all solicitation requirements, such as terms and conditions, as well as technical requirements to be eligible for award. Failure to comply with the terms and conditions of the solicitation may result in the offeror being removed from consideration for award. Any exceptions to the solicitation's terms and conditions must be fully explained and justified.

**SPECIFIC REQUIREMENTS/SCOPE OF WORK:**

1. The successful Offeror will be responsible for providing transport services for the Georgetown County Coroner's Office to include the proper pick-up and transportation of deceased bodies as directed by the Coroner. The County Coroner will direct whether the body is transported to the Grand Stand Regional Medical Center in Myrtle Beach or to the Medical University of South Carolina in Charleston. The Offeror must be qualified, prepared and available to provide these services on a 24 hours a day, seven days a week basis for the Coroner's Office. The Offeror must be familiar with all portions of federal, state, municipal and county laws and ordinances pertaining to the handling of deceased persons.
2. Charges to Deceased's Estate: Contractor shall not charge the deceased's estate, survivors, insurance, etc., for any transportation services made under the direction of the Coroner's Office. Failure to adhere to this requirement may be just cause for immediate termination of the contract
3. The Offeror must also provide satisfactory evidence that they can provide all of the labor, equipment and supplies necessary to perform the proposed services which the Offeror and Coroner reasonably and mutually agree are needed for the Offeror to fulfill the obligations under an agreement. The Offeror must have and maintain in force and effect all necessary and appropriate licenses by the State Board of Funeral Services. Georgetown County will reserve the right of prior approval and the right to conduct background investigations on all Offeror personnel who may be an employee of the Offeror, or under contract or subcontract with the Offeror.
4. The Offeror will be required to provide a removal vehicle fully equipped to handle two standard mortuary stretchers, staffed employees who are fully insured and properly trained for the unaided removal and transportation of human remains. On occasions the County Coroner may require at least two (2) employees to be available to conduct the transport. The equipment and assigned personnel must be available on an "as-needed basis" on a 24 hours a day, seven days a week schedule subject to calls for service from the Georgetown County Coroner's Office. The successful Offeror must agree to be to respond to each of the Coroner's calls for service within a period of thirty (30) minutes. The Offeror will also be required to be able to provide and maintain a backup removal vehicle on an "as-needed basis". The equipment and vehicles used by the Offeror to provide these services must be visibly marked signifying the professional nature of their services. In accordance with the National Association of Medical Examiners (N.A.M.E.) accreditation requirements, the successful Offeror will provide documentation of scheduled maintenance and repair of the Offeror's transport vehicles.

5. Equipment and Supplies:
  - a. All body bags (disaster pouches) shall be provided by the Coroner's Office.
  - a. Body bags will be issued upon the discretion of the Coroner's office when bodily fluids are present.
  - b. Contractor shall provide mortuary cot covers on each stretcher.
  - c. Contractor shall be responsible for supplying all equipment such as backboards, sheets, latex gloves, etc. and materials to cover bodies during removal and transport.
  - d. Contractor shall be responsible for supplying identification arm bands for all transported decedents.
6. The Offeror's employees who will operate these vehicles must be attired professionally and be able to communicate appropriately and interact with persons at any removal location or at any professional, familial or social level. All transport personnel must possess an appropriate and valid South Carolina driver's license, may be subject to a complete criminal background check and/or a random drug screening by Georgetown County. The Coroner reserves the right to request clothing changes from the successful Offeror to ensure that a professional appearance is maintained when transport services are being provided. All transport personnel are bound to confidentiality of information pertaining to the deceased.
7. The successful Offeror must insure that all transported bodies are properly identified with appropriate identification bands showing the name of the deceased, if known, or criminal investigative case number, if the identity is not known. The human remains are to be placed and secured into a suitable body pouch for transport. The successful Offeror must be able to accomplish the banding and shrouding of the human remains in the absence of a Coroner's representative. The successful Offeror will be required to maintain an accurate inventory of all valuable and personal effects relating to all calls. In providing transport services, the Offeror is required to comply with all applicable OHSA standards, including but not limited to standards pertaining to blood borne pathogens, hazardous communications, labeling, employee training, signage and reporting. The dispensing of all disposable supplies and bio-hazardous materials used must be consistent with OSHA guidelines and all other applicable environmental codes, statutes, resolutions and ordinances of the United States, South Carolina and Georgetown County. The Offeror will also be required to provide regular interior cleaning and disinfection reports of the transport vehicles to the Coroner's Office.
8. The Georgetown County Coroner's Office shall initiate and authorize all transportation of human remains to the County's Morgue, another designed morgue facility or other location. It shall be understood that no compensation will be paid when the successful Offeror responds to a call where the human remains have been authorized for transport, but are located at a hospital or nursing facility and the authorities at that facility refuse to allow immediate release of those remains due to circumstances outside the control of Georgetown County.

**1. Submission of Questions**

Questions must be submitted in writing via electronic mail, facsimile or postal mail to the Issuing Officer no later than the "Deadline for Questions" cutoff identified in the Bid Timeline on page two (2) in order to generate an official answer. All written questions will receive an official written response from the Georgetown County Purchasing Office (GCPO) and will become addenda to the solicitation.

GCPO reserves the right to reject or deny any requests made by the provider.

Impromptu, unwritten questions are permitted and verbal answers may be provided, but are only intended as general direction and will not represent the official GCPO position. The only official position of GCPO is that which is stated in writing and issued in the solicitation as addenda thereto.

No other means of communication, whether oral or written, shall be construed as a formal or official response/statement and may not be relied upon. SEND QUESTIONS TO:

2. Written sealed public bids for a Term Contract to provide **Transport Services for the Georgetown County Coroner's Office, "As Required"** shall receive electronically through the County's Vendor Registry webpage until the cut-off time shown in the bid timeline on page three (3) of this document. Bids will then be promptly opened at the designated time by the Buyer. Bids that are not received prior to the stated opening date and time will be considered **NON RESPONSIVE**. An official authorized to bind the offer must sign all bids submitted.

**3. Inclement Weather/Closure of County Courthouse**

**Due to the current COVID-19 situation, County offices at the time of this bid posting remain open but are closed to the public. However, bid openings may occur from an alternate secure and/or remote location as needed.**

4. This solicitation does not commit Georgetown County to award a contract, to pay any cost incurred in the preparation of the bid, or to procure or contract for goods or services. It is the responsibility of each bidder to see that the Georgetown County Purchasing Office receives bids on, or before, the date and time specified for the bid opening. No bid will be accepted thereafter. The County assumes no responsibility for delivery of bids that are mailed. Georgetown County reserves the right to reject any or all bids and to waive any informalities and technicalities in the bid process.
5. NON EXCLUSIVITY Nothing herein is intended nor shall be construed as creating any exclusive arrangement with Contractor. Any resulting contract shall not restrict the County from acquiring similar, equal or like goods and/or services from other entities or sources, when Staff determines internally that this resulting action is in the best interest of Georgetown County.

6. Bidder may not submit more than one bid. Multiple bids for different manufacturers but represented by the same firm will not be accepted. Bids offered directly from manufacturers shall indicate if a local dealer/representative will be involved.

7. Definitions:

- a) The terms “Proposer”, “Offeror”, “Vendor” or “Bidder” refer to those parties who are submitting sealed responses for the work set forth in this document to the OWNER, as distinct from a sub-bidder who provides a bid to the Bidder. The term “Contractor” refers to the successful Bidder.
- b) The term “Transport Services for the Georgetown County Coroner’s Office, “As Required” or “Service” refers to the **complete set of services** as specified in this document, in every aspect.
- c) The terms “Owner” and “County” refer to the County of Georgetown, South Carolina.
- d) Where the words “shall” or “must” are used, it signifies an absolute minimum function or capacity that, if not satisfied, may result in disqualification.
- e) Where the words “should”, “may”, or “is desirable” are used, it signifies desirable, but not mandatory functions or capacities. Bidders who are able to provide these functions or capacities may be evaluated more favorably than those who cannot.

8. Correction or Withdrawal of Bids; Cancellation of Awards

An offeror must submit in writing a request to either correct or withdraw a bid to the Procurement Officer. Each written request must document the fact that the offeror’s mistake is clearly an error that will cause him substantial loss.

- a) Correction of awards : An offeror shall not be permitted to correct a bid mistake after bid opening that would cause such offeror to have the low bid unless the mistake in the judgment of the Procurement Officer is clearly evident from examining the bid document; for example, extension of unit prices or errors in addition.
- b) Cancellation of awards prior to performance: When it is determined after an award has been issued but before performance has begun that Georgetown County’s requirements for the goods or services have changed or have not been met, the award or contract may be canceled and either reawarded or a new solicitation issued.

9. **Faxed, Mailed, Delivered or E-mailed bids will not be accepted by Georgetown County.**

**Electronic bid submissions must be submitted through the Georgetown County Purchasing Vendor Registry page to ensure they remain sealed until the scheduled bid opening date and time.**

10. If you need any reasonable accommodation for any type of disability in order to participate in this procurement, please contact the purchasing office as soon as possible.

11. Title VI of the Civil Rights Act of 1964: Georgetown County hereby gives public notice that it is the policy of the agency to assure full compliance with Title VI of the Civil Rights Act of 1964, the Civil Rights Restoration Act of 1987, Executive Order 12898 on Environmental Justice, and related statutes and regulations in all programs and activities. Title VI requires that no person in the United

States of America shall, on the grounds of race, color, or national origin, be excluded from the participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity for which Georgetown County receives federal financial assistance. Any person who believes they have been aggrieved by an unlawful discriminatory practice under Title VI has a right to file a formal complaint with Georgetown County. Any such complaint must be in writing and filed with Georgetown County's Title VI Coordinator within one hundred and eighty (180) days following the date of the alleged discriminatory occurrence. For more information, or to obtain a Title VI Discriminatory Complaint Form, please see our website at <http://www.gtcountry.org/about/faqs.html>.

12. Any deviations from the specifications or modification of this bid and any extra or incidental work or reductions in work shall be set forth in writing and signed by both parties prior to making such change. Any increase or decrease in the bid price resulting from such change shall be included in writing.
13. Exceptions: The bidder shall list on a separate sheet of paper any variations from, or exceptions to, the conditions and specifications of this bid. This sheet shall be labeled "Exception(s) to Bid Conditions and Specifications," and shall be attached to the bid. When Proposers find instances where they must take exception with certain requirements or specifications of the bid, all exceptions shall be clearly identified. Written explanations shall include the scope of the exceptions, the ramifications of the exceptions for the County of Georgetown, and a description of the advantage to be gained or disadvantages to be incurred by the County as a result of these exceptions. If none, write "NONE".
14. Georgetown County reserves the right to reject any or all bids, and to waive as an informality any irregularities contained in any bid as may be deemed in the best interest of the County. Georgetown County further reserves the right to reject any bid submitted, at its sole option, that the vendor may not be able to meet the service requirements of the bid.
15. Publicity releases: Contractor agrees not to refer to award of any resulting contract in commercial advertising in such a manner as to state or imply that the products or services provided are endorsed or preferred by the user.
16. Material Safety Data Sheets: The County of Georgetown will not receive any materials, products, or chemicals which may be hazardous to an employee's health unless accompanied by a Material Data Sheet when received.
17. Ownership of Copyright: All right, title and interest in all copyrightable materials which vendor shall create in the performance of its obligations hereunder shall be the property of the procurer. Vendor agrees to assign and hereby does assign any and all interest it has in and to such material to procurer. Vendor agrees, upon the request of procurer to execute all papers and perform all other such acts necessary to assist procurer to obtain and register copyrights on such materials. Where applicable, works of authorship created by the vendor in the performance of its obligations hereunder, shall be considered "works for hire" as defined in the U.S. Copyright Act.
18. Ownership of Documents: Any reports, studies, photographs, negatives or other documents prepared by vendor in the performance of its obligations shall be the exclusive property of the procurer and all



such material shall be remitted to the procurer by the vendor upon completion, termination or cancellation of this order. Vendor shall not use, willingly allow or cause to have such material used for any purpose other than performance of its obligations under this order without the prior written consent of the procurer.

19. **Affirmative Action:** The contractor will take affirmative action in complying with all Federal and State requirements concerning fair employment and employment of the handicapped, and concerning the treatment of all employees, without regard or discrimination by reason of age, race, color, religion, sex, national origin or physical handicap. The following are incorporated herein by reference: 41 C.F.R. 60-1.4, 60-250.4 and 60-741.4.

20. All Construction Contracts Over \$2,000:

a) **Davis-Bacon Requirements.** These contracts need to include a provision for compliance with the Davis-Bacon Act (40 USC 276a to a—7) and the Department of Labor implementing regulations (29 CFR Part 5). Under this Act, Contractors are required to include the contract provisions in Section 5.5 (a) of 29 CFR Part 5, and to pay wages to laborers and mechanics at a rate not less than the minimum wages specified in the wage determination made by the Secretary of Labor. In addition, Contractors shall be required to pay wages not less than the minimum wages specified in the wage determination made by the Secretary of Labor. In addition, Contractors shall be required to pay wages not less often than once a week. Current Wage Determination for Georgetown County in South Carolina is available on-line at: <http://www.wdol.gov/dba.aspx#14>

b) **Contract Work Hours and Safety Standard Act Requirements.** The contracts must include a provision for compliance with Sections 103 and 107 of the Contract Work Hours and Safety Standards Act (40 USC 327-330) as supplemented by the Department of Labor regulations (29 CFR Part 5). Under Section 103 of the Act, each Contractor shall be required to compute the wages of every mechanic and laborer on the basis of a standard workweek of 40 hours. Work in excess of the standard workweek is permissible provided that the worker is compensated at a rate not less than one times the basic rate of pay for all hours worked in excess of 40 hours in the workweek. Section 107 of the Act is applicable to construction work and provides that no laborer of mechanic shall be required to work in surroundings or under working conditions which are unsanitary, hazardous, or dangerous to health and safety as determined under construction, safety and health standards promulgated by the Secretary of Labor. These requirements do not apply to the purchases of supplies, materials, or articles ordinarily available on the open market, or contracts for transportation or transmission of intelligence.

**Copeland “Anti-Kickback” Act Requirements. All construction contracts over \$2,000.00 must include a provision for compliance with the Copeland “Anti-Kickback” Act (18 U.S.C. 874) as supplemented in Department of Labor regulations (29 CFR Part 3). This act provides that each Contractor shall be prohibited from inducing, by any means, persons employed in the construction, completion, or repaid of public work to give up any part of their compensation.**

21. Bidders must clearly mark as "confidential" each part of their bid which they consider to be proprietary information that could be exempt from disclosure under section 30-4-40, Code of Laws of South Carolina 1976, as amended (Freedom of Information Act). If any part is designated as confidential, there must be attached to that part an explanation of how this information fits within one or more categories listed in section 30-4-40. The County reserves the right to determine whether

this information should be exempt from disclosure and no legal action may be brought against the County or its agents for its determination in this regard.

22. CERTIFICATION REGARDING DRUG-FREE WORKPLACE:

The contractor certifies that the vendor(s) will provide a “drug-free workplace” as that term is defined in Section 44-107-30 of the Code of Laws of South Carolina, 1976, as amended, by the complying with the requirements set forth in title 44, Chapter 107.

23. Nothing herein is intended to exclude any responsible vendor, his product or service or in any way restrain or restrict competition. On the contrary, all responsible vendors are encouraged to bid and their bids are solicited.

24. Acknowledgement of Addenda

Each contractor is responsible to verify the number of total addenda issued prior to bid. **Failure to acknowledge all addenda may disqualify the bidder.** All addenda are posted by the County at the website located at [www.georgetowncountysc.org](http://www.georgetowncountysc.org), select “Purchasing” and “Current Bids”. It is each proposer’s responsibility to verify that all addenda have been received and acknowledged.

25. This Invitation for Bid covers the estimated requirements to provide Transport Services for the Georgetown County Coroner’s Office, “As Required” for the Georgetown County Coroner’s Office. The purpose is to establish a Term Contract with firm pricing and delivery under which the department may renew annually. The right is reserved to extend the use of this contract to any County Department.

26. TERMS OF AGREEMENT / RENEWAL

The initial term of any resulting contract shall be for a period of one (1) calendar year, effective from date of contract award. The County reserves the right to negotiate with the successful bidder, after contract award, for an additional discount should available funds permit the purchase of additional units within the fiscal year. The County reserves the right, at its sole option, to renew the contract with optional 1 year renewals thereafter not to exceed a maximum term of five (5) years total.

27. PRICE ESCALATION/DE-ESCALATION:

Prices are to remain firm for the first contract period. In subsequent terms, the contractor may request, in writing at least sixty (60) days in advance of the contract ending date, an increase/decrease. Should the County elect to exercise the option to renew the contract for additional year(s), the contract prices for the additional years shall not exceed the percentage increase/decrease of the "Services" category of the CPI-W SECTION OF THE CONSUMER PRICE INDEX of the United States Bureau of Labor Statistics for the latest twelve month for which statistics are available. Should the price change be granted and the County elects to renew the contract, the purchase order will reflect the changes.

28. Bids must be made on Proposal or Bid Form furnished or will be rejected. Proposals shall be typewritten or written in ink on the form prepared by the County. The person signing the bid shall initial all corrections or erasures.

29. Insurance

The successful bidder shall procure, maintain, and provide proof of, insurance coverage for injuries to persons and/or property damage as may arise from or in conjunction with, the work performed on

behalf of the County by the bidder, his agents, representatives, employees or subcontractors. Proof of coverage as contained herein shall be submitted fifteen (15) days prior to the commencement of work and such coverage shall be maintained by the bidder for the duration of the contract period; for occurrence policies.

a. General Liability

Coverage shall be as broad as: Comprehensive General Liability endorsed to include Broad Form, Commercial General Liability form including Products/Completed Operations.

9. The bidder shall furnish the County certificates of insurance including endorsements affecting coverage. The certificates are to be signed by a person authorized by the insurance company(s) to bind coverage on its' behalf, if executed by a broker, notarized copy of authorization to bind, or certify coverage must be attached.
10. All insurance shall be placed with insurers maintaining an A.M. Best rating of no less than an A: VII. If A.M. Best rating is less than A: VII, approval must be received from County's Risk Officer.

### 30. Workman's Compensation Coverage

Georgetown County, SC will require each contractor and service provider to maintain on file with the purchasing officer, a current Certificate of Insurance showing limits as required by the Workers' Compensation Act of SC: Employers Liability, \$1,000,000.

The law also recognizes "statutory employees." These are employees who work for a subcontractor who may be working for a business or another contractor. ### 31. Hold Harmless Clause

32. Condition of Items

Further, the County may, from time to time, make inspections of the work performed under this contract. Any inspection by the County does not relieve the Contractor from any responsibility regarding defects or other failures to meet the contract requirements.

34. Invoicing and Payment

The firm shall submit invoices on a frequency to be determined, as agreed upon by the County, for each payment requested. Such invoice shall also include a detailed breakdown of all charges. All such invoices will be paid within thirty (30) days unless any items thereon are questioned, in which event payment will be withheld pending verification of the amount claimed and the validity of the claim. The firm shall provide complete cooperation during any such investigation. All invoices shall be forwarded to the following address:

35. South Carolina Sales Tax

The County of Georgetown, SC is not exempt and pays the appropriate SC sales tax on all applicable purchases.

36. Assignment of Contract

This contract may not be assigned in whole or part without the written consent of the Purchasing Officer.

37. Termination

Subject to the provisions below, the contract may be terminated by the County upon thirty (30) days advance written notice to the other party; but if any work or service hereunder is in progress, but not completed as of the date of termination, then this contract may be extended upon written approval of the County until said work or services are completed and accepted.

a. Termination for Convenience

In the event that this contract is terminated or canceled upon request and for the convenience of the County, without the required thirty (30) days advance written notice, then the County shall negotiate reasonable termination costs, if applicable.

b. Termination for Cause

Termination by the County for cause, default or negligence on the part of the contractor shall be excluded from the foregoing provision; termination costs, if any, shall not apply. The thirty (30) days advance notice requirement is waived in the event of Termination for Cause.

c. Non-Appropriation:

It is understood and agreed by the parties that in the event funds are not appropriated in the current fiscal year or any subsequent fiscal years, this contract will become null and void and the County will only be required to pay for services completed to the satisfaction of the County.

38. Default

In case of default by the contractor, for any reason whatsoever, the County may procure the goods or services from another source and hold the contractor responsible for any resulting excess cost and may seek other remedies under law

39. Severability

In the event that any provision shall be adjudged or decreed to be invalid, such ruling shall not invalidate the entire Agreement but shall pertain only to the provision in question and the remaining provisions shall continue to be valid, binding and in full force and effect.
