Each vendor may submit more than one bid provided each bid meets the stated specifications. Each bid must be submitted in a separate sealed envelope with the appropriate notation on the outside. All bids must be signed by an authorized agent and submitted on the prescribed forms. Submission of bids by telegraph, telephone, or other electronic means is strictly prohibited. Please enclose a stamped, self addressed envelope to receive a completed bid tabulation form. Any brand name called for the bid specifications is provided as a reference only. Alternate brand name items offered for bid must be equivalent as to function, basic design, type and quality of material, method of construction, and any required dimensions. Bidder must attach a letter of exception to specifications.

2016 Model Type A Lift Bus

These units shall meet all Federal, Tennessee Department of Education and Tennessee Department of Safety school bus standards for the year model offered and shall be certified "School Bus" by the manufacturer. They shall pass any Department of Safety inspections without additional cost to the owner.

1. Two (2) ton chassis, dual rear wheels, 14,200 GVWR chassis.
2. Alternator: 145 amps.
3. Axle: Front: Capacity 4,600 lbs. GAWR. Rear: Capacity 8,600 lbs. GAWR.
- 4a. Battery: Heavy duty, 12 volt, Delco Freedom, Twin 650 CCA, combined 1500 CCA
- 4b. Battery Box, skirt mounted
5. Brakes: Hydraulic power assisted dual system. Front disc, 12.5" rotor, 45.8 sq.in. facing contact front axle. Rear disc, 12.5" rotor, 45.8 sq.in. contact, rear axle. Parking, cable to rear wheels.
6. Bumper Front: Painted black.
7. Chassis Ignition Switch: Shall energize electrical panel.
8. Cooling System: Heavy-duty; includes increased cooling capacity radiator, clutch-type fan and transmission oil cooler.
9. Door: Outward opening. E/Door
10. Emission: Meets Federal and State of Tennessee standards.
11. Engine: Diesel 260 H.P. Duramax 6.6 liter V8 or higher. Turbo Integral engine, natural aspiration oil cooler, block heater.

24. Interior Trim: Gray.
25. Wheels: 16" tubeless type, painted black. One spare, seven (7) total.
26. Windows: Tinted glass, 28% light transmission. (Bus bodies)
27. Windshield: Tinted.
28. Wipers: 2-speed with intermittent delay and wet arm washers.
29. Padded shoulder rail.
30. Head room of 76" or higher.
31. Rub rail, skirt mounted. All rub rails painted black.

35. Radio - AM/FM Radio with CD Player and four (4) interior speakers. One of four interior speakers must be mounted in the driver's door. Radio must be operable on ACC power.

37. Numbers painted or applied on four exterior locations on the body (minimum height of 6") Bus # -Year (**##-16**) front, rear, right, and left - to agree with VIN year model.
38. Right and left side lettered "ROBERTSON COUNTY SCHOOLS" below windows between rub rails.
39. Stop sign equipped with flashing strobe lights.
40. One (1) Roof Hatches

41. Chair Lift: Bus shall be equipped with: Ricon Wheel Chair Lift (capable of lifting 1,000 pounds) or equivalent equipment, installed on the right hand side to the rear of the rear fender well. All standard seats to be 39" wide with seat belts included. Three (3) forward facing wheel chair positions shall be installed. Seven (7) 39" seats with seat belts to be installed. Two (2) additional 39" seats with seat belts shall be furnished but not installed in each bus. Must be retractor style tie down belts.

42. Bid must include freight to Springfield, Tennessee, Robertson County School Bus Terminal.

43. Color: Body Cohen Bus Yellow and roof shall be white strobe light on top at the back of the bus.

44. Synovia GPS equipment package and five (5) year service contract included.

WARRANTY: 100% Five (5) years 100,000 miles, all parts and labor on engine, transmission and wheel chair lift.

NOTE: Alternate bids will be considered for lift buses. Please include floor plan. If bids are for conventional size school buses, then air brakes are required.
