SCOPE OF WORK involves: The project work includes construction of repairs to the Main Street Pier in Daytona Beach. The work generally consists of repair or replacement of existing wooden pier bracing and connection hardware as well as tightening of all existing connection connections on the pier and repair and replacement to existing pilings and concrete slab bases on pier. Repair and replacement of existing utility line and appurtenances underneath the pier are also included in the project.

BIDS MAY BE HELD by the City of Daytona Beach for a period not to exceed 60 days from the date of opening of bids for the purpose of reviewing the Bid and investigating the qualifications of Bidders prior to awarding the contract. Bidders submitting bids to the City must comply with Chapter 30, Purchasing Code, "Minority and Women Owned Business Enterprises.
